
2 INTRODUCTION

This describes the user interface of Snow License Manager, a tool for Software Asset Management.

Software Asset Management (SAM) is the process of managing, controlling, and protecting software assets within an organization. SAM includes management of the entire life cycle of software, from need assessment, purchase, installation, and maintenance to removal.

2.1 PLATFORM OVERVIEW

The Snow License Manager platform includes a number of system components with dedicated functions. The overview shows the data flow in the Snow License Manager platform.



Component	Description
Snow Inventory Agents and Oracle Scanners	Computers and servers in the IT environment are inventoried by the Snow Inventory Agents and the Snow Inventory Oracle Scanners and the data is then sent to Snow Inventory Server for processing. For more information, see Snow Inventory Agents and Oracle Scanners.



Component	Description
Snow Integration Manager	The Snow Integration Connectors integrate with third-party inventory solutions and virtualization technologies to collect inventory data. The data is then gathered in Snow Integration Manager and sent to Snow Inventory Server for processing. Data from the SaaS connectors is sent directly from Snow Integration Manager to the Snow License Manager database. For more information, see Snow Integration Manager
Snow Inventory Server	Snow Inventory Server receives data from the inventory sources. After processing, the inventory data is stored in the Snow Inventory database. For more information, see Snow Inventory Server.
Data Update Job	Data Update Job is a daily recurring SQL job, which processes the information in the Snow Inventory database into a more usable format for software asset management. For more information, see Data Update Job.
Snow License Manager database	Data Update Job re-populates the Snow License Manager database with new and updated inventory information, applies software recognition rules, and calculates usage, and alerts.
Data Intelligence Service	Any unrecognized software is automatically sent to the Data Intelligence Service team for analysis. When an application has been identified, the team creates new software filtering rules and updates the central Software Recognition Service database. Snow License Manager retrieves updates from the Software Recognition Service database on a daily basis using Snow Update Service. For more information, see Data Intelligence Service.
Snow Management and Configuration Center	Snow Management and Configuration Center is used to manage the technical and administrative parts of Snow License Manager. For more information, see Snow Management and Configuration Center.
Snow License Manager user interface	All information on software installations, usage, users, computers, mobile devices, licenses, and agreements is managed in the user interface of Snow License Manager.
Snow License Manager API	The Snow License Manager API enables information to be retrieved from the Snow License Manager system.
Automation Platform	Automation Platform is used for the automation of processes, for example, software requests and re-harvesting based on usage or subscriptions. Information on available software, related settings, and license availability is synchronized via the Snow License Manager API. For more information, see Automation Platform.
ITSM Connectors	The ITSM connectors update third-party configuration management databases (CMDB) with normalized data, to enhance data quality, by pulling data from the Snow License Manager API and sending it to the CMDB. For more information, see ITSM Connectors.
Snow Update Service	Snow Update Service updates installed Snow software by downloading update files from Snow's central update server. Snow Update Service is not illustrated in the Platform overview. For more information, see Snow Update Service.



2.2 RESPONSIBILITY OF THE USER

Snow License Manager is designed to efficiently manage large volumes of data and to provide competent tools for license compliance analysis, resource planning, cost administration, and much more. A lot of the information, such as inventory data and software recognition rules, is automatically fed into the system.

However, Snow License Manager also heavily relies on information not available through the inventory, in particular information on licenses. If the information entered by the user is incorrect or incomplete, the output will not be accurate.

Understanding the central concepts described in Concepts, terminology, and features is vital in order to achieve reliable results when working with the tool.



3 CONCEPTS, TERMINOLOGY, AND FEATURES

The following chapter explains concepts, terms, functions, and features that are vital to understand when using the SLM Web UI, in order to achieve correct results from Snow License Manager.

3.1 SOFTWARE ASSET MANAGEMENT

Software Asset Management, or SAM, is defined by ISO as "effective management, control, and protection of software assets within an organization".

A **global SAM owner** is an individual at a central organization wide level who is in charge of Software Asset Management. A **local SAM owner** is an individual in charge of SAM for a defined node or section of an organization. Local SAM owners are sub-ordinated to the global SAM owner.

3.2 COMPLIANCE

The term **compliance** is used to indicate that an organization is legally and correctly licensed, meaning that the organization has the amount of licenses that is required to cover its usage of applications.

Snow License Manager regularly establishes a compliance statement for the IT environment. This means that the installed applications are matched with the stock of purchased licenses.

If all applications that require a license are covered, the organization is compliant. An organization that is over-licensed is still compliant, while an organization with too few licenses is incompliant. Obviously there are applications that are free to use without any license. These applications have no effect on compliance.

3.2.1 LICENSE REQUIREMENT

License requirement states the number of licenses that is required to ensure compliance for an application with the selected metric. For example, for applications with the default metric **Installations**, the license requirement is the number of installations of the application that require a license.

The license requirement states the number of required stand-alone licenses. Applications installed as part of a bundle are not included, since they require a suite license.

License requirement for an application is indicated by the graphics in the **Application details view**, see Application.

3.2.2 LICENSE TRACKING

The License tracking functionality in Snow License Manager provides the administrator with detailed information on the entitlement state of each application. The entitlement state describes to what extent a consumer (computer, user, or device) is covered by the available entitlement. The administrator gets an overview of what license and what



agreement covers which consumer, which limits the risk of licensing the same consumer twice. This information is available both in the application details, and in the computer, user, and device details.

3.3 SOFTWARE RECOGNITION SERVICE

Software Recognition Service (SRS) is a service developed by Snow Software, which automatically identifies software in an IT environment. The SRS basically consists of a central database and an automated process for identification of unrecognized software.

All subscribers of the SRS service have access to the central database, which includes rules for recognition of hundreds of thousands of software applications, ranging from commonly used commercial applications to freeware, games, file sharing clients, and poker clients. The number is steadily increasing as new applications constantly show up on the global market.

Based on the information from the SRS database, the local Snow License Manager is capable of identifying inventoried applications by name, manufacturer, version, and edition. Also, the database allows Snow License Manager to detect if the application was installed as part of a product suite and identify any upgrade and downgrade possibilities.

Any unrecognized software is automatically sent to the Software Recognition Service Desk. The experienced members of the SRS team analyze and identify the application and update the SRS database with the new information. Up-to-date filtering rules for software identification are sent to all subscribers of the Software Recognition Service and the information is automatically stored in the local Snow License Manager.

3.4 APPLICATION

In Snow License Manager, an **application** is defined as software installed or run on a computer or device. Each application is associated with filtering rules, which are used to identify programs installed on the inventoried computers.

Applications are normally created by the SRS team and distributed to all subscribers of the Software Recognition Service. As a complement, there may also be customized applications, created locally in Snow Management and Configuration Center (Snow MACC).

3.4.1 APPLICATION BUNDLE

Some applications can be installed both as a stand-alone product and as part of a product suite. Normally, different licenses are required depending on the type of installation. For example, even though Photoshop is included in the Adobe Creative Suite, a stand-alone installation of Photoshop cannot be covered by a license applicable to the Adobe Creative Suite.

For a correct compliance calculation, Snow License Manager needs to be able to determine if an identified application is a stand-alone or product suite installation. The mechanism used to identify installations that are part of a product suite is called an *application bundle*. Application bundles are administered via the Software Recognition Service.

3.4.1.1 LICENSE BUNDLE COMPONENTS INDIVIDUALLY

In some cases it may be allowed to use the installation media of a product suite to install single components, for example components included in the Adobe Creative Suite.



These stand-alone installations are then licensed individually instead of via the application bundle.

In Snow License Manager this is achieved by manually removing the application bundle from the computer. All installed bundle components will be regarded as stand-alone installations when compliance is calculated. For more information, see <u>Bundle options</u>.

3.4.2 APPLICATION FAMILY

Upgrade and downgrade refer to the extended right to use a license also for the preceding and/or subsequent versions. For more information, see Upgrade and downgrade.

The way to manage upgrade/downgrade rights is referred to as **application family**. An application family contains all products from the same product family. Application families are administered via the Software Recognition Service.

3.4.3 APPLICATION TYPE

An **application type** is a classification based on function, according to the United Nations Standard Products and Services Code (UNSPSC). This enables listing of for example all virus applications in the IT environment, without having to know the manufacturer or the application name. The application types are administered via the Software Recognition Service.

3.4.4 APPLICATION CATEGORY

Application categories are created in Snow MACC for a set of applications that have something in common. Application categories can for example be used to specify the standard applications that, according to the IT policy of the organization, should be installed on all computers and laptops.

The report **Computers that do not comply to application categories** lists all computers/laptops that are missing the applications specified by the application category.

3.4.5 APPLICATION USE RIGHTS

Application use rights can be assigned to applications, for example in order to monitor and ensure correct usage of expensive applications. Users without use rights of the application are high-lighted. Application use rights are managed in the SLM Web UI.

3.4.6 STOCK-KEEPING UNIT (SKU)

Stock-keeping unit, or SKU, is a code used to identify and track products, and most manufacturers assign SKUs to their applications. A unique SKU is assigned to each variant of the application, such as different versions, bundles, metric, etc. This means that an application can have one or several SKUs. In Snow License Manager, licenses can be identified by the SKU of the application it applies to. There is also SKU intelligence when registering a license purchase and when importing licenses.

3.5 LICENSE

A license is something you purchase to have the right to use a software application. Suppliers of software can issue licenses in many different variants, resulting in a



large variety of licensing conditions. An application may also be offered with several different license options. The simplest form of license is one that permits one installation of a specified version of an application. More advanced licenses may permit several installations or multiple users, as well as the right to upgrade to a later version of the application.

The alert and report functionality in Snow License Manager helps the administrators identifying licenses that are not used correctly. This provides a possibility to make corrections to better utilize existing licenses and obtain maximum license usage.

3.5.1 METRIC

The metric describes the licensing conditions and is the unit of measure for applications and licenses.

The **metric for the application**, or the default metric, is identified by the Software Recognition Service (SRS). However, the default metric can be changed in Snow License Manager. The default metric is set per application, meaning that an application can have only one default metric.

Available **metrics for the license** depend on the metric of the application. While there can only be one metric per application, it is possible to register license purchases with different metrics. In Snow License Manager, metric is set and any additional information related to the license can be entered when a license purchase is registered.

3.5.2 ORACLE SPECIFIC LICENSE TYPES

The license type for an Oracle product is the unit of measurement for the Oracle license. To see details about an Oracle product in Snow License Manager the Oracle Management Option needs to be installed.

Snow License Manager supports the following Oracle specific license types:

3.5.3 UPGRADE AND DOWNGRADE

Upgrade and downgrade refer to the extended right to use a license not only for the application it was purchased for, but also for one or several of the preceding and/or subsequent versions. The upgrade/downgrade path specifies which versions the application can be upgraded or downgraded to, and in what sequence – and still be covered by the same license. The paths also make it easy to track the original license



for upgraded licenses, regardless of whether the manufacturer or application has changed names.

A common example of upgrade rights is automatic upgrade agreements, which entitle you to stay current with all new releases of the application, without any license renewal.

Also licenses with downgrade rights offer flexibility, as illustrated by the following example.

EXAMPLE

You have purchased 100 licenses for Application 10, which also include the two previous versions. You can use these licenses to cover in total 100 installations of Application 10, 9 and/or 8. Should any of the users of Application 9 or Application 8 choose to upgrade to Application 10, they are still covered by the same license.

3.5.3.1 Automated handling of upgrades and downgrades

Snow License Manager offers full support for automated handling of upgrades and downgrades. Upgrade/downgrade rights are part of the Software Recognition Service analysis and the results reside in Snow License Manager.

To enable the computerized intelligence, you need to ensure that the correct agreement, license, and application settings are made:

Upgrade rights

Upgrade rights can be enabled for the agreement or for each license purchase. Upgrade entitlement will be applied to the highest version, as stipulated by the entered license/agreement.

Downgrade rights

Downgrade rights must be enabled for the application, and for each license purchase. Optionally, you can manually define the downgrade path, by adding or removing application versions and changing the order. Manual path definitions override cross edition rights and downgrade paths identified by the Software Recognition Service.

3.5.3.2 Release date

For licenses that are attached to an agreement with automatic upgrade enabled, the release date of the application is of major importance. These licenses permit you to use the latest version of the application that is available over the active contractual period – also after the end date of the agreement. In other words, if a new version of an application is released while you have an active agreement, you can upgrade to this very version also when the agreement has expired, at no additional cost.

The release date for each application is collected from the Software Recognition Service and is presented in Snow License Manager. You can use the information to see if there is a possibility to upgrade users to later versions without having to pay for it. The information is also used by the system when compliance is calculated, to optimize the allocation of licenses.

3.5.4 ALLOCATION

When a license purchase is registered, you specify the legal organization owning the license. Also, you have the option to enable automatic allocation, or to manually allocate licenses to non-legal organizations.



For optimal utilization of the license ownership, it is recommended to use the automatic allocation feature instead of manual allocation. Automatic allocation is enabled when registering a license, see Add license purchase.

3.5.4.1 Automatic allocation

With the automatic allocation functionality enabled, purchased licenses are automatically distributed to nodes in the organization hierarchy, based on the licensing requirements for each node. Licenses that are purchased on a central level of the organization will then automatically be distributed to underlying organization units based on actual installations. All licenses with automatic allocation enabled will be re-allocated each time compliance is calculated.

Automatic allocation is especially important to take into account for licenses with downgrade rights enabled. When both automatic allocation and downgrade rights are activated, licenses are compared to installations of the same and the specified prior versions of an application, on all sub-levels of the legal organization owning the license.

If automatic allocation is deactivated and no manual allocation has been made, the licenses for the specific purchase will only be compared to installations on the same organization level as the purchase is registered at. If downgrade is activated, installations of prior versions on the same organization level will be taken into account.

3.5.4.2 MANUAL ALLOCATION

It is also possible to manually specify how licenses should be allocated. Manually allocated licenses will not be included in the automated allocation. When compliance is calculated, manually allocated licenses will only be used to cover applications within the organization node that these licenses have been allocated to.

3.5.5 CROSS EDITION RIGHTS

Some software suppliers offer licensing rights where a license could cover other installations within the application family, with the same and/or lower edition. In Snow License Manager this is called Cross edition rights.

Cross edition rights are included in licenses with the following metrics and assignment types:

Also, cross edition rights can interact with upgrade and downgrade rights.

EXAMPLE

A license for Microsoft Windows Server 2012 Datacenter with cross edition rights could cover Microsoft Windows Server 2012 Standard, as well (same version, lower edition).



A license for Microsoft Windows Server 2012 Datacenter with upgrade rights and cross edition rights could cover Microsoft Windows Server 2012 R2 Standard, as well (higher version, lower edition).

NOTE

A manually defined downgrade path will override the cross edition rights.

3.5.6 CROSS PLATFORM RIGHTS

There are applications with licensing conditions that permit installation on more than one type of operating system. In Snow License Manager this is called Cross platform rights.

Just as cross edition rights, cross platform rights can interact with upgrade and downgrade rights.

EXAMPLE

A license for Adobe Acrobat 8 Professional with cross platform rights could cover installations of Adobe Acrobat 8 Professional on both Windows and Mac operating systems (same version, same edition).

A license for Adobe Acrobat 8 Professional with upgrade rights and cross platform rights could cover installations of Adobe Acrobat X Pro as well (higher version, same edition), on both Windows and Mac operating systems.

3.5.7 MULTIPLE VERSIONS/EDITIONS

Licensing conditions for some applications permit you to install and run several versions of the application at the same time. A subset of these rights is that multiple editions are allowed as well. This means that one license is enough to cover installations of more than one version/edition of the application.

NOTE

With this type of licensing, you can only cover a simultaneously installed **lower version** and/or **lower edition** of the same application. Higher versions and/or higher editions cannot be covered.

When compliance is calculated, multiple version/edition is only considered if the appropriate setting for the application has been made in the SLM Web UI, see License settings tab.

3.5.8 SECONDARY USE RIGHTS

Some software suppliers offer licensing features for "Home PC – Work PC", "Desktop – Laptop", or "Desktop - Desktop", also referred to as Secondary use rights. With this type of feature, one single license covers two installations of the same application on two separate computers, for instance, one desktop and one laptop.

To manage this feature from a compliance perspective, secondary use rights must be enabled for the application and a connection must be established between the two sibling computers in Snow License Manager. Sibling computers can be specified either manually or by using an automated function that establishes connections based on identified



primary users of computers within the same organization. For automated handling of sibling computers, contact Snow Software for implementation in your environment.

Snow License Manager also supports Secondary use rights for TS environments, with locally installed software on rich clients.

3.5.9 VM USE RIGHTS

Certain licensing rules allow for covering not only the physical host but also associated virtual machines. With VM use rights, each licensed installation entitles the use of a fixed or an unlimited number of virtual instances of the application.

VM use rights are registered when adding a license purchase and can only be registered for licenses with assignment type Computer/datacenter. Note that VM use rights will only be applied to associated virtual machines if the physical host is fully compliant.

Snow License Manager 9.2 introduces a feature that takes Microsoft Windows Server licensing rules into account: when a Windows Server license is added, the VM use rights are fixed, that is, automatically applied in accordance with Microsoft licensing rules.

If Windows Server Standard is used, the fixed VM use right is two VMs per each fully licensed host.

If Windows Server Datacenter is used, the fixed VM use right is an unlimited number of VMs per each fully licensed host.

EXAMPLE

A computer is assigned four licenses. VM use rights allow each assigned license to be used on three virtual instances. This means that the four assigned licenses can cover 12 virtual machines.

EXAMPLE

From one license purchase, Server A is assigned eight licenses and Server B is assigned four licenses. VM use rights allow each assigned license to be used on one virtual instance per server.

Server A has 16 associated virtual machines. The VM use rights for Server A are changed so that eight specific virtual machines are assigned a license each. The remaining ones need to be covered by another license purchase. The changed VM use rights for Server A overrides the original VM use rights.

The VM use rights for Server B are not changed and will continue to be dynamically assigned as needed. The four assigned licenses are still allowed to be used on four virtual instances.

3.5.10 EXTENDED COVERAGE

Extended coverage means that one single license covers two installations of the same application on two separate computers or datacenters/clusters. Extended coverage is used for passive cluster nodes, disaster recovery test/development environments, and/or for a customer specific reason i.e. a customer specific agreement with extended user rights of the product.



You need to specify the computer or datacenter/cluster the coverage should be extended to, for which application, and for what reason, see Edit computer (Computers) and Add datacenter and cluster (Datacenters and clusters).

3.5.11 SUBSCRIPTION LICENSE

Instead of purchasing a license, you can subscribe to the right to use an application. A subscription license is only valid for a specified period. Once the period has past, the license will no longer be included in the compliance calculation. However, subscription licenses attached to a subscription agreement will have their period overridden by the agreement period. For more information, see Subscription agreement.

In Snow License Manager, information on expired subscription licenses can be found here:

• In **Application details** and on the **Compliance** tab, information is shown on number of **Expired subscription licenses**.

3.5.12 LICENSE REGISTRATION POLICY

All processes and routines are dependent on all participants learning, understanding, and following instructions and policies. Snow License Manager allows you to facilitate registration of licenses and help the users to enter the correct information. You can make fields mandatory, add lists with pre-defined options, and add descriptions that clearly state the intended purpose of a specific field.

Correct registrations of license purchases will reduce the overall administration and prove a better foundation for your software asset management. The License registration policy is managed in the SLM Web UI, see Custom compare value types and Ensure correct license registrations.

3.5.13 INCOMPLETE LICENSES

The Incomplete licenses functionality makes it possible to import and/or register license purchases even though all required information is not available for the purchase to be used as a valid entitlement. You can for example import licenses from a file with incomplete data and then add the required information at a later stage.

License purchases with missing data are marked as incomplete and will not be included when compliance is calculated. Examples of data that will make the license purchase incomplete, if missing, are application name and quantity.

The Incomplete licenses functionality is activated by a setting in Snow MACC.

NOTE

Fields that are indicated as Required in the License Policy must be entered during license registration or the license cannot be saved, not even as incomplete.

3.5.14 UNASSIGNED LICENSES

A license is regarded as unassigned when a license purchase has been registered with an assignment type and a quantity, but no assignments have been made, or assignments have only been made for a part of the license quantity.

In Snow License Manager, information on unassigned licenses can be found here:



- In Application details and on the Compliance tab, see information on number of Unassigned licenses.
- In the report **All licenses**, add the column **Unassigned licenses** from the Column selector.
- In the alert report **Unassigned licenses**.

For assignment type Computer/datacenter:

 In License details and on the Assignment tab, information is shown on number of Total licenses, number of Total assigned licenses, and number of Total remaining licenses to be assigned.

3.5.15 INVALID LICENSE ASSIGNMENTS

A license assignment becomes invalid when a mismatch occurs between the type or quantities of the purchased license compared with the device or user the license is assigned to. For example, a previously valid license assignment can become invalid if:

- The number of licenses assigned to a computer/datacenter exceeds the number required from a compliance perspective.
- The application or family covered by the license is no longer installed on the computer/datacenter the license is assigned to.
- The user the license is assigned to has not used the application nor any application in the family covered by the license within the specified metering period.
- The processor count of the computer the license is assigned to exceeds the number covered by the license.

To prevent you from creating invalid licenses during assignment, an error will flag when you attempt to assign more licenses to a computer, datacenter, or user than you have purchased. This precaution will help prevent some invalid assignments, over time, changes in your environment will cause mismatches. To help you identify these mismatches alert messages show on the **License details** view and standard **Reports** provide a complete overview of invalid license assignments.

Alerts identifying potential mismatches include:

- **No eligible application installed** indicates that the application covered by the license purchase is not installed on the machine you have assigned the license to.
- **Overassignment** indicates that you have assigned more licenses to the user or machine than is required for compliance.
- Missing primary user indicates that the license was assigned to a user for an application that is not installed on any of the computers which the user is a primary user of.
- Missing installation for user indicates that the license is assigned to a user, but the user has never used the application.
- No usage within metering period indicates that the application metric has a metering period, but the application was not used by the user within this period of time.



- Invalid processor count indicates that the machine you have assigned the license to has more processors than which are covered by the license. This alert is only applicable for WindowsServer applications.
- Missing computer, Inactive computer, Missing users, Missing datacenter, Invalid metric (metric equals 0), Invalid quantity (quantity less than, or equal to, 0), Invalid metric group (assigned metric is not supported by the application) indicates invalid or missing data.

To gain an overview of invalid license assignments in your system, use the **Invalid license assignments** report, or add the **Invalid assignments** column to the **All licenses** report.

NOTE

Invalid license assignment can only occur for licenses that can be assigned to a **Computer/datacenter**, or a **User**. Licenses that are assigned automatically to an **Organization** or **Site** do not become invalid.

When computers or users are deleted, licenses assigned to them are automatically unassigned, removing any invalid license assignments.

3.6 ORGANIZATION

An organization structure enables analysis of software and hardware assets based on cost center or department. The organization structure is created in Snow Management and Configuration Center (Snow MACC).

The top-level of the company is normally registered as the legal organization; that is, the legal entity that owns software and hardware assets. If the organization has multiple legal entities, there can be multiple legal organization nodes. Nodes that are not legal, typically nodes further down in the organization hierarchy, are referred to as non-legal organization nodes.

All computers, devices, and users in Snow License Manager are attached to a node in the organization hierarchy. Licenses are always registered for a legal organization node, but can be allocated to the non-legal organization nodes.


3.6.1 AUTO CONNECT RULES

Auto connect rules facilitates management of the organization by automatically assigning computers, devices, and users to the right place in the organization structure. This is achieved by defining one or several filters (rules), based on for example host name, IP address, or user name. Auto connect rules allows you to set up your organization structure once, with no need for further management. Auto connect rules are created in Snow MACC.

Auto connect rules are processed in falling sequence per node level. All nodes on one level will be processed first, then the nearest sub-node level will be processed.

The numbers indicate the order in which the Auto connect rules are applied.





3.7 AGREEMENT

Snow License Manager supports six agreement types, described in the following table. It is also possible to create custom agreement types, intended for agreements that do not match any of the pre-defined agreement types.

Description			
The only agreement type that allows attachment of licenses.			
Hardware maintenance only.			
Hardware support agreements only.			
Hardware purchase agreements only.			
A general agreement type that can be used for any agreement.			
Oracle agreements only, such as Oracle Support and Software Updates Agreement or an Oracle ULA (Unlimited License Agreement). Note: Oracle agreements are registered, managed, and viewed in the Enterprise > Oracle overview section of the user interface, see Oracle overview.			

3.7.1 MASTER AGREEMENT

A master agreement is an agreement that controls the terms, conditions, and dates of subordinate agreements or tasks. Master agreements can also carry licenses or other objects in the system.

3.7.2 SUB-AGREEMENT

A sub-agreement is an agreement signed within another agreement, a master agreement.



3.7.3 SUBSCRIPTION AGREEMENT

A subscription agreement is only valid for a specified period. Licenses that are part of a subscription agreement are only valid over the validity period of the agreement. Subscription licenses attached to a subscription agreement will have their period overridden by the agreement period. For example if a subscription license's specified period expires after the subscription agreements specified period, the subscription license will not be considered in compliance once the subscription agreement period has expired.

In practice, there are two different ways to manage subscriptions depending on how expiration is handled by the product use rights:

- If all of your licenses within an agreement expire when the agreement does, you should create the agreement as a subscription agreement and you will not need to add periods to each license you attach.
- If you have licenses within your agreement that expire at different times, or will expire after the agreement is renewed, you should not add the agreement as a subscription agreement, and should instead add the subscription periods when adding each license purchase.

3.8 SOFTWARE STORE OPTION

Snow's Software Store Option enables organizations to provide a self-service portal for software requests that empowers their end users while giving greater control to the SAM team. By accessing an automated online software catalog that is populated and controlled by Snow License Manager, users can select for themselves what software they need.

Applications that should be available to the users must have the **Available in Software Store** option enabled in Snow License Manager. All changes in application availability are written to the Action log in Snow License Manager, and the report **Applications in Software Store** gives an overview of currently available applications.

3.9 ORACLE MANAGEMENT OPTION

Oracle licensing is complex, with intricate rules and dependencies. To determine if you are correctly licensed, you need to know which Oracle products are installed and used in your IT environment. In addition, you need to know the hardware configuration of the servers running Oracle, as well as have full control over all Oracle agreements and orders.

The Oracle Management Option (OMO) enables asset management of your Oracle products. It provides visibility of your Oracle Databases, Fusion Middleware, and Oracle Java products, as well as license requirements and license assignments for the Oracle Databases plus their Options and Management packs, and for the WebLogic Server as part of the Fusion Middleware portfolio. The information is shown on the Oracle overview page in Snow License Manager.

While the information from the inventoried Oracle environments, gathered by the Oracle scanners, is supplied automatically to Snow License Manager, all Oracle agreements must be registered manually. Oracle orders (entitlements) can be added either one by one or through a bulk order file import. You must also associate the Oracle orders with the Oracle servers, which you can do either manually or by using the Oracle auto-assignment functionality.



Snow License Manager supports the compliance analysis process with dedicated reports and recommendations for Oracle servers not covered by a license. You can also generate and export reports in the format required when submitting a declaration to Oracle, for example, the Oracle Product Compliance report.

With the Oracle verified data feature enabled, you can download a ZIP file with Oracle Database and Oracle Fusion Middleware data that Oracle accepts as an alternative to installing Oracle tooling.

3.10 WINDOWS VDA LICENSING FOR VDI ENVIRONMENTS

Virtual Desktop Infrastructure (VDI) technologies enable users to access their work desktops from almost any device.

Every device connecting to a Windows VDI will require virtual desktop access rights. If the accessing device is a computer covered by a Windows license with valid Software Assurance, the virtual desktop access rights are included. For other devices, a Windows Virtual Desktop Access (VDA) license is required. For the Windows VDA licenses, 90-day reassignment rights apply, which means that a license cannot be reassigned to another device within 90 days of the last assignment.

Snow License Manager identifies all devices that have been connected to a VDI. The device may, for example, be a home PC, a smartphone, or a thin client, but it could also be an inventoried computer. Snow License Manager then adds the application Windows Virtual Desktop Access to all of these devices.

3.10.1 LICENSE REQUIREMENTS

When Snow License Manager calculates the license requirement for the Windows Virtual Desktop Access, the following rules apply:

- If the device is an inventoried computer and if the computer is covered by a Windows license with valid Software Assurance, no Windows VDA license is required.
- If the device is an inventoried computer with a Windows license without Software Assurance, a Windows VDA license is required.
- If the device is an inventoried computer not covered by a Windows license, a Windows VDA license is required.
- If the device is not an inventoried computer, a Windows VDA license is required.
- A Windows VDA license can be reassigned after 90-days.

The Windows operating systems on the Virtual Desktops (VDI) do not require a Windows client license and are automatically removed from the license requirements for the Windows operating system they run, this is illustrated by the VDI remark on the computer as well as under license requirements when looking at the information details.

The management of Windows VDA licensing in Snow License Manager is automated. However, to ensure correct license allocation, all purchases of Windows licenses with Software Assurance must be registered with upgrade rights enabled.



Licensing is also required for the server and management infrastructure of the VDI solution. As a support in the licensing of the VDI structure (Microsoft or other supplier), Snow License Manager provides dedicated stock reports:

- All devices that have accessed a VDI
- All users that have accessed a VDI

3.11 MICROSOFT CIDC REPORT

The Microsoft WorkSpace is a web-based analysis program designed for Microsoft Partners to manage their SAM engagements. Microsoft Partners upload inventory data to the WorkSpace using an input template called Clean Inventory Data Contract (CIDC), an Excel spreadsheet containing detailed inventory information.

Snow License Manager can export inventory data directly into the CIDC format. For detailed instructions on how to generate a CIDC report, see Generate a Microsoft CIDC.

3.12 CORE FACTORS

For some software, manufacturers like Microsoft and Oracle use core factors for licensing on particular hardware configurations. The core factor is a numerical value that is associated with a specific physical processor type, and is multiplied with the actual number of processor cores to calculate the license requirement.

Software that can be licensed based on a core factor is automatically defined in Snow License Manager, and information can be found here:

- In **Application details**:
 - On the **Information** tab, see if the application can be **Licensed based on core factors** (Yes/No).
 - On the Licenses tab, click Tracking to see a list of all license consumers. Click the arrow in the Required column to see if a core factor has been used in the license requirements calculation.
 - On the **Compliance** tab, see information on any **Core factor adjustment** in the **Required licenses** section.
- In the **All applications** report, add the column **Licensed based on core factors**.

3.12.1 MICROSOFT

With the release of SQL Server 2012, Microsoft introduced a new model for licensing of server software based on computing power. In this licensing model, physical processor cores are used as metric instead of, as previously, physical processors. This Per Core model can be used for installations of SQL Server and BizTalk Server.

For more information on the Per Core model and the current Microsoft Core Factor Table, refer to documentation from Microsoft.



3.12.1.1 LICENSABLE CORES

Snow License Manager uses the **Microsoft Core factor table** to calculate the number of **Licensable cores** for a particular hardware configuration (and a physical processor type) where:

Licensable cores = Processors cores × Core factor

In Snow License Manager, the number of licensable cores are automatically calculated for all physical computers running server operating systems. In this way the customers are able to get an indication of the license requirement for a core-based application prior to a deployment. The licensable cores figure is only applied when there is a product to be covered.

In Snow License Manager, information for the computer can be found here:

- In Computerdetails and on the Information tab, see information on Microsoft Core Factor and number of Licensable Cores
- In the Applications per computer report, add the columns Core factor, Core factor table, and Licensable cores from the column selector. For comparison, add also the columns Processors and Processor cores.

3.12.2 ORACLE

Snow License Manager uses the Oracle Processor Core Factor Table to show the current Core Processor Licensing Factor for a particular physical hardware configuration where Oracle software is installed. In Snow License Manager, information on this licensing factor can be found here:

- In **Computer details** and on the **Information** tab, see information on the current **Oracle Processor Core Factor**.
- In the column Core factor of the reports All Oracle database servers, All Oracle databases per server, and Unused Oracle options per server.

For more information on the Core Processor Licensing Factor, refer to documentation from Oracle.

3.13 IBM PVU LICENSING

Processor Value Unit (PVU) is a unit of measure by which an IBM software can be licensed. The number of required PVU entitlements is based on the processor model and by the number of processors made available to the software. IBM continues to define a processor, for the purpose of PVU-based licensing, to be each processor core on a chip (socket). A dual-core processor chip, for example, has two processor cores.

In Snow License Manager, IBM PVU licensing is managed by the metric PVU, which is defined to use the PVU values of the computers as basis for the compliance calculation.

The IBM License Metric Tool (ILMT) automatically determines the required PVU for each computer, as part of the inventory of the machine. This information can be automatically integrated with Snow License Manager to define which PVU value to use for each installation. Integration of ILMT data is done via the Snow Integration Manager (SIM).

In Snow License Manager, information on PVU values can be found here:



- In the Search for computers view, add the column PVU per core from the column selector
- In Computer details and on the Information tab, see information on PVU per core

Also, the administrator will be alerted on any licenses for IBM software that are registered with other metrics than PVU:

• The alert There is [number] licenses with incompatible metrics for PVU licensed IBM applications in Licenses overview

3.13.1 FULL CAPACITY AND SUB CAPACITY

Some software products from IBM, that are licensed based on the metric PVU and can be deployed in a virtualized server environment, can be licensed according to *Full capacity* or *Sub capacity* (virtualization capacity).

Full capacity

Number of required PVU licenses is based on the physical core capacity of the server (every physical, activated processor core) where the IBM software is installed.

Sub capacity

Number of required PVU licenses is based on the virtual core capacity of a partition or a virtual machine available to the IBM software.

The sum of all sub capacity requirements for the virtual machines cannot exceed the full capacity of the physical server hosting the virtual machines. Information on installations that are eligible for sub capacity licensing is gathered by ILMT and can be integrated in Snow License Manager via Snow Integration Manager (SIM).

NOTE

In order to be eligible for sub capacity licensing, all virtual machines of a host must be recognized by ILMT. Otherwise, the host needs to be licensed through full capacity licensing.

Snow License Manager will alert the SAM administrator on computers that are running IBM applications with the metric PVU, but for which ILMT is lacking information:

- In the alert There are [number] of computers with IBM PVU-based products installed without data from ILMT in Computers overview
- In the report Computers with IBM PVU based products without data from ILMT

For information on software products, virtualization technologies, and processor technologies that are eligible for sub capacity licensing, refer to documentation from IBM.

3.14 SAP INFORMATION

The Snow Optimizer for SAP Software analyses transactional and individual usage data, identifies duplicate SAP users and unused licenses, giving the customers an opportunity to reduce costs and liabilities. Also, the solution can automatically recommend "best-fit" metrics based on current behavior of the users.



Information from Snow Optimizer for SAP Software can be integrated into Snow License Manager using automated or manual file imports. When imported, the information is available on the **SAP overview** page as well as in the report **All SAP user accounts**.

3.15 SOFTWARE USAGE METERING

Software usage, for example information about who is using an application and when the application was last used, is shown in Snow License Manager web user interface. The following software usage metering data is shown for applications with a registered usage:

- **Name**: The name of the user that was using the application.
- Last used: The date and time of the last known usage of the application.
 The date and time settings, for example time zone, of the local computer is used.
- Run: How many times the application has been started.
 For more information, see the User Guide for Snow Inventory Agent for Windows.
- Total time (days:hh:mm): The total duration that the application has been run. The total time does not include time when the screen is locked, in sleep mode, or hibernated.

Multiple instances of the same application are disregarded. For example, if a user has ten Microsoft Word documents open for an hour, the total time is one hour and not ten hours.

Per run (hh:mm): The average time per run.
 For example, the average time per run is 44 min if the total time is 22 hours and the application has been run 30 times.



4 **GENERIC FUNCTIONALITY**

The following chapter describes information and functions that are the same throughout the Web User Interface of Snow License Manager.

4.1 LOGIN

Type user name and password, and click **Sign in** or press **Enter**.

4.1.1 MORE OPTIONS

Select the **Remember me on this computer** check box to more easily log on to the SLM Web UI. Login credentials are encrypted and saved in a cookie on the computer.

Select language from the **Language** list to store the setting in the user profile. The selected language will apply by default.

Click **Forgot your password**, type your email address, and then click **Send** to request a new password.


4.2.1.2 PRINT



To modify the report that the pie chart is based on:

- 1. Click **View report**.
- 2. In the report view, modify the search criteria, and then click **Set default**.

For more information, see Change report criteria. To indicate that a pie chart has been modified, **[Filtered]** is displayed after the name of the chart.

4.3 MANAGE LISTS

Lists are easy ways to manage and search for information in the everyday use of the SLM Web UI. There are three different types of lists;

List type	Description
List all	This type of list is available for mobile devices , users , agreements , and licenses . It displays all rows with selected information within the specific category. You can then sort and filter the information further.



List type	Description
Search	All search results are displayed using lists. Search results can be saved for later use.
	For mobile devices , users , agreements , and licenses , the Search view is empty until you apply one or more search criteria.
	For applications and computers , the Search view displays all rows with selected information within the specific category. You can then filter the information by applying one or more search criteria.
Reports	For more advanced reporting purposes pre-configured stock reports are available in the Report section. These reports can be filtered and scheduled for automatic delivery.

In lists, all rows are clickable and lead to the detail view of the selected computer, user, etc. When you return to the list, it will appear the same way as you left it, with any grouping and/or filtering applied.

All lists use paging by default, and they are cache-enabled which stores the initially loaded data. To reload/renew list contents, select **Refresh** on the context menu.

4.3.1 FILTERING

List contents can be modified directly using filters:

Type the filter criterion in the box below the column header (no wildcard character is required) and wait a second while the list is reloaded.
 Only rows that match the filter are displayed.

4.3.2 SORTING

The list is by default sorted based on the first column, but can be sorted by another column.

- To sort the list by another column than the first column, click the column header.
- To reverse the sorting order, click the same column header once again.

A selected sort order is indicated by an arrow in the column header.

4.3.3 GROUPING

To group list contents:

 Drag column headers to the grouping area above the list. The list contents can be grouped in several levels, by dragging two or more column headers to the grouping area.

Details of the group are hidden by default. To expand the group, click the arrow to the left.

4.3.4 COLUMN SELECTOR

Use the **Column selector** function to add columns that are not displayed by default, or to remove unnecessary columns.

- On the context menu, click Column selector. The Select columns dialog box appears.
- 2. To add a column to the list, drag and drop the column to the list header.
- 3. To remove a header from the list, drag it back and drop it in the **Select columns** dialog box.
- 4. To close the **Column selector** dialog box, click \times in the top right corner.

4.4 SEARCH FOR APPLICATIONS AND COMPUTERS

NOTE

This section describes the search function for the **Applications** and **Computers** categories. For a description of the search function for other categories, see Search for Mobile devices, Users, Agreements, Licenses, and Objects.

The **Search** view displays a list containing all rows with selected information within the category. You can add columns with more information to the list by using the column selector function.

You can search the list either by using the filtering function directly on one or more columns in the list, or by using the **Apply filters** function.

To search the list by using the Apply filters function:

- Select the **Filter** button to the left of the list. The **Apply filters** pane appears.
- 2. Optionally, select a subset of the organisation tree from the **Organisation** box. The filter will be applied to the subset.
- 3. To add a search criterion, select the filter target from the **Choose filter** drop down list box.



The search criterion is added below the Choose filter box.

- 4. For the added search criterion, select an operator type and select a search value or enter a search string. Use % as a wildcard character for the search string.
- 5. Optionally, add more search criteria.
- 6. Select **Search**.

The list is filtered by the search criteria. Each search criterion is displayed as a tag above the filtered list.

TIP

Remove a search criterion from the search you just made by selecting the \times on the search criterion tag. The filtered list is updated immediately.

4.4.1 SAVE SEARCHES FOR APPLICATIONS AND COMPUTERS

Filters and groupings that have been made in a search can be saved for easy access and reuse. Searches are saved per user.

To save a search:

- 1. Select **Save current search** above the search result list. The **Save search** dialog box appears.
- 2. Name the search in one of the following ways:
 - To update a previously saved search, select a search name from the dropdown list box.
 - To save a new search, enter a name for the search in the **Name** box.
- 3. Select **Save**.

The search name is displayed as a tag above the filtered list.

Select the **Searches** button to the left of the list to access the list of saved searches. When a saved search is used, it will be applied on the current information in the database.

4.5 SEARCH FOR MOBILE DEVICES, USERS, AGREEMENTS, LICENSES, AND OBJECTS

NOTE

This section describes the search function for the **Mobile devices**, **Users**, **Agreements**, **Licenses**, and **Objects** categories. For a description of the search function for other categories, see Search for Applications and Computers.

The search functionality is based on the standard lists, but has filtering applied from start. Searches do not include all available columns within the specific category by default.

To start a search:

- 1. Select type of operator and type the search string. Use % as a wildcard character.
- 2. To add a new search criterion, select type from the bottom list and click . Selected type is added to the list above.



3. Click Search.

Search is not activated until valid search strings and conditions have been entered.

4.5.1 SAVE SEARCHES FOR MOBILE DEVICES, USERS, AGREEMENTS, LICENSES, AND OBJECTS

Filters and groupings that have been made in a search, regardless of category, can be saved for easy access and reuse later on. Searches are saved per user.

• Select **Save search** from the context menu and type a name for the search.

Searches that have been saved can be selected from the **Saved searches** list. When a saved search is used, it will be applied on the current information in the database.

4.6 EXPORT

Snow License Manager offers several export capabilities. Lists can be exported to the formats CSV, PDF, XLS/XLSX, XML. To export a list:

• In a detail view, right-click a list on a detail tab, and then click format.

4.7 CATEGORY VIEWS

The information in Snow License Manager is sorted in categories, for example in **Applications**, **Computers** and **Users**.

- Use Category overview to show a quick summary of the category displayed in pie charts, and to find alerts related to the category.
- Use **Search for** to find a specific category item.
- Use **List all** to navigate through all the category items.

This chapter gives an overview of the information found in the category detail views and how to edit and delete category items.

4.7.1 DETAIL VIEWS

To show detailed information on a specific item:


• Click the item in a list of category items.

Note that the detail views are different depending on category.

The **top section** of the detail view contains general information on the category item, messages and a summary in information boxes. Some information is clickable and links to



other views. In the following figure, there are links to the manufacturer (Adobe Systems Inc.) and to the application family (Adobe Acrobat).



The **bottom section** of the detail view shows detailed information organized in tabs and tables.

4.7.1.1 Messages

Messages are only displayed when there are messages. The message types are:

- Information
- Warning
- Critical



4.7.1.2 INFORMATION BOXES

Depending on the category, the summary in the information boxes shows for example:

- Licensing information for an application.
- The number of installed applications on a computer.
- The number of applications a user is utilizing.

A blue arrow in the information box indicates that there is more information related to the data.

• Click the information box to show more information.

4.7.2 EDIT CATEGORY ITEMS

There are two ways of editing category items: either by editing a single item at a time, or by editing multiple items at the same time. Not all category items allow for multiple editing.

To edit single category items:

- 1. Navigate to the category item.
- 2. On the context menu, click **Edit** <*category item*>.
- 3. Edit the details for the category item.
- 4. Click **Save**.

To edit multiple category items (this function is available for some categories, but not all):

- On the Category menu, click List all <*category items*> or Search for <*category items*> and find the category items to be edited.
- 2. Click the check boxes to the left to select the category items.
- 3. On the context menu, click **Edit** <*category items*>.
- Edit the details for the selected category items.
 All changes will apply to all selected category items. Fields left unchanged will keep their original content.
- 5. Click Save.

Note that the instruction for editing multiple category items can also be used to edit a single item.

4.7.3 DELETE CATEGORY ITEMS

When a category item is deleted, the item is removed from the system and all associated details are deleted. All attachments to other category items are released.



NOTE

A deleted category item cannot be restored.

There are two ways of deleting category items: either by deleting a single item at a time, or by deleting multiple items at the same time. Not all category items allow for multiple deletion.

To delete single category items:

- 1. Navigate to the category item.
- 2. On the context menu, click **Edit** <*category item*>.
- 3. Click **Delete**, and then confirm the deletion.

To delete multiple category items (this function is available for some categories, but not all):

- On the Category menu, click List all <*category items*> or Search for <*category items*> and find the category items to be deleted.
- 2. Click the check boxes to the left to select the category items.
- 3. On the context menu, click **Delete** <*category items*> and then confirm the deletion.

Note that the instruction for deleting multiple category items can also be used to delete a single item.

4.8 MANAGE DOCUMENTS AND LINKS

In Snow License Manager it is possible to upload documents related to all of the categories, for example, supporting documents to your agreements or licenses. Uploaded documents are shown on the **Documents** tab in the detail views. If you don't want to upload the physical document itself, you can instead add a link to where the document is located.

You add, edit, and remove documents in the edit view of the category item.

ΝΟΤΕ

The file size of an uploaded document must be less than 500 MB.

4.8.1 VIEW ADDED DOCUMENTS

- 1. Navigate to the detail view of a category item.
- Click the **Documents** tab.
 Any added documents appear in the list.
- To open a document, click Show document ¹/₂. The document will either open in the web browser or be available as a downloaded file in your web browser.



4.8.2 ADD DOCUMENTS

- 1. Navigate to the edit view of a category item.
- 2. On the **Documents** tab, click **Add document**.
- 3. Do one of the following:
 - To upload a document:
 - a. Click **Upload**.
 - b. Click **Choose file**, and then select the file.
 - c. Type a **Title** and a **Description** of the document.
 - To add a link to a document:
 - a. Click **Link**.
 - b. In **Link to file**, type the link to the location where the file is located.

NOTE

If you type a path to a local file share, the link will only be shown as a reference to where the file is located.

If you want the document to open when you later click **Show document**, you must enter a URL to the location of the document.

Example: https://domain.org/servername/folder/filename.pdf

c. Type a **Title** and a **Description** of the document.

4. Click **Save**.

The document is added to the list.

4.8.3 EDIT DOCUMENTS

- 1. Navigate to the edit view of a category item.
- 2. Click the **Documents** tab.
- 3. In the list of documents, find the document you want to edit, and then click **Edit**
- 4. Add or edit the applicable information.
- 5. Click Save.

4.8.4 REMOVE DOCUMENTS

- 1. Navigate to the edit view of a category item.
- 2. Click the **Documents** tab.
- 3. In the list of documents, find the document you want to remove, and then click **Remove** \times .
- Click **OK** to confirm. The document is removed from the list.



4.9 DATA UPDATE JOB

Data Update Job is a daily recurring Microsoft SQL Server batch job that is used for transferring, transforming, and normalizing new and updated Snow Inventory data to Snow License Manager. By default, Data Update Job starts at 09:00 PM.

While Data Update Job runs, users are able to access and work with inventory assets, for example, computers and users. If a specific page or area is momentarily being processed by Data Update Job, it will temporarily be unavailable. Users who try to access such a page or area will see a page informing them that their data is temporarily unavailable.

The main reason for restricting access to a page or area is to prevent inconsistent data from being presented and to prevent users from making critical business decisions based on incomplete data.

Data Update Job keeps track of what is being processed, and will both lock and unlock areas of Snow License Manager when they are unavailable and available, respectively. When Data Update Job runs, reports can be the most locked-down part of Snow License Manager due to the fact that report data is often collated from many different parts of Snow License Manager.

To show the status for the Data Update Job:

• Select **Data Update Job status** on the Tool bar. The **Data Update Job status** window appears.

NOTE

A user account with adequate permissions to access Snow Management and Configuration Console can change the time when Data Update Job automatically runs. For more information on this, see the document *User Guide: Snow Management and Configuration Center for Snow License Manager 9*.



5 ADMINISTRATIVE TASKS

The following chapter describes how to customize the Web User Interface of Snow License Manager and how to perform administrative tasks.

When logging in to Snow License Manager, the main start page shows one of the following:

- An **Alert list** (named Overview)
- A Snowboard

The preferred start page is selected in **Settings**, see User settings

5.1 ALERT LIST

The **Alert list** shows a summarized list of active alerts for all categories, and pie charts for **Inventory status** and **Compliance**.

By default, all active alerts are displayed in the view.

• To narrow down the alert categories, click **Filter** in the top right corner and then click to select the categories.

5.2 SNOWBOARD

The **Snowboard** shows a quick overview of status and alerts. The overview is provided using widgets, that is, small objects with tools and content of various nature. There are two types of Snowboards:

- The **Default Snowboard** is accessible to all users. It can neither be edited nor deleted.
- A **customized Snowboard** is only accessible to the user who created it. A user can create several Snowboards, and switch between them on the **Snowboard** menu.

By default, all Snowboards are presented in view mode. To be able to change the appearance or content of a Snowboard, it must be set in edit mode which is done on the **Snowboard** menu.

5.2.1 CREATE A NEW SNOWBOARD

A new Snowboard can be created either from scratch or by using an existing Snowboard as basis.

- On the context menu, click Create Snowboard. The Create Snowboard dialog box appears.
- 2. Type a name for the new Snowboard.
- To use another Snowboard as basis, select the Copy from an existing Snowboard check box and select the Snowboard from the Select Snowboard list.



4. Click **Save**.

The new Snowboard is created.

When the Snowboard is created from scratch, an empty Snowboard will be displayed. However, if an existing is used as basis, the new Snowboard will be populated with the widgets of that selected Snowboard.

5.2.2 EDIT A SNOWBOARD

To add, move, resize, edit or remove widgets, the Snowboard must first be set in edit mode:

1. On the **Snowboard** menu, click the Snowboard to be edited.

 On the context menu, click Edit current Snowboard. The Snowboard is set to edit mode.

NOTE

If navigating to another page in Snow License Manager while the Snowboard is in edit mode, the Snowboard will return to view mode, and changes made to the Snowboard will not be saved.

5.2.2.1 ADD WIDGETS

- 1. Click **Add widget**. The **Add widget** dialog box appears.
- 2. In the **Type** step, click to select a widget type.
- 3. In the **Widget** step, click to select a widget.
- 4. In the **Settings** step:
 - a. Optionally configure the selected widget. Available properties depend on the selected widget type. The content of the widget will be adjusted to the selected **Size**.
 - b. Optionally type a **filter criterion** to filter the data the widget is based on. Use % as a wildcard character.

NOTE

Widget settings can also be changed later on, see Edit widget.

- 5. To return to a previous tab, click **Type** or **Widget**.
- 6. To add the selected widget, click **Add widget to Snowboard**. The widget is added to the Snowboard.
- 7. Repeat the steps to add more widgets.



8. Click **Save** to save the changes and return to view mode.

5.2.2.2 MOVE WIDGETS

To move a widget within a **Snowboard**:

- 1. Drag the widget to the new place.
- 2. Click **Save** to save the changes and return to view mode.

5.2.2.3 RESIZE WIDGETS

- 1. Point to the icon in the top left corner of the widget $\overset{\infty}{\overset{\infty}}$, and then select a new size.
- 2. Click **Save** to save the changes and return to view mode.

5.2.2.4 EDIT WIDGET

- 1. Point to the icon in the top left corner of the widget the number of the number of
- 2. Configure the settings.
- 3. Click **Apply changes**.
- 4. Click **Save** to save the changes and return to view mode.

5.2.2.5 Remove widgets

- 1. Point to the icon in the top left corner of the widget the widget widget.
- 2. Click **Save** to save the changes and return to view mode.

5.2.3 SHARE A SNOWBOARD

Snowboards can be shared with other users or partner customers to facilitate for example introduction of new users or customers. All Snowboards, except the **Default Snowboard**, can be shared.

To share a Snowboard means that you create a copy of the Snowboard and the copy is then added to the selected user's **Snowboard** menu. The copy and the original Snowboard are not connected. Neither changes to the original Snowboard nor changes to the copy will affect one another.

- 1. On the context menu, click **Share Snowboard**. The **Share Snowboard** dialog box appears.
- 2. Keep the original name or enter a new name in the **Name** box.
- 3. Select the users that you want to share the Snowboard with.

4. Click **Share**.

The shared Snowboard appears on the **Snowboard** menu for the selected users.

5.2.4 VIEW DATA

To show the data the widget is based on, click **View data**.

If the data is filtered, then the filter criterion is shown above the list of data:



- If a wildcard was used when filtering the data, that is, the data *contains* the filter criterion, the symbol and is shown together with the filter criterion.
- If no wildcard was used when filtering the data, that is, the data is *equal to* the filter criterion, the symbol is shown together with the filter criterion.

5.2.5 DELETE A SNOWBOARD

To delete a Snowboard, the Snowboard must be set in edit mode.

- 1. On the **Snowboard** menu, click the Snowboard to be deleted.
- On the context menu, click Edit current Snowboard. The Snowboard is set to edit mode.
- 3. Click **Delete Snowboard**, and then confirm the deletion.

5.3 ADMINISTRATION OVERVIEW

The **Administration** overview on the **Home** menu gives access to a number of administrative tasks, which can be performed directly in the SLM Web UI. The administrative tasks are described in the following sections.

5.3.1 CLEAR TEMPORARY CACHE MEMORY

All reports, lists, alerts, detail views, and graphs are stored in a temporary cache memory.

To clear the cache memory:

• In the **Administration** overview and on the context menu, click **Clear temporary** cache memory.

Information that has been registered and saved will neither be removed nor changed.

5.3.2 ACTION LOG

The **Action log** view shows information on changes in the system, for example added or removed licenses, deleted items, or other critical changes.

The following table shows examples of changes that are logged. The changes are grouped by category in the table. Note that the table does not show all changes that are logged.

5.3.3 APPLICATION DENYLIST

Applications that are not approved for installation and usage in the IT environment can be specified in the **Application denylist** view. Unwanted software, for example, game and poker applications, can be monitored with the denylist functionality.

The **Application denylist** view consists of two tabs according to the following table.

Tab	Description
Criteria	Used for specifying criteria that result in a denylist of unwanted applications. A denylist criteria applies to an application name or an application type.
Applications (result)	Displays all applications affected by the denylist criteria.

Unwanted applications are automatically identified based on added criteria (application name or application type). Also, applications can be manually added to the denylist.

Installation or usage of a denylisted application will result in an alert. Denylisted applications are also displayed with red background in the **Computer details** and **User details** views.

To list all applications that have been denylisted:

- Use the stock report **All applications**, and add the report criteria **Denylisted**.
- In the view Search for applications, add the column Denylisted (Yes/No) from the Column selector to facilitate filtering.
- Use the stock reports Denylisted applications per computer or Denylisted applications per user.

5.3.3.1 Add or edit denylist criteria

- 1. On the **Criteria** tab, perform one of the following:
 - To add a denylist criterion, click Add criteria.
 The Add criteria dialog box appears.



- To edit a denylist criterion, click the criteria row.
 The Edit criteria dialog box appears.
- 2. Select **Criteria type** from the list.
- 3. Type the **Criteria**. Use % as a wildcard character to include several applications with common names or types.
 - Example: %poker%
- 4. Optionally, type a **Comment** to describe why the criterion is denylisted.
- 5. Optionally, select the specific **organization** nodes that the denylist criterion applies to.

NOTE

If no specific organization node is selected, then the criterion applies to the whole organization.

6. Click **Save**.

5.3.3.2 Delete denylist criteria

- 1. On the **Criteria** tab, and on the criteria row, click the **Delete** \times icon. The **Delete criteria** dialog box appears.
- 2. Click **OK** to confirm.

5.3.3.3 VIEW DENYLIST APPLICATIONS

All applications that are affected by the denylist criteria are displayed on the **Applications** (result) tab, regardless if they are installed in the current IT environment or not. The columns **Installations** and **Users** show the number of installations and users in the current IT environment.

5.3.4 APPLICATION ALLOWLIST

Applications that are approved for installation and usage in the IT environment can be specified in the **Application allowlist** view. To use this feature, you must enable the basic setting **ACTIVATE_APPLICATION_WHITELISTING** in Snow Management and Configuration Center, see Basic settings.

The **Application allowlist** view consists of two tabs according to the following table.

Tab	Description
Criteria	Used for specifying criteria and automation rules that result in an allowlist of approved applications. An allowlist criteria applies to an application name, application type, or application manufacturer.
Applications (result)	Displays all applications that are affected by the allowlist criteria.

Approved applications are automatically identified based on added criteria. Also, applications can be manually added to the allowlist.



Installation or usage of an application that is not on the allowlist will result in an alert. Non-approved applications are also displayed with grey background in the **Computer details** and **User details** views.

To list all applications that have been allowlisted:

- Use the stock report **All applications**, and add the report criteria **Allowlisted**.
- In the Search for applications view, add the column Allowlisted (Yes/No) from the Column selector to facilitate filtering.

NOTE

Denylist overrides allowlist. If an approved application is denylisted, it will be removed from the allowlist.

- 5.3.4.1 Add or edit allowlist criteria
 - 1. On the **Criteria tab** tab, perform one of the following:
 - To add an allowlist criterion, click Add criteria.
 The Add criteria dialog box appears.
 - To edit an allowlist criterion, click the allowlist criteria row.
 The Edit criteria tab appears.
 - 2. Select **Criteria type** from the list.
 - 3. Type the **Criteria**. Use % as a wildcard character to include several applications with common names or types.
 - Example: %ftp%
 - 4. Click Save.
- 5.3.4.2 Delete allowlist criteria
 - 1. On the **Criteria** tab, and on the criteria row, click the **Delete** \times icon. The **Delete criteria** dialog box appears.
 - 2. Click **OK** to confirm.

5.3.4.3 Set allowlist automation rules

- 1. On the **Criteria** tab, and in the **Allowlist automation rules** section, click **Edit**.
- To set a rule, select the check box of the rule.
 If needed, change the quantities in the **installations** and **users** boxes.
- 3. To apply the allowlist automation rules, click **Apply rules**.

5.3.4.4 VIEW ALLOWLIST OF APPROVED APPLICATIONS

All applications that are affected by the allowlist criteria are displayed on the **Applications** (result) tab, whether they are installed or not. The columns **Installations** and **Users** show the number of installations and users in the current IT environment.

5.3.5 COMPLIANCE EXCLUSIONS

Software manufacturers can apply special licensing rules which cannot be detected automatically, for example, license exceptions and exclusions. As an example, one rule



could state that if Windows Server is installed on a host and the host's only enabled role is **Hyper-V**, the host does not need to be counted for compliance reasons.

Use the **Compliance exclusions** in Snow License Manager to create rules for applications that you want to exclude from compliance calculations for selected computers or users. Where the exclusion rules are applied, the license requirements are removed.

You can only create an exclusion rule based on the default metric of the application. This means that, if you want to create exclusion rules for both computers and users, you need to create the first exclusion rule, change the default metric of the application, and then create the second exclusion rule. For information, see Change default metric.

5.3.5.1 Characteristics

On the **Compliance exclusions** page you see the two tabs **Rules** and **Results**.

Tab	Description
Rules	The created exclusion rules. The rules can have status Active , Inactive , Incomplete , or Calculating .
Results	The applications and consumers excluded from compliance calculations due to active compliance exclusion rules.

On the **Reports** page, you find the **Compliance exclusions for computers** and **Compliance exclusions for users** reports. They show the applications that are excluded from compliance calculations, by which rules, and for which computers or users.

5.3.5.2 ADD COMPLIANCE EXCEPTION RULES

You create a new compliance exclusion rule in four steps: **Exclusion details**, **Applications**, **Computers** or **Users**, and **Summary**.

NOTE

- The applications listed in the **Applications** step depend on the selected **Consumer type**.
- If you want to create an exclusion rule for an application with multiple metrics, you must select the application manually by using the **Manual selection** option.
- If you create and save a compliance exclusion rule without selecting any applications or consumers, the rule will be inactive and marked as **Incomplete**. An inactive rule does not affect the compliance calculations.
- 1. On the Home menu, under Administration, select Compliance exclusions.
- 2. On the **Compliance exclusions** page, select **Create exclusion**.
- 3. In the **Exclusion details** step, do the following:
 - a. In **Consumer type**, select **Computer** or **User**.
 - b. In **Rule name**, enter a name for the rule.
 - c. In **Reason**, enter a description of the rule and a reason for why the rule exists.
 - d. Select **Next step**.



- 4. In the **Applications** step, select the applications you want to exclude. Do one of the following:
 - To select applications by using filtering:
 - a. Select **Automatic filter**.
 - b. Use the **Add group** or **Add criteria** to create your filter. Use % as a wildcard character.
 - **Example: Application name** *like* **zip%**
 - c. To see what applications the filter returns, select **Preview results**.
 - d. Select **Next step**.
 - To select applications manually:
 - a. Select Manual selection.
 - b. Select one or several applications that you want to exclude.
 - c. Select **Next step**.
- 5. In the **Consumers** step, select the consumers for which the selected applications should be excluded. Do one of the following:
 - To select consumers by using filtering:
 - a. Select **Automatic filter**.
 - b. Use the Add group or Add criteria to create your filter. Use % as a wildcard character.
 Example: Organization equal to Finance
 - c. To see what consumers the filter returns, select **Preview results**.
 - d. Select **Next step**.
 - To select consumers manually:
 - a. Select Manual selection.
 - b. Select one or several consumers that you want to exclude.
 - c. Select **Next step**.
- 6. In the **Summary** step, you see the combined result of your created filters and selections of applications and consumers.
- 7. To start using the exclusion, select **Activate exclusion**.
- 8. Select **Save**.
- 5.3.5.3 EDIT COMPLIANCE EXCEPTION RULES

NOTE

You cannot change the **Consumer type** of an already existing exclusion rule.

- 1. On the **Home** menu, under **Administration**, select **Compliance exclusions**.
- 2. On the **Compliance exclusions** page, on the **Rules** tab, find the exclusion rule that you want to edit.
- 3. Under **Actions**, select the three dots, and then select **Edit**.
- 4. Add or edit the applicable information in the **Exclusions details**, **Applications**, and **Consumers** steps. For details, see Add compliance exception rules.



5. Select **Save**.

5.3.5.4 DUPLICATE COMPLIANCE EXCEPTION RULES

Create a copy of an existing exclusion rule to use as the basis for a new rule.

- 1. On the **Home** menu, under **Administration**, select **Compliance exclusions**.
- 2. On the **Compliance exclusions** page, on the **Rules** tab, find the exclusion rule that you want to copy.
- 3. Under **Actions**, select the three dots, and then select **Duplicate**. This creates a copy of the exclusion rule with **(Copy)** added to its **Rule name**.

5.3.5.5 DELETE COMPLIANCE EXCEPTION RULES

- 1. On the **Home** menu, under **Administration**, select **Compliance exclusions**.
- 2. On the **Compliance exclusions** page, on the **Rules** tab, find the exclusion rule that you want to delete.
- 3. Under **Actions**, select the three dots, and then select **Delete**.
- 4. Select **OK** to confirm.

5.3.6 COMPUTER STANDARDS

Snow License Manager can be used as a tool for budget calculations of computer hardware. In the **Computer standards** view, minimum requirements and the price for hardware components can be defined.

The **Computer standards** view consists of two tabs according to the following table.

Tab	Description	
Computer standards	Define minimum requirements for the computer standards.	
Price information	Define price for hardware components related to a specific manufacturer and/or computer model.	
	Define standard prices for hardware components of computers that are not specified in the Price information tab.	

The report **Substandard computers** is based on the information entered in the **Computer standards** detail view and includes the computers that do not meet the defined minimum requirements.

- In the Price information column you can see if the hardware component costs for the computer are based on what you have entered in the Price information tab. If the box is blank, standard prices are used instead, as specified in the Standard price tab.
- Upgrade cost is the cost to complement the hardware components of the computer to meet the minimum requirements. The cost is based on the difference between the minimum requirements and the current hardware components of the computer.
- **Replacement cost** is the cost to replace the hardware components of the computer with new hardware components according to minimum requirements.



5.3.6.1 Add or edit computer standard

- 1. On the **Computer standards** tab, perform one of the following:
 - To add a computer standard, click Add computer standard. The Add computer standard dialog box appears.
 - To edit a computer standard, click the computer standard row.
 The Edit computer standard dialog box appears.
- 2. Type a **Name** for the new computer standard.
- 3. Type minimum requirements for the hardware components in the **Processor speed**, **Memory**, and **Total disk space** boxes.
- 4. Click Save.

As an alternative, an existing computer can be used as basis when creating a new computer standard:

- 1. Navigate to the selected computer.
- 2. On the context menu, click **Use as computer standard**.
- 3. Type a **Name** for the new computer standard.
- 4. **Processor speed**, **Memory**, and **Total disk space** requirements will be set automatically based on the selected computer, but the values may be changed.
- 5. Click Save.

5.3.6.2 Delete computer standard

- On the computer standard row, click the **Delete** [×]icon. The **Delete computer standard** dialog box appears.
- 2. Click **OK** to confirm.
- 5.3.6.3 Add or edit price information
 - 1. On the **Price Information** tab, perform one of the following:
 - To add price information, click **Add price information**. The **Add price information** dialog box appears.
 - To edit price information, click the price information row.
 The Add price information dialog box appears.
 - 2. Type **Manufacturer** and computer **Model** names. Use % as a wildcard character.
 - 3. Select currency and type replacement costs for **Processor**, **Memory**, and **Disk space**.
 - 4. Click **Save**.
- 5.3.6.4 Delete price information
 - On the Price information tab, and on the price information row, click the Delete × icon.

The **Delete price information** dialog box appears.

2. Click **OK** to confirm.



5.3.6.5 EDIT STANDARD PRICE

- 1. On the **Price information** tab, and in the **Standard price** section, click **Edit**.
- 2. Type standard replacement costs for **Processor**, **Memory**, and **Disk space** and select currencies.
- 3. Click **Save**.

5.3.7 CUSTOM COMPARE VALUE TYPES

A custom compare value type is a customized metric intended for licenses where the pre-defined metrics in Snow License Manager are not applicable. Custom compare value types are used to solve complex situations when data needs to come from other sources than Snow Inventory agents. The custom compare value type is available for the metric **Custom compare values** for applications.

A custom field can be used as the basis for compliance calculations when using a custom compare value type as the metric. For more information, see Custom fields.

The **Custom compare value types** page shows a list of the added custom compare value types. The page has four columns: **Name**, **Description**, **Use a custom field value for compliance**, and **A custom field value is used for compliance**.

- The checkboxes in the column Use a custom field value for compliance show if a custom field is used as the basis for compliance calculations for this custom compare value type. Note that you cannot select these checkboxes in the Custom compare value types page.
- The checkboxes in the column A custom field value is used for compliance show if a custom compare value has been added as the metric for an application. Note that you cannot select these checkboxes in the Custom compare value types page.

5.3.7.1 Add or edit custom compare value type

- 1. Perform one of the following:
 - To add a custom compare value type, click Add.
 The Add custom compare value type dialog box appears.
 - To edit a custom compare value type, click the custom compare value type row.

The **Edit custom compare value type** dialog box appears.

- 2. In the **Name** box, type a name for the custom compare value type.
- 3. In the **Description** box, optionally type a name for the custom compare value type.
- 4. To use a custom field value as the basis for compliance calculations, select the **Use a custom field value for compliance** check box, and then select the custom field from the list.



NOTE

To use a custom field value as the basis for compliance calculations, the custom field must have the following properties:

- Category: Computer/Mobile device
- Type: Digit

The **Use a custom field value for compliance** checkbox will not show if there is no custom field with these properties.

- 5. Click Save.
- 5.3.7.2 DELETE CUSTOM COMPARE VALUE TYPE
 - On the custom compare value type row , click the **Delete** X icon. The **Delete custom compare value type** dialog box appears.
 - 2. Click **OK** to confirm.

5.3.8 CUSTOM FIELDS

Custom fields are used for information or data that needs to be managed but do not have a pre-defined entry in Snow License Manager. An unlimited number of custom fields can be created for the agreement, application, computer/mobile device, license, and user categories.

NOTE

When you create a custom field, do not give it the same name as one of the standard fields which already exist in Snow License Manager. This can cause conflicts, for example, when importing data.

A custom field can be **Mandatory**, and must in that case have a defined **Default value**. The default value will automatically be added to new items within the category, as well as existing items without a value in the custom field. Information in a custom field of an existing item will not be overwritten. New items cannot be saved unless there is a value in all mandatory custom fields.

If you want to calculate the compliance for an application and include a custom field in the calculation, then the application must be installed and recognized on the computer with the custom field added. The custom field must also have these properties:

- Category: Computer/Mobile device
- Type: Digit

A list of all created custom fields is displayed in the **Custom fields** view.

5.3.8.1 ADD OR EDIT CUSTOM FIELD

- 1. Perform one of the following:
 - To add a custom field, click **Add custom field**. The **Add custom field** dialog box appears.
 - To edit a custom field, click the custom field row.



The **Edit Custom field** dialog box appears.

2. In the **Name** box, type a name for the custom field.

The name will be displayed in the detail view of the computer/mobile device, license, and user categories. Choose a name so it will be easy to understand what kind of information is supposed to be entered.

NOTE

Do not use the same name as one of the standard fields in Snow License Manager. This can cause conflicts, for example, when importing data.

- 3. In the **Category** list, select for which category this custom field should be available.
- 4. In the **Type** list, select type of content that can be entered in the field. The different types have built-in value validation.
- 5. In the **Description** box, optionally type a description for the custom field.
- 6. To create a list with pre-defined values for digit and text fields, type the value in the **Multi select** box and then click the **Add** ⊕ icon for each value.
- To make the custom field mandatory for the selected category, select the Mandatory check box, and then type a default value in the Default value box.
- 8. Click Save.

5.3.8.2 DELETE CUSTOM FIELD

- 1. On the custom field row , click the **Delete** \times icon. The **Delete custom field** dialog box appears.
- 2. Click **OK** to confirm.

5.3.8.3 ENTER CUSTOM FIELD INFORMATION

The **Custom information** tab is part of the add/edit views of the categories and is used to enter information in custom fields.

To add a custom field and value:

- 1. In the **Custom fields** list, select the custom field to be added and then click **Add** or click **Add all** to add all available custom fields. The selected custom fields are added to the view.
- 2. Enter information in the **Value** box. Depending on selected custom field, values can be typed, or selected from lists or calendar views.

5.3.9 INVENTORY SOURCES

The **Inventory sources** view shows the inventory sources that are configured for your platform. The inventory sources are configured in **Snow Management and Configuration Center**. For more information about inventory sources and how to configure the inventory sources, see the *User guide for Snow Management and Configuration Center*.

If the inventory sources are configured to gather data from more than one database or twice from the same database, then warning messages with instructions on how to solve the issues will be displayed.



5.3.10 LICENSE ASSIGNMENT TRACKING

If tracking is activated, the **License assignment tracking** view shows a log of license assignments. The view shows who assigned a license, when the assignment was made, and a comment on why the assignment was made. The assignments are given an identity in a consecutive order.

The tracking can be activated and deactivated on the **License assignment tracking** view:

- Click **Activate tracking** to log license assignments.
- Click **Deactivate tracking** to stop logging assignments.
 The log of license assignments will remain but no new license assignments will be logged if the tracking is deactivated.

If a license is configured to be auto allocated, then this configuration will be logged, but the individual auto allocated assignments will not be logged.

If the tracking is activated, then the **Add assignment tracking** dialog box appears when a license has been assigned and saved. Review the information, make changes if needed, and then click **OK**.

5.3.11 LICENSE POLICY

The license registration process can be managed and adjusted in order to ensure correct license registrations. Fields can be made mandatory and lists with pre-defined options can be added, as well as descriptions that clearly state the intended purpose of a specific field.

The **License policy** view shows a list of all fields related to a license registration.

 To add a description, make the field mandatory, and/or add a multi-selection list, click the license policy row.

NOTE

Fields that are indicated as Required in the License policy must be entered during license registration. If the information is not entered, then the license cannot be saved, not even as incomplete.

5.3.12 MANUFACTURERS AND VENDORS

The **Manufacturer and vendors** view shows the contents of your manufacturer/vendor database. The information in the database can be used to facilitate the process of adding/ editing agreements.

New manufacturers, vendors, and contractors are added to the database via the **Import data** wizard.

5.3.13 MY NOTIFICATIONS

The notifications enable you to monitor alerts and system events in Snow License Manager, such as added licenses, deleted computers, updated agreements, or agreements nearing their expiration dates.

Your configured email notifications are sent per category and action. This means that if you have one notification for added agreements and one for updated agreements, you will



receive one email listing all of the added agreements and one listing all of the updated agreements. Depending on the activity in your system, you might also receive multiple notifications per day for each category and action.

The notifications will be sent only once so make sure to take appropriate action, when needed.

NOTE

SMTP settings must be activated in Snow MACC to enable sending of e-mails.

- 5.3.13.1 Add or edit notification
 - 1. Perform one of the following
 - To add a notification, click **Add notification**. The **Add notification** dialog box appears.
 - To edit a notification, click the notification row. The **Edit notification** dialog box appears.
 - 2. On the **Details** tab:
 - a. To activate the notification, select the **Active** box. If left cleared, no notifications will be generated.
 - b. Type a **Name** for the notification.
 - c. In the **Send to** box, type the e-mail address of the recipients that the notification is intended for. Use comma as separator.
 - d. In the **Category** list, select the category that the notification applies to.
 - e. In the **When** list, select for which action a notification should be sent. Available options depend on the selected category.
 - 3. Optionally, on the **Criteria** tab:
 - To make the notification more precise, add more criteria. Use multiple criteria and groups in order to create advanced filters. For each criteria, select an operator which tells the system how to compare the values. Use % as a wildcard character for values.
 - 4. Click Save.

5.3.13.2 DELETE NOTIFICATION

- 1. On the notification row, click the **Delete** \times icon. The **Delete notification** dialog box appears.
- 2. Click **OK** to confirm.

5.3.14 ORACLE COMPUTER MODEL MAPPING

An important criteria for determining Oracle licensing is the physical capacity of the server. One such detail is the number of processor sockets of the physical server, information that cannot be obtained by the inventory scan.

The **Oracle computer model mapping** view is used to manually specify the number of processor sockets for each unique computer model. The specified socket count value



will be used as default for all servers of that model, but the value can be changed for a specific computer, if needed. The list includes all inventoried computer models with Oracle databases installed.

The Oracle Server Worksheet (OSW) requires information on the physical socket count and this report will be populated using the information supplied via the **Oracle computer model mapping**.

To specify the number of processor sockets of the physical server:

- Click the computer model row. The **Oracle computer model mapping** dialog box appears.
- 2. Type the physical socket capacity in the **Number of sockets** box.
- 3. Click **Save**.

5.3.15 REPORTS CACHE

Some reports can take a long time to run. Use the cache reports functionality to run the reports from a cache instead of from the live database. This will enable you to run reports faster.

- 1. On the **Administration** menu, select **Reports cache**.
- 2. Select the reports that you want to run from the cache.
- 3. Select **Save**.

To configure the cache reports functionality, see Improve report performance.

5.3.16 WEB APPLICATIONS

It is possible to collect and measure usage of cloud/web based applications. Regardless of what type of binary being used (regular application, browser, etc.), the Snow web metering solution measures the HTTP/HTTPS traffic for the hosts that have been configured. The result is presented in Snow License Manager as regular applications, with most regular application features available.

Configuration of which cloud/web applications to monitor is done in the **Web applications** task.

When a web application is added and activated, software recognition rules are created automatically. This means that any usage of cloud/web applications that matches the entered patterns will be identified and presented in Snow License Manager.

5.3.16.1 ADD OR EDIT WEB APPLICATION

- 1. Perform one of the following:
 - To add a web application, click Add web application.
 The Add web application dialog box appears.
 - To edit a web application, click the web application row.
 The Edit web application dialog box appears.
- 2. Select **Client site name** and **Client configuration** from the lists.
- 3. Type the **Name** for the web application. This is the name that will be used by Snow License Manager.



- 4. In the **Patterns** box, type the domain name of the web application (no wildcard characters are allowed). Use domain names and not URLs. Several domain names can be entered, but only one per row.
 - Example: portal.microsoftonline.com
- 5. To activate the web application, select the **Active** check box. If left cleared, Snow License Manager will not measure usage of the web application.
- 6. Click **Save**.

NOTE

An added web application will only apply to a specified site and configuration. If several sites and configurations are to be measured, create one web application for each site and configuration combination.

- 5.3.16.2 DELETE WEB APPLICATION
 - 1. On the web application row, click the **Delete** \times icon. The **Delete web application** dialog box appears.
 - 2. Click **OK** to confirm,

5.6.3 ALERTS TAB

The **Alerts** tab shows all available alerts.


- Click the checkboxes to select alerts to be displayed in the category overviews.
- Click the **Alert** checkbox in the top left corner to select/deselect all alerts.

5.7 RECALCULATE COMPLIANCE

The compliance position for an application can change, for example, following the registration of new license purchases, the addition of downgrade or cross-edition rights to a license, or the conversion of metrics. The system does not automatically know when editing is complete, so to determine the effect of changes to compliance, you need to manually recalculate compliance.

To do this:

- 1. On the menu in the upper right corner, select **Recalculate compliance**.
- 2. Refresh the web-browser page.





6 **APPLICATIONS**

The **Applications** category gives complete information on all inventoried applications, such as:

- Application details
- Application manufacturers
- SAP utilization

Here, applications can be viewed and managed, and application usage can be monitored.

6.1 APPLICATION DETAIL VIEW

To show detailed information on a specific application, click the item in a list of applications.

The information boxes in the **Application** detail view show licensing information according to the following table.

The bottom section of the detail view contains detailed information on the application presented in tabs according to the following table.

Available tabs in the application detail view depend on the metric and if the application is installed on a computer or on a mobile device.

6.1.1 MULTIPLE METRICS

If the **Multiple metrics** symbol is displayed next to the application name at the top of the Application detail view, more than one metric can be used in the license assignment, reporting, and compliance calculations for the application. You can add metrics to an application in the **Metrics** section on the License settings tab.

When multiple metrics are included for an application, you can select metric from the pop-up list in the **Instance** box.

The information boxes will change to show licensing information for the selected metric.

The selected metric is listed next to the application name together with the **Multiple metrics** symbol 4 Users \times .

The **Licenses** and **Allocation** tabs display information about the selected metric, and the **Compliance** tab displays information for all metrics added to the application.

6.1.2 LICENSES TAB

The Licenses tab contains the views Purchases, Transfers, and Tracking.

Purchases

The **Purchases** view shows information on all license purchases that have been registered for the application. The **Incomplete** check box is used for indication of any incomplete licenses.

Click the arrow next to the purchase date to open a separate window presenting the current license allocation.

Click a purchase in the list to be directed to the details of that license registration.

Transfers

If any licenses have been received or given via upgrade rights or downgrade rights, a list of these transfers can be found in the **Transfers** view. Information is shown on involved applications, transfer type, metric of the license, and number of transferred licenses.

Click an application in the list to be directed to the details of that application.

Tracking

The **Tracking** view shows a list of all consumers that require a license for the application.

If multiple metrics are available for the application, the type of consumer and related information depends on the selected metric.

- The **Used** column indicates if the installation is used or not.
- The **Required** column shows the number of licenses that is required for coverage. Click the arrow next to the quantity to see information on any license adjustments that have been made to the initial license requirement.



• The **Entitlement state** column shows to what extent the consumer is covered. Click the arrow next to the state to see more information, and to be directed via a link to any license purchase that is used for coverage.

Click a consumer in the list to be directed to the details of that consumer.

6.1.3 COMPLIANCE TAB

The **Details** view on the **Compliance** tab shows in-depth information on how licenses, requirement, and coverage on the **Application** detail view have been calculated.

The top section shows calculations based on the metric of the application. If any licenses have been registered with other metrics than the application's metric, additional sections with calculations will follow.

If multiple metrics are available for the application, select **Show additional metrics** to see the calculations for all available metrics.

6.2 EDIT APPLICATION

- 1. On the **Applications** menu, click **Search for applications** and find one or more applications to be edited.
- 2. To edit one application:
 - a. Click the application row.
 The **Application detail view** appears.
 - b. On the context menu, click **Edit application**.
- 3. To edit several applications at the same time:
 - a. Select the applications.
 - b. Click Edit applications on the context menu.
 The Multiple application editing view appears.
- 4. Edit the information in the fields on the tabs according to the following sections.
- 5. Click Save.

6.2.1 GENERAL INFO TAB

To edit additional information about the application, edit the settings on the **General info** tab:

- 1. Type a **Description** of the application.
- 2. Type **Serial numbers/license keys** for easy access during installation/ reinstallation.
- 3. In the **Media** box, type information on storage location of the installation media.
- 4. In the **System owner** boxes, type information on whom to get in contact with in case of any questions or issues with this specific application.

6.2.2 LICENSE SETTINGS TAB

To select and enter license related information, edit the settings on the **License settings** tab.

6.2.2.1 GENERAL

The following general information for the application can be added:

License requirement

Select the **No license required** check box if no license is required for the application.

Additional settings

• **Enable secondary use rights** To enable secondary use rights for this application, select the check box.

• Allow simultaneous multiple versions

To set that only one license is required for a computer with multiple versions of the application installed, select the check box.

NOTE

You can only cover a simultaneously installed **lower version** of the same application. A higher version cannot be covered.



Despite being selected, the feature is enabled only when there is a license that covers the local installations. Before a license is added, both versions will be displayed as requiring a license on the computer. This is done because the right of running multiple simultaneous versions on one computer is covered by the license, not by the application.

• Allow simultaneous multiple editions

To set that only one license is required for a computer with multiple editions of the application, select the check box.

NOTE

You can only cover a simultaneously installed **lower edition** of the same application. A higher edition cannot be covered.

Compliance settings

• Apply metrics to upgrade/downgrade

To apply all added metrics to the applications from upgrade/downgrade path, select the check box.

• Apply metrics to cross edition

To apply all added metrics to the applications from cross edition path, select the check box.

Release date

The Software Recognition Service provides the General Availability Date for each application. To override this global release date, enter a **Release date**.

6.2.2.2 DOWNGRADE RIGHTS PATH

Select the number of previous versions a downgrade can be made to from the list in this section.

6.2.2.3 METRICS

The left side of the **Metrics** section displays all metrics that have been added to the application.

To add a metric to the application, select a metric from the list below the added metrics, and then select the **Add** \oplus button.

Delete a metric by selecting the trashcan icon next to the metric.

ΝΟΤΕ

A metric cannot be deleted in the following cases:

- When the metric is the default metric.
- When the metric is connected to a license purchase registration.
 The license must be deleted before the metric can be deleted.

In these cases, no trashcan is available for the metric.

The default metric is marked with the default metric $\stackrel{(s)}{\longrightarrow}$ icon. To make another metric the default metric, select the metric and then select **Set as default metric**.



NOTE

The default metric cannot be changed for a Windows Server application.

Select one of the added metrics to view information related to the selected metric on the right side of the **Metrics** section. Edit the information related to the selected metric according to the following description:

Enter an estimated cost for each license in the box. The value is used for creating cost estimations of over- and under-licensing and total cost for installations, devices, users etc.

Select **Currency**. The currency does not have to be the same as the currency selected in your user settings.

NOTE

You need to recalculate compliance to update the cost estimations after entering new cost information for the Application cost or License cost.

6.2.3 OTHER SETTINGS TAB

To select how alerts should be used, edit the settings on the **Other settings** tab.



When an alert is excluded, potential over-licensing or under-licensing will be displayed in the **Applications details** view, but it will not be shown as an alert.

6.2.4 DOWNGRADE PATHS TAB

Use the fields on the **Downgrade paths** tab to manually add versions within the application family that this application is valid to downgrade to. The application versions can be listed in relative order to define the downgrade path.

NOTE

A manual downgrade path will override cross edition rights and downgrade paths identified by the Software Recognition Service.

Add application:

- 1. In the **Available applications** list, select the application to be added.
- Click the Add ≥ icon.
 The application is moved to the The application is valid for downgrade to list.

Change downgrade order:

- 1. In the **The application is valid for downgrade to** list, select the application to be moved.
- 2. Click the **Up** or **Down** icons to move the application up or down in the list.

Remove application:

- 1. In **The application is valid for downgrade to** list, select the application to be removed.
- Click the **Remove** icon.
 The application is moved to the **Available applications** list.

6.2.5 PROGRAM FILES TAB

The information on the **Program files** tab shows all identified inventoried program files and registry keys that are linked to the application. No changes can be made on this tab.

6.2.6 CUSTOM INFORMATION TAB

Use the **Custom information**, to add custom fields and change the values in the custom fields. Only custom fields that are created for the **Application** category are available.

For more information, see Enter custom field information.

6.2.7 COMPARE VALUES TAB

The **Compare values** tab is available for the metric **Custom compare values**, and if this metric is not connected to a custom field.

Use the **Compare values** tab to specify the quantity per organization of the custom compare value type selected in the **License settings** tab.

To edit the settings on the **Compare values** tab:



- 1. To add organization node and quantity:
 - a. In the list, click the check boxes to select the organization nodes to be added, and then click **OK**.
 - b. Click Add.

The selected organization nodes are added to the view.

- c. Type a custom compare value for the organization node in the **Quantity** box.
- 2. To change quantity, type a new custom compare value for the selected organization node in the **Quantity** box.
- 3. To remove organization node, click the **Remove** \times icon to the right of the organization node to be removed.

EXAMPLE

Monitor compliance for Exchange email accounts

The license requirement for Client access licenses (CALs) for Microsoft Exchange Server 2010 cannot be discovered by Snow Inventory agents. A metric called **Exchange CAL** is therefore defined to monitor the compliance for **Exchange email accounts**.

The following steps are performed to monitor the compliance for the application **Microsoft Exchange Server 2010 Standard User CAL**:

- 1. Create a new custom compare value called **Exchange CAL** according to Custom compare value types.
- 2. Navigate to the application details view for **Microsoft Exchange Server 2010 Standard User CAL**.
- 3. Click Edit application.
- 4. On the License settings tab, set the Metric to Custom compare values, and set the Custom compare value type to Exchange CAL.
- 5. On the **Compare values** tab, specify the number of Exchange email accounts for each organization node and for this application.
- 6. Click **Save**.
- On the context menu, click Add application license.
 The Add license view appears.
- 8. In the **Quantity** box, type the number of CALs purchased.
- 9. Click **Save** and then select **Recalculate compliance** from the dropdown menu under your username.
- 10. On the **Allocation** tab, analyze the compliance for the application.

6.2.8 STORE TAB

Use the **Store** tab to specify whether this application should be available for order in Software Store or not. Available software is indicated by the information message **Available in Software Store** in the application details view.



NOTE

The Store tab is only available if the setting SOFTWARE_STORE_OPTION_ACTIVE has been enabled, and if the logged in user has the required permissions to administer applications in the Software Store. Settings and permissions are managed in Snow MACC.

To make an application available and to define how it will be displayed in the Software Store:

- 1. Select the **Available in Software Store** check box. Input fields are enabled.
- 2. In the **Name** box, optionally change the application name. This name will be displayed in the Software Store.
- 3. Type a **Description** of the application which will be displayed in the Software Store.
- 4. Click **Browse** to upload an application **Image**.
- 5. Type a **Cost** and a **Rental cost** for the application. Note that these costs are set using the base currency of Snow License Manager.
- 6. If orders of this application needs approval from a Group Manager, select the **Require organizational approval** check box.
- 7. If orders of this application needs approval from the application owner, select the **Require application owner approval** check box. Type the **Application owner's AD username** in the box that is displayed.
- 8. Select how this application will be provisioned from the **Provisioning type** list, and type the related **Identifier (AD group)**.
- 9. From the **Publish level** list, select the actions that will be available for this application in the Software Store.
- For additional Uninstall options, click Change (the button is only enabled when Publish level is set to Uninstall or Install and Uninstall). Select one of the following settings:
 - **No limited use**: The application will not be automatically uninstalled.
 - Uninstall this application based on time: The application will be automatically uninstalled from the user's computer after a set number of days.

A notification can be sent to the user before the application is removed. Optionally, the user can be offered to extend the subscription with a number of days.

 Uninstall this application based on usage: The application will be automatically uninstalled from the user's computer if it has not been used for a set number of days.

A notification can be sent to the user before the application is removed.

NOTE

The number of days must be less than specified in the setting METERING_ HISTORY_MONTHS in Snow Management and Configuration Center, so that Snow License Manager has enough metering/usage data to provide data for this scenario.



6.2.9 BUNDLE OPTIONS TAB

On the Bundle options tab, select to unbundle an application bundle in order to license the included applications individually instead. This is done on the computer where the application is installed.

This tab is only available for bundles.

6.3 CHANGE DEFAULT METRIC

The default metric describes the general licensing conditions for an application. In Snow License Manager, the default metric is set per application, meaning that an application only can have one default metric. To change the metric for a license, you need to edit the application that the license is attached to.

NOTE

The default metric can only be changed if the metric for all registered license purchases is according to the default metric. For example, the default metric for an application with the default metric **Devices** can only be changed if all registered license purchases have the metric **Devices**. However, if licenses are added to applications with the default metric **Installations**, **Number of processors** and **Number of processor cores**, then the default metric can be changed to any of **Installations**, **Number of processors** and **Number of processors** and

- 1. Navigate to the application to be edited.
- 2. On the context menu, click **Edit application**.
- 3. On the **License settings** tab, select the new **Metric** from the list.
- 4. Click Save.

6.4 ALLOWLIST APPLICATION

An allowlisted application is approved for installation and usage in the IT environment. For more information on the application allowlist and how to specify criteria and automation rules that result in an allowlist of approved applications, see Application allowlist.

6.4.1 ADD APPLICATION TO ALLOWLIST

To add an application to the system's allowlist:

- 1. Navigate to the application to be allowlisted.
- On the context menu, click Allowlist application, and then click OK.
 The information message Allowlisted is added to the application details view.

6.4.2 REMOVE APPLICATION FROM ALLOWLIST

To remove an application from the system's allowlist:

1. On the **Home** menu, click **Administration**. The **Administration overview** appears.



2. Click **Application allowlist**. The **Application allowlist** appears.

3. Find the application, click **Remove** \times , and then click **OK**.

6.5 DENYLIST APPLICATION

An application on the system's denylist is not approved for installation and usage in the IT environment. For more information on the application denylist and how to specify criteria and automation rules that result in a denylist of not approved applications, see Application denylist.

6.5.1 ADD APPLICATION TO DENYLIST

To add an application to the system's denylist:

- 1. Navigate to the application to be denylisted.
- On the context menu, click **Denylist application**, and then click **OK**.
 The warning message **Denylisted** is added to the application details view.

6.5.2 REMOVE APPLICATION FROM DENYLIST

- 1. On the **Home** menu, click **Administration**. The **Administration overview** appears.
- 2. Click **Application denylist**. The **Application denylist** appears.
- 3. Find the application, click **Remove** \times , and then click **OK**.

6.6 APPLICATION USE RIGHTS

Application use rights can be assigned to users to, for example, monitor and ensure correct usage of expensive applications. When a user without use rights uses the application, an alert will be generated.

An application with registered use rights is indicated by the warning message **Application rights registered**.

6.6.1 ADD APPLICATION USE RIGHTS

- 1. Navigate to the application.
- 2. On the **Users** tab, right-click the user that will receive use rights of the application, and then click **Add rights to user**.
 - All users without use rights of the application are highlighted in red in the list.
 - The warning message **Application rights registered** is added to the application.



6.7 BUNDLE OPTIONS

Application bundle licensing is removed from (or restored on) the computer where the bundle component is installed.

6.7.1 REMOVE BUNDLE LICENSING

- 1. Navigate to the application for which bundle licensing is to be removed.
- 2. On the context menu, click **Edit application**.
- 3. On the **Bundle options** tab, find the computer for which the bundle licensing is to be removed and click **Unbundle**.

Click Save. A message box opens requesting you to confirm the changes you have made. Click OK.

- 5. On the **Computers** tab of the **Application details** view, the text UB will show in the **Remark** column.
- 6. Select **Recalculate compliance** from the dropdown menu under your username.
- 7. Refresh your web browser.
- 8. The data shown in the **Application details** view will reflect the changes you have made.

6.7.2 RESTORE BUNDLE LICENSING

- 1. Navigate to the application for which bundle licensing is to be restored.
- 2. On the context menu, click **Edit application**.
- 3. On the **Bundle options** tab, find the computer for which the bundle licensing is to be restored and click **Bundle**.

Click Save. A message box opens requesting you to confirm the changes you have made. Click OK.

- 5. Select **Recalculate compliance** from the dropdown menu under your username.
- 6. Refresh your web browser.
- 7. The data shown in the **Application details** view will reflect the changes you have made.

6.8 APPLICATION MANUFACTURERS

The **Application manufacturers** view shows a list of all identified application manufacturers in the system. Pie charts are provided for a quick overview.

6.8.1 APPLICATION MANUFACTURERS DETAIL VIEW

The top section of the **Application manufacturers** detail view shows pie charts with information on **Top application installations** and **Top application license cost** for the selected manufacturer.

The bottom section of the detail view shows information on applications (both with and without license requirements), software agreements, and license purchases.



6.9 APPLICATION FAMILY OVERVIEW

All versions and editions of an application are together called an application family. In Snow License Manager, the application families are defined by the Software Recognition Service.

The **Application family overview** summarizes for example the license cost, compliance, and risk for applications belonging to the same family. The information can be used to optimize the licensing within an application family.

To view an **Application family overview**:

• In the top section of the **Application detail view**, click the **Application family** link.

The Application family overview consists of:

- A **graph** showing the number of installations per application and the percentage of how many consumers that are covered by a license.
- A **summary** of for example license cost, compliance and risk.
- **Detailed information** about the applications listed in tabs.

6.9.1 GRAPH

The graph shows specific bars for the five applications with the latest versions and editions, and a summarized bar for the older versions and editions. Only applications being installed and requiring a license are shown in the graph.

When pointing to a bar in the graph an information box appears. The information box shows the details on the coverage of the application.

6.9.2 SUMMARY

The summary shows licensing information for the whole application family.

The information is described in the following table.

To find more information that can be used to optimize the licensing for the application family, click an application in the list on the **Applications** tab. Go to **Tracking** on the **Licenses** tab in the **Application detail view**.



7 COMPUTERS

The **Computers** category gives detailed information on the IT environment, such as computers, mobile devices, datacenters/clusters, and devices (RDS/Citrix). Here, information on available hardware can be found as well as information on which applications and users that have been using a specific computer.

7.1 COMPUTERS DETAIL VIEW

To show detailed information on a specific computer, click the item in a list of computers.

The information boxes in the **Computers** detail view shows information on usage and cost according to the following table.

7.1.1 APPLICATIONS TAB

The Applications tab shows a list of all applications installed on the computer

An arrow \triangleright to the left of the application name in the list is available for all applications with **registered usage**. Click the arrow to expand a list of users that have used this application on the specific computer. The following usage is registered per user:

- **Last used**: The last date and point of time when the application was used on the computer.
- **Run**: How many times the application has been executed on the computer.
- **Total time**: Total application usage displayed in days, hours, and minutes.

Applications can be marked with a background color according to the following table.

- 2. To edit one computer:
 - a. Click the computer row. The **Computer detail view** appears.
 - b. On the context menu, click **Edit computer**.
- 3. To edit several computers at the same time:
 - a. Select the computers.
 - b. Click Edit computers on the context menu.
 The Multiple computer editing view appears.
- 4. Edit the information in the fields on the tabs according to the following sections.
- 5. Click Save.

7.2.1 GENERAL TAB

To enter information on the **General** tab:

- 1. Enter information on **Purchase date**, **Purchase price** and **currency**, **Vendor** and **Invoice reference**. Note that currency may vary and does not have to correspond to the default viewing currency.
- 2. Select computer **Status**. Available options:
 - Active The computer is active in the system and will require licenses for installed applications.



- Quarantined The computer is placed in quarantine after a defined number of days of not reporting inventory data, but will still require licenses for its installed applications. If automatic quarantine management is activated (in Snow MACC) the computer will automatically be placed in quarantine, and then removed from the system or set to inactive.
- Inactive The computer is not active in the system (when in storage for example) and does not require licenses for its installed applications. The computer is not included in compliance calculations. However, if the computer is still reporting to the Snow Inventory server, it will update its data in Snow License Manager. When an inactive computer reports inventory data, an alert is displayed.
- 3. Select **Organization** node that this computer belongs to.
- 4. In the **Security code** box, type any anti-theft label on the computer.
- 5. To disable auto connect rules, select the **Disable auto editing** check box.
- 6. To prevent the computer from being placed in quarantine status or removed from the system if it stops reporting inventory data, select the **Disable automatic quarantine management** check box.

NOTE

This setting is not available for members of auto-generated datacenters. To make this setting available, you must first configure the setting **DCC_AUTODISCONNECT_DAYS** in **Snow Management and Configuration Center**. For more information, see Quarantine management.

- 7. In the **Physical socket capacity**, type the number of processor sockets in the computer.
- 8. For physical servers that use MCM processors, select the **Uses MCM Processors** check box and type the number of **Chip modules per processor** in the box. This information is used to calculate and present number of populated physical sockets in the Oracle Server Worksheet report for servers that use MCM processors.
- 9. To enable secondary use rights:
 - a. Click the **Search** e icon to the right of the **Sibling computer** box. The **Search for computer** dialog box appears.
 - b. Type the search criterion and click **Search**. A list of computers that match the search criterion is displayed.
 - c. Select the computer to be added from the list.
- 10. For virtual machines, type **Host computer name**. Selected host/virtual machine will be displayed on the **Information** tab of the virtual machine. To remove a host computer, click the **Clear** icon to the right of the box.

7.2.2 AGREEMENTS TAB

Select one or more check boxes to attach the computer to one or more agreements.

If the correct agreement is not available in the list, it has to be created.



7.2.3 CUSTOM INFORMATION TAB

On the **Custom information** tab, enter information and values in the custom fields that are available for the **Computer/mobile device** category.

For more information, see Enter custom field information.

7.2.4 IDENTIFIED FILES TAB

The **Identified files** tab shows all identified inventoried application files on the computer. No changes can be made on this tab.

7.2.5 DOCUMENTS TAB

On the Documents tab, click **Add document** to upload documents or add links related to the computer.

For more information, see Manage documents and links.

7.2.6 EXTENDED COVERAGE TAB

Use the **Extended coverage** tab to specify which computer the coverage should be extended to, for which application, and for what reason.

Add or remove which computer the coverage should be extended to.

7.2.6.1 ADD COMPUTER

- Click the Search sicon.
 The Search for computer dialog box appears.
- Type the search criterion and click **Search**.
 A list of computers that match the search criterion is displayed.
- 3. Select the computer to be added from the list.
- 4. Select an application from the **Select application** list.
- 5. Select a reason from the **Select the reason for extending coverage** list.
- 6. Click **OK**.

The dialog box is closed and the selected computer is displayed in the **Computer** box.

Click Add to the right of the Computer box.
 The selected computer is added to the list of computers with extended coverage.

7.2.6.2 REMOVE COMPUTER

• Click the **Remove** imes icon to the right in the list, and then confirm the deletion.

7.2.7 ORACLE TAB

The **Oracle** tab is only available for servers running Oracle database products, and is used for associating a server with one or several Oracle orders.

To associate a server with an Oracle order:



- 1. Click Add. The Search for Oracle order item dialog box appears.
- 2. Type the search criterion (Customer Support Identifier, CSI, or Product name) and click **Search**.

A list of Oracle orders that match the search criterion is displayed.

3. Click the check boxes to select the correct Oracle order, and then click **OK**. The order is added to the list of Oracle orders.

7.3 ARCHIVE COMPUTER

When a computer is archived, a snapshot of the computer details is saved before the computer is removed from the system. Since an archived computer is removed, all licenses currently attached to it are released. The saved details can be accessed using the computer report **Archived computers** or the **Search for computers** page if the filter **Show archived** is added.

NOTE

An archived computer does not consume, that is, does not count towards the unit limit of the Snow License Manager license.

7.3.1 ARCHIVE ONE COMPUTER

- 1. Navigate to the specific computer to be archived.
- 2. On the context menu, click **Edit computer**.
- 3. Click **Archive** in the top right corner, and then click **Yes**.

7.3.2 ARCHIVE ONE OR MORE COMPUTERS

- 1. On the **Computers** menu, click **Search for computers** and find the computers to be archived.
- 2. Select the check boxes to the left of the computers to be archived.
- 3. On the context menu, click **Archive computers** and then click **OK**.

7.4 DELETE COMPUTER

For information on how to delete computers, see Category views.



8 MOBILE DEVICES

This chapter describes how to manage mobile devices in Snow License Manager.

8.1 MOBILE DEVICE DETAILS

The information boxes in the **Mobile device details** view shows information on usage and cost according to the following table.

- 4. Edit the information in the fields on the tabs according to the following sections.
- 5. Click Save.

8.2.1 GENERAL TAB

To enter information on the **General** tab:

- 1. Enter information on **Purchase date**, **Purchase price**, **currency**, **Vendor** and **Invoice reference**. Note that currency may vary and does not have to correspond to the default viewing currency.
- 2. Select mobile device **Status** from the list:
 - **Active** The mobile device is active in the system and will require licenses for installed applications.



- Quarantined The mobile device is placed in quarantine, but will still require licenses for its installed applications. If automatic quarantine management is activated (in Snow MACC) the mobile device will automatically be placed in quarantine and removed from the system when it stops reporting inventory data.
- Inactive The mobile device is not active in the system (when in storage for example) and does not require licenses for its installed applications. The mobile device is not included in compliance calculations. However, if the mobile device is still reporting to the Snow Inventory server, it will update its data in Snow License Manager. When an inactive mobile device reports inventory data, an alert is displayed.
- 3. Select **Organization** node that this mobile device belongs to from the list.
- 4. In the **Security code** box, type any anti-theft label on the mobile device.
- 5. To disable auto connect rules, select the **Disable auto editing** check box.
- 6. To prevent the mobile device from being placed in quarantine status or removed from the system if it stops reporting inventory data, select the **Disable automatic quarantine management** check box.

8.2.2 AGREEMENTS TAB

On the **Agreements** tab, select one or more check boxes to attach the mobile device to one or more agreements.

If the correct agreement is not available in the list, it has to be created.

8.2.3 CUSTOM INFORMATION TAB

On the **Custom information** tab, enter information and values in the custom fields that are available for the **Computer/mobile device** category.

For more information, see Enter custom field information.

8.2.4 IDENTIFIED FILES TAB

The **Identified files** tab shows all identified inventoried application files on the mobile device. No changes can be made on this tab.

8.2.5 DOCUMENTS TAB

On the **Documents** tab, click **Add document** to upload documents or add links related to the mobile device.

For more information, see Manage documents and links.

8.3 DELETE MOBILE DEVICE

For information on how to delete mobile devices, see Category views.



9 DATACENTERS AND CLUSTERS

This chapter describes how to manage datacenters and clusters in Snow License Manager.

9.1 DATACENTERS AND CLUSTERS

The **Datacenters and clusters** overview provides a summary with information on licensed applications, physical servers, and virtual machines (inventoried and total number) on each identified datacenter/cluster.

Datacenters and clusters that have been added based on inventory data are indicated as "auto generated" in the **Description** column.

9.1.1 DATACENTER/CLUSTER DETAIL VIEW

The information boxes in the **Datacenter/cluster details** view shows information on for example the number of hosts, processor, and cores, according to the following table.

* The license coverage shows the percentage of all licensable applications on all hosts and their virtual machines that are fully covered by licenses. The license coverage is an indicator of the overall level of risk of the datacenter.

9.2 ADD DATACENTER AND CLUSTER

- 1. On the **Computers** menu, click **Datacenters** and clusters. The **Datacenters** and clusters view appears.
- On the context menu, click Add datacenter/cluster. The Datacenter and cluster detail view appears.
- 3. Enter information on the **General**, **Hosts**, and **Extended coverage** tabs according to the following sections.

9.2.1 GENERAL TAB

Use the fields on the **General** tab to enter information on the datacenter/cluster:

- 1. Type a **Name** for the new datacenter/cluster.
- 2. Select **Organization** node that the datacenter/cluster belongs to from the list.
- 3. For datacenters that are managed by a controller, select the **Controller** from the list.
 - To add a **Controller**:
 - a. Select the **Select a controller** drop-down list. The **Search controller** dialog appears.
 - b. Select the controller manually from the list, or click **Search controller** and start typing a search criterion; a list of computers that match the search criterion is displayed.
 - c. Select the computer to use as controller.
 - To remove a **Controller**, click the **Select a controller** drop-down list, and then select **Clear**.
- 4. Type a **Description** for the datacenter/cluster.
- 5. Select the **Hypervisor technology** that is used for the datacenter/cluster.
 - If VMware vSphere is selected as hypervisor, an additional option appears at the bottom of this screen. Select Datacenter is a VMware DRS cluster if the VMware DRS feature has been enabled for this cluster.
- 6. Select **High availability enabled** if high availability is used for the datacenter/ cluster. If you are unsure whether it is, check with the administrator of the cluster.



NOTE

In the following scenario, most of the **General** tab settings are derived automatically:

- The Snow Integration Connector for VMware vSphere has been activated in the Snow License Manager environment.
- A datacenter/cluster is using **VMware vSphere** as its hypervisor technology.

In this case, the configuration of this particular VMware vSphere datacenter/cluster will be passed to Snow License Manager, which means that you will see the following on the **General** tab here on the **Edit datacenter/cluster** page:

- All of the fields will be grayed out, with the exception of Organization, Controller (host), and Description, which will still be editable.
- The Hypervisor technology will be VMware vSphere, and the following will be set automatically—selected or not—depending on this datacenter/cluster's particular VMware vSphere configuration:
 - High availability enabled
 - Datacenter is a VMware DRS cluster

By design, these grayed-out settings cannot be manually changed, as having them in place is instrumental in licensing Windows Server environments correctly. These settings ensure that licensing requirements are covered for hosts with virtual machines running in datacenters/clusters that use VMware vSphere hypervisor technology.

In other words, implementing the VMware vSphere connector provides an automated way to reach improved license compliance calculations; in addition, these settings are also used in the Windows Server Assessment report.



9.2.2 HOSTS TAB

Use the **Hosts** tab to add servers that will be included in the datacenter/cluster:

- 1. Click Add hosts.
- 2. To select hosts, either use the check boxes on the left-hand side of the screen to select multiple hosts, or filter the list of available hosts by typing a search criterion and subsequently select hosts; a list of computers that match the search criterion is automatically displayed.
- 3. Select the servers to be added, and then click **Save**.
- 4. The selected servers are added to the **Hosts** list.

To delete a host, click **Delete** on the right-hand side of the host to delete.

9.2.3 EXTENDED COVERAGE TAB

Use the **Extended coverage** tab to specify for which datacenter/cluster the coverage should be extended to, for which application, and for what reason.

- Select Extend coverage.
 The Select application screen appears.
- Select the Select application drop-down list. The Search for application dialog appears.
- 3. Select the application manually from the list, or select **Search for application** and start typing a search criterion; select the application from the list of applications that match the search criterion.
- 4. Select a reason from the **Coverage reason** list.
- 5. Select **Select datacenter/cluster**.
- 6. Select the datacenter/cluster to extend coverage to.
- 7. Select **Extend coverage**.

The selected datacenter/cluster is added to the list of datacenters/clusters with extended coverage.

9.3 EDIT DATACENTERS AND CLUSTERS

For information on how to edit datacenters and clusters, see Category views. For information on how to edit the information on the tabs, see Add datacenter and cluster.



10 **DEVICES**

This chapter describes how to manage devices in Snow License Manager.

10.1 DEVICES

A device is a computer or object that has been connected to one or more remote desktop servers and/or virtual desktops. A device could be either an inventoried computer or a non-inventoried object.

Select **List all devices** from the category navigation to see all devices in the IT environment. Click a device to see the device details.

10.1.1 DEVICE DETAIL VIEW

The top section of the detail view contains general information on the device.

The bottom section of the detail view contains detailed information on the device. The information is presented in tabs according to the following table.

Tab	Description

Applications	Applications installed on the device
Remote servers	The remote desktop servers that the device has been connected to
Virtual desktops	Available if the device has accessed a virtual desktop, and displays a list of the virtual desktops that the device has been connected to.

General	General information on the device. The information in the list is sorted by information type.

10.2 EDIT DEVICE

- 1. On the **Computers** menu, click **List all devices** and find one or more devices to be edited.
- 2. To edit one device:
 - a. Click the device row.The **Device detail view** appears.
 - b. On the context menu, click **Edit device**.
- 3. To edit several devices at the same time:
 - a. Select the devices.
 - b. Click Edit devices on the context menu.
 The Multiple device editing view appears.
- 4. Edit the information in the fields on the **General** tab according to the following section.



5. Click Save.

10.2.1 GENERAL TAB

Use the fields on the **General** tab to edit information on the device:

- 1. Select **Organization** node that this device belongs to from the list.
- 2. Select device **Status** from the list:
 - Active The device is active in the system and will require licenses for installed applications.
 - **Quarantined** The device is placed in quarantine, but will still require licenses for its installed applications. If automatic quarantine management is activated (in Snow MACC) the device will automatically be placed in quarantine and removed from the system when it stops reporting inventory data.
- 3. To prevent the device from being placed in quarantine status or being removed from the system if it stops reporting inventory data, select the **Disable automatic quarantine management**.

11.1 USERS DETAIL VIEW

To show detailed information on a specific user, click the item in a list of users.

The top section of the detail view contains general information on the user.

- 1. On the **Users** menu, click **List all users** or **Search for users** and find one or more users to be edited.
- 2. To edit one user:
 - a. Click the user row.
 The **User detail view** appears.
 - b. On the context menu, click **Edit user**.
- 3. To edit several users at the same time:
 - a. Select the users.
 - b. Click Edit users on the context menu.The Multiple user editing view appears.
- 4. Edit the information in the fields on the tabs according to the following sections.
- 5. Click Save.

11.2.1 GENERAL TAB

Use the fields on the **General** tab to enter information on the user:

- 1. Select **Organization** node that this user belongs to from the list.
- 2. If not populated already, type **Full name** of the user to facilitate searches. Normally, this information is automatically populated by Snow Inventory.
- 3. Type the user's contact information; Location, Room number, Phone number, Mobile phone number, and E-mail.
- 4. Select user **Status** from the list:
 - Active The user is active in the system and will require licenses for usage of applications.
 - **Quarantined** The user is placed in quarantine, but will still require licenses for its usage of applications. If automatic quarantine management is



activated (in Snow MACC) the user will automatically be placed in quarantine and removed from the system when it stops reporting inventory data.

- 5. To prevent the user from being placed in quarantine status or being removed from the system if it stops reporting inventory data, select the **Disable automatic quarantine management** check box.
- 6. To disable auto connect rules, select the **Disable auto editing** check box.

11.2.2 CUSTOM INFORMATION TAB

On the **Custom information** tab, enter information and values in the custom fields that are available for the **Users** category.

For more information, see Enter custom field information.

11.2.3 APPLICATION RIGHTS TAB

Use the **Application rights** tab to add and remove application rights to the user.

11.2.3.1 ADD APPLICATION RIGHTS

- Click the Search for application icon. The Find application dialog box appears.
- Type a search criterion, and then click **Search**.
 A list of applications that match the search criteria is displayed.
- 3. Select the application to be added from the list, and then click **OK**.
- 4. Click **Add**. The selected application is added to the list of assigned applications.
- 11.2.3.2 REMOVE APPLICATION RIGHTS
 - Click the **Remove** × icon.
 The application is removed from the list of assigned applications.

11.2.4 DOCUMENTS TAB

On the **Documents** tab, click **Add document** to upload documents or add links related to the user.

CLOUD

The **Cloud** category in Snow License Manager gives detailed information on cloud services, such as Adobe Creative Cloud, Microsoft 365, and other SaaS (Software as a Service) providers.

Cloud services, also called SaaS services, are often licensed using a subscription model, which are purchased on an ongoing basis. A subscription, or subscription plan, entitles the user to one or several included applications.

ADOBE CREATIVE CLOUD

Use the Adobe Creative Cloud pages in Snow License Manager to find optimization opportunities for your license utilization and costs.

12.1.1 DESCRIPTION

The **Adobe Creative Cloud** pages provide information on the licenses, users, and costs for Adobe Creative Cloud. To populate the pages with data you need inventory sources, and to get correct statistics and insights you must add cost periods to the licenses and link users. See Prerequisites for more information.

On the **Licenses**, **Users**, and **Cost** pages you can explore activity, availability and spend for your Adobe Creative Cloud, to find optimization opportunities and potential cost savings.

The **Insights** show the potential cost savings and optimization opportunities for your Adobe Creative Cloud licenses specifically, and link to the corresponding report. On the **Reports** page you can directly explore and export all reports related to Adobe Creative Cloud. The **Portals** page shows all of your configured Adobe Creative Cloud portals which you import data from.

NOTE

Adobe Creative Cloud customers with an Enterprise (ETLA) agreement must be aware that manually changing the license quota for the licensing profiles in the Adobe Admin Console might cause Snow License Manager to show an incorrect number of licenses. To show the correct number of licenses, the sum of license quotas for all licensing profiles must equal the total licenses purchased.

12.1.2 CHARACTERISTICS

The statistics are presented in charts and tables. Several filters are available.

12.1.2.1 Filters

There is one main filter for portals and license plans, affecting most data, and column filters in tables.

Filter

The main filter affects all data in the **Licenses**, **Users**, and **Cost** pages but not **Reports** or **Insights**.



• Portals

Select one or several Adobe portals to filter data from.

• License plans

Select one or multiple license plans to filter data on.

Column filter

Search or select a metric in a column to filter data in the table. This affects data exports from the table.

NOTE

For proper recognition of Adobe Acrobat edition by the agent, you may require an Adobe Acrobat Registry Scan script from Snow's Data Intelligence Service. Contact Snow Software Support for access to and help with the script.

ADD COST PERIODS AND LINK USERS

To get accurate statistics and insights in the **Adobe Creative Cloud** pages, cost periods must be added and Adobe Creative Cloud users linked to Snow inventoried users.

Add cost periods

Information imported from the Adobe Creative Cloud portal only contains the total number of licenses and the number of licenses that have been assigned to users. There is no information about the costs for the Adobe Creative Cloud licenses in the portal, so the cost periods must be added manually.

See Manage cost periods on how to add, edit and delete cost periods on the **Cost** page.

Link users

To automatically detect license coverage of applications, users gathered from the inventory sources and the Adobe Creative Cloud portal users must be linked. The usage of on-premises applications can then be connected to the corresponding user and license.

Users are linked during the import of the Adobe Creative Cloud connector by matching the email addresses of Snow License Manager users with the Adobe user names from the Adobe Creative Cloud Portal. If a match is found, the user is linked. When no match is found, the user remains unlinked. To see users that are not linked, go to the **Link users** page.

See Manage user linking on how to improve automatic linking and manually link users.



MANAGE USER LINKING

Learn how to improve and manage linking of Adobe Creative Cloud users with Snow inventoried users in Snow License Manager.

Users are linked during the import of the Adobe Creative Cloud connector by matching the email addresses of inventoried Snow License Manager users with the Adobe user names from the Adobe Creative Cloud Portal. The best way to retain accurate user linking is to keep user email addresses up to date in the Adobe Creative Cloud portal.

12.1.4.1 Improve user linking with Active Directory user discovery

Use Active Directory user discovery to improve the automatic user linking and bring additional value to the Adobe Creative Cloud feature.

• Enable Active Directory user discovery in the Snow Inventory Server to collect user data from Active Directory. The collected data is used to generate user objects in Snow License Manager so that they can be linked to the users from Adobe Creative Cloud portal data during imports. See Snow Inventory Server Admin Console for information on how to enable Active Directory user discovery.

12.1.4.2 Improve user linking through manual matching with Adobe user names

If Active Directory user discovery is not used to improve user linking, you can improve it by editing the email addresses of inventoried users through an import or manually.

- Create a list with the user names of the Snow License Manager users that you want to match with a corresponding Adobe Creative Cloud user. The Snow License Manager users are found in the **All users** report or in the **List all users** view.
- 2. Add a column with the matching Adobe user name for each user.
- 3. Import the data by updating the existing users according to Import data. At the **Field mappings** step, ensure that the Adobe user name field is mapped to the **Email address** field.

You can also manually edit the email address for users one by one, by entering the Adobe user name in **E-mail** for the user. See Edit users for more information.

12.1.4.3 LINK USERS MANUALLY

When you have Adobe Creative Cloud users that cannot be automatically linked with Snow inventoried users, you can instead link them manually based on suggested matches and searches on the **Link users** page.

TIP

One Adobe account can be linked to several Snow inventoried users.

- 1. In the **Adobe Creative Cloud** navigation bar, select **Link users**.
- On the Users to link tab, review the suggested matches in the table. The table rows show Adobe users and any suggested Link options to Snow inventoried users. The link options can be inventoried user names, full names, or email addresses.
- 3. Select the rows for the Adobe users you want to link.



- 4. Optionally, in the **Link options** column, change the suggested matches or add more users to be linked.
 - To add a user:
 - a. In the **Link options** column, start typing a user name, full name, or email address. The search results appear as you enter text.
 - b. Select the user to link.
 - c. Repeat to add more users.
 - To remove a user, select the remove icon for that user.
- 5. To review the user linking, select **Preview**.
 - To add or remove users in the **Link options** column, see Step 4.
 - To remove a user linking completely, select the trach can icon for that Adobe user.
- 6. To confirm the user linking, select **Save**.

12.1.4.4 Edit manual user linking

To edit or remove a manual user linking, do the following:

- 1. In the **Adobe Creative Cloud** navigation bar, select **Link users**.
- 2. On the **Linked users** tab, do one of the following:
 - To add or remove users in the **Link options** column, see **Link users manually** Step 4, and then select the save icon.
 - To remove a user linking completely, select the trash can icon for that Adobe user. This unlinks the user accounts and the Adobe user is moved to the Users to link tab.
- 12.1.4.5 Improve search time when linking users manually

NOTE

This can only be performed by the system administrator.

In Snow License Manager, the **Snow Software SLM Cache Server Service** caches data on Snow inventoried users. For this purpose, there is a **EnableCachingUsers** setting in the appsettings.json file of the service. This setting is enabled by default.

To reduce the search time when you want to manually link Snow inventoried users to Adobe Creative Cloud users, you can use the cached information instead of the real-time information in the Snow License Manager database. When you run a search against the cached information, you get a faster response. However, the cache is only updated automatically once a day so you will not see more recent changes without manually refreshing the cache.

To enable searches against the cached information, do the following:

- 1. Stop the **SnowLicenseManagerAdobeCCBFF** service.
- 2. Navigate to and open the appsettings.json file located in C:\Program Files\Snow Software\Snow License Manager\Services\AdobeCCBFF.
- 3. Change **SImUsersFilteringSource** to **MongoDB**. The default value is **SLMDatabase**.



- Optionally, change PageSizeUsersBySearchTerm.
 The property defines the maximum number of fetched Snow License Manager users that can be returned in the response. The default value is 100.
- 5. Save the changes in the appsettings.json file.
- 6. Start the **SnowLicenseManagerAdobeCCBFF** service.
- 7. Stop the **SnowCacheServer** service.
- 8. Navigate to and open the appsettings.json file located in C:\Program Files\Snow Software\Snow License Manager\Services\CacheServer.
- 9. Verify that **EnableCachingUsers** is set to **true**.
- 10. Optionally, under **CachingSchedule**, change the **Interval** and **StartDateTime** for the scheduled refresh of the cache.
- 11. Save any changes in the appsettings.json file.
- 12. Start the **SnowCacheServer** service.

MANAGE COST PERIODS

12.1.5.1 VIEW COST PERIODS

- 1. Go to the **Cost** page.
- 2. On the **Data** tab, select the license in the list.

A cost period is valid until a new cost period is added.

12.1.5.2 Add cost periods

A cost period is valid until a new cost period is added. It is possible to add both older and future cost periods. However, it is only possible to add an old cost period if there is usage data for this period imported through the connector.

You can add costs for all your Adobe portals.

- 1. Go to the **Cost** page.
- 2. On the **Data** tab, select the license in the list.
- 3. Select **Add cost period**.
- 4. Select **Portal**.
- 5. Select **Year** and **Month** when the cost period starts.
- 6. Enter the **Monthly cost** and select **Currency**.
- 7. Select **Add cost**. The new cost period appears in the list.

12.1.5.3 EDIT COST PERIODS

If the cost for a license is changed, the the monthly cost and currency can be edited. But to change the start of a cost period, a new cost period must be added.

1. Go to the **Cost** page.



- 2. On the **Data** tab, select the license in the list.
- 3. Select the **Edit** icon for the cost period that you want to edit.
- 4. In License cost, edit the Monthly cost and Currency.
- 5. Select **Save cost**. The changes appear in the list.

12.1.5.4 Delete cost periods

- 1. Go to the **Cost** page.
- 2. On the **Data** tab, select the license in the list.
- 3. Select the **Delete** icon for the cost period that you want to remove.
- Select **Delete** in the modal that appears.
 If the cost period is not removed automatically from the list, refresh the page.

MANAGE PORTALS

12.1.6.1 Prerequisites

To schedule a portal migration, cancel a scheduled portal migration, or delete a portal, you must either be assigned the **Administrator** role or be assigned the permission **ADOBECC_PORTAL_MANAGEMENT** in Snow Management and Configuration Center.

12.1.6.2 VIEW PORTALS

- 1. On the **Cloud** menu, select **Adobe Creative Cloud**.
- 2. Select **Portals**.

The table shows the **Id** and **Name** of the configured portals, and date and time of the **Last import** of data. If you have scheduled a portal migration, it will be shown as **True** in **Scheduled migration**.

12.1.6.3 DELETE PORTALS

CAUTION

A deleted portal cannot be restored. When you delete a portal, you also delete all information on costs and linked users.

- 1. On the **Cloud** menu, select **Adobe Creative Cloud**.
- 2. Select **Portals**.
- 3. On the **Portals** tab, find the portal you want to delete, and then select **Delete**.
- 4. In **Delete portal**, enter the name of the portal to confirm the deletion, and then select **Delete**.

12.1.6.4 MIGRATE PORTALS

You can migrate information on costs, linked users, and monthly breakdown data from one portal to another. After the migration to the destination portal, the source portal is deleted.



CAUTION

A migrated and deleted portal cannot be restored. When you delete a portal, you also delete all information on costs and linked users.

The following rules apply for a migration:

- Cost periods in the source portal will be migrated if they **don't exist** in the destination portal.
- Data on linked users in the source portal will only be migrated for the users who also exist in the destination portal.

You always set up the migration as a scheduled task. By default, the scheduled migrations will run daily at 04:00 AM, but the time is configurable, see Configure time for scheduled portal migrations. You can also chose to run the migration manually, see Run portal migrations manually.

NOTE

Since a migration can take a long time to complete, it is recommended to schedule it outside of business hours.

- 1. On the **Cloud** menu, select **Adobe Creative Cloud**.
- 2. Select **Portals**.
- 3. Select the **Migrate portals** tab.
- 4. In the **Select source portal** step, select the portal you want to migrate data from, and then select **Next**.
- 5. In the **Select destination portal** step, select the portal you want to migrate data to, and then select **Next**.
- 6. In the **Confirm migration** step, enter the name of the source portal to confirm the migration, and then select **Migrate**.

12.1.6.5 CONFIGURE TIME FOR SCHEDULED PORTAL MIGRATIONS

You configure the time for scheduled portal migrations in the **appsettings.json** file.

Do the following on your Snow License Manager application server:

- 1. Stop the service **SnowLicenseManagerAdobeCCService**.
- 2. Open the **<install_dir>\Snow Software\Snow License Manager\Services\AdobeCC\appsettings.json** file.
- 3. Change the following entry to your preferred time:

"PortalMigrationTime": "04:00",

- 4. Save the changes to the **appsettings.json** file.
- 5. Start the service **SnowLicenseManagerAdobeCCService**.

12.1.6.6 RUN PORTAL MIGRATIONS MANUALLY

You can chose to run scheduled migrations manually instead of waiting until the scheduled time.



- 1. On the **Cloud** menu, select **Adobe Creative Cloud**.

- 3. On the **Portals** tab, select **Run portals migration**.

12.1.6.7 CANCEL SCHEDULED PORTAL MIGRATIONS

MICROSOFT 365

Use the Microsoft 365 pages in Snow License Manager to find optimization opportunities for your subscription utilization and costs.

12.2.1 DESCRIPTION

The **Microsoft 365** pages provide information on the subscription plans, user activity, and costs for the cloud service. To populate the pages with data you need inventory sources, and to get correct statistics and insights you must add cost periods to the subscriptions and link users. See Prerequisites for more information.

On the **Subscriptions**, **Users**, and **Cost** pages you can explore activity, availability and spend for all your Microsoft 365 subscriptions and users, to find optimization opportunities and potential cost savings.

The **Overview** page relates the most important messages for the following metrics:

- **Subscriptions**: Shows how many of your subscriptions that have been provisioned (assigned) to a user.
- **Users**: Shows how many of the users with provisioned subscriptions that have been active within the last 90 days.
- **Spend**: Shows how much you spend on unprovisioned (unassigned) subscriptions and inactive users.
- Subscription utilization: Shows how well you utilize each subscription with user-based metrics, divided into active users, inactive users, and unprovisioned (unassigned) subscriptions.

The **Insights** show the potential cost savings and optimization opportunities for your Microsoft 365 subscriptions specifically, and link to the corresponding report. On the **Reports** page you can directly explore and export all reports related to Microsoft 365. The **Portals** page shows all of your configured Microsoft 365 portals which you import data from.

12.2.1.1 DEFINITIONS

Definitions of subscription terms in the Microsoft 365 pages:



- **Assigned** and **Provisioned** means the number of subscriptions that you have assigned to users.
- Unassigned and Unprovisioned means the number of subscriptions that you have available to assign to users.
- **Overassigned** means the number of subscriptions that you have assigned that exceeds the number that you have bought. Often these over-allocated subscriptions are reconciled in your next invoice or renewal.

12.2.1.2 USER ACTIVITY

User activity means when the user last had any activity in the application. Activity data comes from one or several inventory sources. In such a case, the latest available activity is shown regardless of inventory source. For some applications, activity cannot be monitored.

The Microsoft 365 portal provides activities for some applications: Outlook, OneDrive, Sharepoint, Teams, Yammer, Skype. Activities for all other Microsoft 365 applications are collected through Snow Inventory Agents and Cloud Application Metering: Power BI, Visio, Project, Apps for Enterprise, Dynamics365, Office Online.

To always show updated user activity data in the **Microsoft 365** pages, you are recommended to scan your inventory sources regularly. See Prerequisites for more information.

NOTE

Changes from Snow License Manager 9.12

After installation of Snow License Manager 9.12, when the O365 service is started, migration of historic data for user activity starts automatically. The migration is only executed once, at this first start of the O365 service. The **Subscription utilization** chart on the **Activity** page shows accurate data, including inactive users, only for periods occurring **after** installation of Snow License Manager 9.12. Historic data from before the installation of Snow License Manager 9.12 shows only active users and the numbers are **approximate**, only used to show **trends**.

Refer to Microsoft 365 functionality for more information on the migration of user activity historic data.

12.2.2.1 FILTERS

There are several types of filters available to filter data in charts and tables.

Portal filter

Select a Microsoft portal to filter data from. The filter affects **all** pages that display data from the chosen portal: **Overview**, **Subscriptions**, **Users**, **Cost**. The filter can be selected from all of those pages.

Subscription filter

Select one or multiple subscriptions to filter data on in the **At a glance** chart or in subscription and cost charts. The filter contains subscriptions that have user-based metrics. The filter only affects the chart.



Annual filter

Select a year to filter data on in charts. The filter only affects the chart.

Column filter

Search in a column to filter data in tables. The filter only affects the table.

Add cost periods

Information imported from the Microsoft 365 portal only contains the total number of subscriptions and the number of subscriptions that have been assigned to users. There is no information about the costs for the Microsoft 365 subscriptions in the portal, so the cost periods must be added manually.

Link users

To automatically detect license coverage of applications, users gathered from the inventory sources and the Microsoft 365 portal users must be linked. The usage of on-premises applications can then be connected to the corresponding user and subscription plan.

Manual linking and unlinking is done on the **Link users** page. See Manage user linking for more information on how to set up automatic linking, manually link users, and unlink users.

MANAGE USER LINKING

12.2.4.1 LINK USERS AUTOMATICALLY WITH ACTIVE DIRECTORY USER DISCOVERY

Automatic linking through the use of Active Directory user discovery brings additional value to the Microsoft 365 feature.

• Enable **Active Directory user discovery** in **Snow Inventory Server** to collect user data from Active Directory. The collected data is used to generate user objects in Snow License Manager and link them to the users from Microsoft 365 portal data. Refer to Snow Inventory Server Admin Console for information on how to enable Active Directory user discovery.



NOTE

From Snow Inventory Server 6.5.0, the collected data includes Microsoft 365 User Principle Name (UPN). From Snow License Manager 9.8.1, user objects are created based on the Active Directory data (including UPN) and not only from inventoried users. You are recommended to update to the latest product versions. If you are using product versions earlier than Snow Inventory Server 6.5.0 and Snow License Manager 9.8.1, user linking based on UPN can be done manually as described in Link users through manual matching with Microsoft 365 UPN.

12.2.4.2 Link users through manual matching with Microsoft 365 UPN

If you are using product versions earlier than Snow Inventory Server 6.5.0 and Snow License Manager 9.8.1, you can link users by manually matching their username to their Microsoft 365 User Principle Name (UPN) and import the file.

- Find and export a list of Snow License Manager users that you want to match to a corresponding Microsoft 365 user. The Snow License Manager users are found in the **All users** report or in the **List** all users view.
- Remove all columns except the user name and add a column called Microsoft 365 UPN to the user export and add the matching Microsoft 365 User Principle Name for each user.
 The Microsoft 365 users are found under Users in the Microsoft 365 paying tion.

The Microsoft 365 users are found under **Users** in the **Microsoft 365** navigation, or in the Microsoft 365 portal.

 Import the data by updating the existing users according to Import data. At the Field mappings step, ensure that the Microsoft 365 UPN field is mapped to the Email address field.

During the next import by the Microsoft 365 connector, correctly mapped users will be linked. The import can be manually triggered in the Snow Integration Manager user interface.

12.2.4.3 LINK USERS MANUALLY

For users that can not be automatically linked, manual linking is done based on suggested matches.

- 1. In the **Microsoft 365** navigation bar, select **Link users**. The **Link users** view appears.
- Select the Users to link tab, if it is not already shown. The list shows users that can be linked to a matching inventoried user. If you are satisfied with the suggestion, go to Step 4.

NOTE

If several matching users exist, chose which inventoried user to link to.

3. To change the default suggestion, select another option in the **Link options** column.

Mark as online only will not connect the user to an inventoried user account. **Keep unlinked** will move the user to the **Unlinked users** tab.



4. Select **Preview**.

A list with your selected link options is shown.

- 5. To edit or delete a linking choice, use the icons on each row.
- 6. Select **Save** to confirm the linking options.
- 7. The **Users to link** tab is shown.

If all users are linked, or if users are not yet inventoried in Snow License Manager, the list is empty, otherwise it shows the remaining suggestions for users to link.

12.2.4.4 UNLINK USERS

A Microsoft 365 user that has been linked to an inventoried user, or marked as online only, can be unlinked.

A deleted portal cannot be restored. When you delete a portal, you also delete all information on costs and linked users.

12.3.1 DESCRIPTION

The **SaaS overview** provides an overview of which SaaS (Software as a Service) service providers are being used in your organization, by which users and how much they are using them. The information is imported from the respective service provider via Snow Integration Connector for SaaS.

Select a SaaS service provider to explore details for the provider, and then select a subscription to explore more details for the specific subscription type.

To populate the **SaaS overview** pages with data you need inventory sources, and to get correct statistics and insights you must add cost periods to the subscriptions. See Prerequisites for SaaS overview for more information.

12.3.2 CHARACTERISTICS

ADD COST PERIODS

To get accurate statistics and insights in the **SaaS overview** pages, you must add cost periods.

The information imported from SaaS providers covers the total number of subscriptions and the number of subscriptions that have been assigned to users. However, there is no information about the costs for the subscriptions from the service providers. Therefore, the cost periods must be added manually to provide accurate statistics and charts. Refer to Manage cost periods in SaaS overview on how to add and delete cost periods.

MANAGE COST PERIODS IN SAAS OVERVIEW

Learn how to add and delete cost periods for SaaS subscriptions in Snow License Manager.

12.3.4.1 ADD COST PERIODS

A cost period is valid until a new cost period is added. Hence, if the cost for a license or a subscription plan changes, a new cost period must be added. It is possible to add both older and future cost periods. However, it is only possible to add an old cost period if there is imported user data for this period.

1. On the **Total monthly cost** tab for the subscription type, select **Edit cost periods**.

The **Cost periods** dialog box appears.

- 2. Select Add new cost period.
- 3. Select the month and year from when the periods starts.
- 4. Set the price for the subscription plan or subscription and select the currency for the period.

NOTE

For SaaS subscriptions, the cost model can vary and depends on the service provider.

5. Select **Add period**.

The added cost period is being processed.

- 6. Select **Close**.
- 7. If the cost period is not added automatically, refresh the page.



12.3.4.2 Delete cost periods

It is not possible to edit a cost period, but it is possible to delete a cost period.

- On the Total monthly cost tab for the subscription type, select Edit cost periods. The Cost periods dialog box appears.
- 2. Select **Delete** for the cost period to be deleted.
- 3. Select **Yes, delete period**. The deleted cost period is being processed.
- 4. Select **Close**.
- 5. If the cost period is not deleted automatically, refresh the page.



13 AGREEMENTS

Agreements, including master and sub-agreements, can be viewed and managed in the Agreements category.

This section also covers how to manage Oracle agreements in the Enterprise category.

13.1 AGREEMENTS DETAIL VIEW

To show detailed information on a specific agreement, click the item in a list of agreements.

The top section of the detail view contains general information on the agreement.

13.1.1 TOTAL COST

If there are licenses linked to an agreement, the **Total cost** or value of the agreement is visible from the top section of the agreement detail view. If no financial information is visible within the agreement, then either there are no licenses linked to the agreement or there is no financial information entered on the license. Note that incomplete license purchases are not included in the Total cost.

To see a cost breakdown for all licenses attached to the agreement, click the **Total cost** box.

13.2 ADD AGREEMENT

NOTE

Oracle agreements are not described here. For instructions on how to add Oracle agreements, see Manage Oracle agreements.

To add an agreement, other than an Oracle agreement:

- 1. On the **Agreements** menu, click **Add agreement**. The **Add agreement** view appears.
- 2. Enter information in the fields on the tabs according to the following sections.
- 3. Click **Save**.

13.2.1 GENERAL TAB

Use the fields on the **General** tab to enter general information, for example agreement type and agreement number, on the agreement.

ΝΟΤΕ

Depending on selected agreement type, available fields and options will vary.

1. Select agreement **Type** from the list.



To be able to attach licenses to the agreement, select **Software agreement**. All other agreement types are hardware related so it is not possible to attach a license. For more information about Agreement types, see Agreement.

- 2. Type **Agreement number** and **Agreement name** according to the manufacturer. If the agreement has an Agreement number and Agreement name, then use those. However, if there is no unique number or specific agreement name, internally agree on a naming convention so it is done the same way by everyone within the organization.
- 3. To automatically attach computers to the agreement (not available for Software agreements), select the **Auto attach computers** check box and select organization nodes from the list.
- 4. For subscription agreements, select the **Subscription agreement** check box.

NOTE

The period of a Subscription agreement will override any Subscription period for licenses attached to the agreement if the **Subscription agreements** check box is selected. This impacts which licenses are included in the compliance calculation. If you wish to add a subscription period for each license instead then do not check this check box. You can still add expiration and renewal information.

- 5. For software agreements with upgrade rights, select the **Upgrade rights** check box to specify that upgrade rights apply, and that each license manually added and connected to the agreement will have upgrade rights.
- 6. To always have the agreement visible when you want to search for and attach agreements to license purchases, select **Include in searches where license purchase date is outside of active period**. The agreement will then be visible even if the agreement period has expired or has not yet started at the time of the license purchase date.

13.2.2 AGREEMENT PERIODS TAB

Use the **Agreement periods** tab to specify start and end dates for the agreement. Note that agreement periods cannot overlap.

If the agreement is renewed check whether all licenses attached to the agreement are included in the renewal:

- If the **licenses are included in the renewal** add the new agreement period to the existing agreement.
- If the **licenses are not included in the renewal** do one of the following:
 - Create a new agreement for the renewal and attach the licenses covered by the renewal.
 - Add the new periods to the existing agreement but detach the licenses which are not covered by the new agreement.

To edit the detail on the **Agreement periods** tab:

- 1. Click **Add new period**.
- 2. Select dates from the **Valid from** and **Valid to** lists, and then click **OK**. The agreement period is added to the list.



13.2.3 CONTACT INFO TAB

Use the Contact info tab to add contact information, for the contractor as well as for the agreement owner within your own organization:

Add contact information on **Contractor**, **Contractor** contact, and **Local contact**. If the agreement was signed with the application manufacturer add that manufacturer as Contractor. If the agreement was signed through a reseller, add the reseller as Contractor. The local contact is the agreement owner within the organization.

13.2.4 ALERTS TAB

Use the **Alerts** tab to specify if agreement expiration should give alerts on the Snowboard/Overview.

- 1. To activate agreement alerts, select the **Activate alerts on and before agreement expiration** check box.
- 2. In the **Renewal** box ^O, type the number of days before expiration that this agreement needs to be renewed, or is automatically renewed as stated in the agreement.

EXAMPLE

If the actual renewal date is the end date of the agreement, type 0.

If the renewal date is 3 months before the end date of the agreement, type 90.

- 3. In the **Warning** box **A**, type the number of days before expiration that an agreement alert will appear as a warning.
- 4. In the **Critical** box **(**), type the number of days before expiration that an agreement alert will appear as critical.

It is also possible to add email notifications to give alerts when an agreement is about to expire. For more information, see My notifications.

13.2.5 DESCRIPTION TAB

Use the **Description** tab to add specific information related to the agreement, for example metrics, geographical restrictions and use rights. This will save time when adding licenses relating to the agreement as the key information will be easily visible, rather than having to search through the attached agreement document each time.

Read through the agreement and copy and paste or type the specific information in the white area of the tab.

13.2.6 DOCUMENTS TAB

Use the **Documents** tab to upload documents or add links related to the agreement. It is recommended to give the documents meaningful names to prevent having to open each document to see what it is.

Click **Add document** to upload documents or add links related to the agreement.

For more information, see Manage documents and links.



13.2.7 CUSTOM INFORMATION TAB

Use the **Custom information** tab to enter information and values in the custom fields that are mandatory for the **Agreement** category.

For more information, see Enter custom field information.

13.2.8 SECURITY TAB

The **Security** tab is used to manage the security for the agreements, on an organization and role level. By attaching the agreement to one or more roles, the system will only make the agreement available to users attached to the specific role. For management of roles, refer to the User Guide for Snow Management and Configuration Center.

- To limit access to the agreement on an organization level, select an organization node from the Organization access list and select the Restrict access according to organization setting check box.
- To limit access to the agreement on a role level, select the Allow access to the following roles only check box and use the check boxes to the left to select the roles.

13.3 EDIT AGREEMENT

You can edit single agreements or you can edit several agreements at the same time, as long as the selected agreements are of the same type.

NOTE

Oracle agreements are not described here. For instructions on how to edit Oracle agreements, see Manage Oracle agreements.

To edit <u>one</u> agreement, do the following:

- 1. On the **Agreements** menu, click **List all agreements** or **Search for agreements** and find the agreement you want to edit. For information on how to sort, filter, and add more columns to the list, or how to search, see Manage lists or Search for Mobile devices, Users, Agreements, Licenses, and Objects.
- Click the agreement row.
 The Agreement detail view appears.
- 3. Click **Edit agreement**.
- 4. Edit the information in the fields on the tabs according to Add agreement.
- 5. Click **Save**.

To edit <u>several</u> agreements at the same time, do the following:

- 1. On the **Agreements** menu, click **List all agreements** and find the agreements you want to edit. You can sort and filter the list, or add more columns. For more information, see Manage lists.
- 2. Use the checkboxes to select the agreements you want to edit.
- 3. On the context menu, click **Edit agreements**.
- 4. Edit the information in the fields on the available tabs according to Add agreement.



5. Click Save.

13.4 MANAGE SUB-AGREEMENTS

There are two ways of connecting agreements to each other. An agreement can either be attached to another agreement as a sub-agreement, or be selected as master to another agreement which will then act as a sub-agreement.

In the **List all agreements** view, the relationships between master and sub-agreements is indicated by an arrow S.

13.4.1 ADD SUB-AGREEMENT

- 1. Navigate to the agreement that will be used as master.
- 2. On the context menu, click **Add sub-agreement**.

NOTE

For Oracle agreements, click **Add sub-agreement** on the **Sub-agreements** tab or on the context menu.

3. Add a new agreement according to Add agreement

13.4.2 ATTACH AGREEMENT TO MASTER

- 1. Navigate to the agreement that will be used as sub-agreement.
- 2. On the context menu, click **Attach to master**. The **Attach to master** dialog box appears.
- Select the agreement that will be used as master from the Agreement list and click Save.
 The sub-agreement is added to the Sub-agreements tab of the selected master agreement.

13.4.3 VIEW MASTER AGREEMENT

- 1. Navigate to the sub-agreement.
- 2. On the context menu, click **Show master agreement**.



The Master agreement detail view appears.

13.4.4 DETACH SUB-AGREEMENT

- 1. Navigate to the agreement to detach.
- 2. On the context menu, click **Detach from master**, and then confirm the detachment.

13.5 MANAGE CUSTOM AGREEMENT TYPES

A custom agreement type can be used in case the pre-defined agreement types in Snow License Manager are not applicable, and it can be used for any type of agreement.

- To manage custom agreement types, click Custom Agreement types on the Agreements menu.
 The Custom Agreement types view appears.
- 2. Add, edit or delete a custom agreement type according to the following sections.

13.5.1 ADD CUSTOM AGREEMENT TYPE

- On the context menu, click Add agreement type. The Add agreement type view appears.
- 2. Enter information in the fields on the tabs according to the following table.
- 3. Click **Save**.

13.5.2 EDIT CUSTOM AGREEMENT TYPE

To edit details of an existing agreement type:

- 1. Navigate to the custom agreement type to be edited.
- 2. Enter information in the fields on the tabs according to the following table.
- 3. Click **Save**.

13.5.3 DELETE CUSTOM AGREEMENT TYPE

1. Navigate to the specific custom agreement type to be deleted.



2. Click **Delete** in the top right corner, and then confirm the deletion.

NOTE

Only custom agreement types that have no agreements attached can be deleted. A deleted custom agreement type is removed from the system and cannot be restored.

13.6 ARCHIVING AND UNARCHIVING AGREEMENTS

An agreement can be archived, for example if it is not in use or if it is in a draft stage. It is kept in the database for future reference, in contrast to when an agreement is deleted and removed from the system completely. During the archiving procedure, you will have the option to archive connected licenses and agreements.

If connected licenses and agreements are not archived together, they will be disconnected. A disconnected license may become incomplete, since the agreement number and the maintenance period in the agreement is disconnected from the license.

An agreement can be unarchived to be actively used again. During the archiving procedure, you will have the option to unarchive licenses and agreements that were archived together with the selected agreeement.

If an agreement is unarchived, then previously connected licenses and agreements will be reconnected to it. However, if the licenses and agreements have been connected to another agreement already, they will not be reconnected to the selected agreement.

Archived agreements can be viewed in the report **Archived agreements**. For instructions how to find it, go to Find a report.

13.6.1 ARCHIVE AGREEMENT

- 1. On the **Agreements** menu, select **List all agreements** or **Search for agreements** to find the agreement to archive.
- Select the agreement row.
 The **Agreement detail** view appears.
- On the context menu, select Archive agreement.
 The Select agreements view appears.
- 4. Select the check boxes for the agreements to archive.
- Select the Next button if it is enabled, indicating that there are connected licenses to the selected agreements. Otherwise, continue to Step 7.
 The Select licenses view appears. The list shows licenses connected to the selected agreements.
- 6. Select the check boxes for the licenses to archive.
- 7. Select **Archive**.

The selected agreements and licenses are archived, and you are returned to the **Agreement list** view. Use the check box **Show archived** to either show or hide archived agreements in the list.



13.6.2 UNARCHIVE AGREEMENT

- 1. On the **Agreements** menu, select **List all agreements**.
- 2. Select the box **Show archived**.
- Select the agreement row.
 The Agreement detail view appears.
- 4. On the context menu, select **Unarchive**. The **Select agreements** view appears.
- 5. Select the check boxes for the agreements to unarchive.
- Select the Next button if it is enabled, indicating that there are previously connected licenses to the selected agreements. Otherwise, continue to Step 8. The Select licenses view appears. The list shows licenses previously connected to the selected agreement.
- 7. Select the check boxes for the licenses to unarchive.
- 8. Select **Unarchive**.

The selected agreements and licenses are unarchived, and you are returned to the **Agreement list** view.

14 LICENSES

In the **Licenses** category all license purchases can be viewed and managed, and compared to installations and usage.

14.1 LICENSE DETAIL VIEW

To show detailed information on a specific license, click the item in a list of licenses.

The top section of the detail view contains general information on the license purchase. Some information is clickable to show more details, such as the Incomplete warning that shows the reasons that make the license incomplete.

The bottom section of the detail view contains detailed information on the license. The information is presented in tabs according to the following table.

14.1.1 PURCHASE TAB

The **Purchase tab** displays details that are related to the license purchase.

If a license has been upgraded, the field **Upgraded to** will be available next to the **Show upgrades** link. Select **Show upgrades** to see which application that this license is upgraded to, and its quantity; select the application name to display the license that the current license is upgraded to.

If a license is upgraded from another license, the field **Upgraded from** will be available next to the **Show base licenses** link. Select **Show base licenses** to see which



application that this license is upgraded from, and its quantity; select the application name to display the license that the current license is based on.

For more information on the fields that are available in this tab, see Add license purchase

14.1.2 MAINTENANCE AND SUPPORT TAB

The **Maintenance and support** tab lets the user keep track of periodical costs connected to the license purchase. Any registered costs will be included in the **Total license cost** displayed on the **Financial info** tab in the application details view.

There are three options for adding maintenance and support periods to a license purchase;

- 1. Add period and application upgrade rights manually.
- 2. Use period and application upgrade rights according to an existing agreement that this license purchase has been registered as a part of.
- 3. Use application upgrade rights according to the application SKU, and add period manually.

If a license has manually set upgrade rights and registered periods for maintenance and support, and that is changed to be according to an agreement instead, then these manually registered settings are replaced by the settings of the selected agreement.

When an agreement is updated with a new period, any license purchases that are part of that agreement will be updated regarding their maintenance and/or support periods.

14.2 ADD LICENSE PURCHASE

Correct registration of license purchases is important to achieve accurate compliance statements from Snow License Manager.

To make the registration of a license purchase complete, Snow License Manager requires certain information to be entered, such as application, number of licenses, and metric. There may also be a license policy defined by the system administrator, making more fields mandatory.

To add a new license purchase:

- 1. Perform one of the following steps:
 - Navigate to the application, and then click Add application license on the context menu.
 - On the **Licenses** menu, click **Add License**.

The **Add license** view appears. If the license is added as an application license, the correct application is pre-selected on the **Purchase** tab.

- 2. Enter information in the fields on the tabs according to the following sections.
- 3. Click **Save**.

For more information on how to copy a license, see Copy license purchase.



14.2.1 PURCHASE TAB

Use the **Purchase** tab to enter information on the license purchase.

- 1. Enter **Date of purchase**.
- Select the Legal organization that is the owner of the license from the list. Only one legal organization can be selected for each license purchase (normally the top level of the organization). With auto allocation enabled, licenses will be allocated from selected organization level and downwards.
- Type the **Purchase price** and select **currency** from the list.
 The currency does not have to correspond with the default viewing currency.
 New currencies are added in Snow MACC.
- 4. Type an **Invoice reference**.
- 5. To select the **Application** that the license purchase applies to (if not already selected):
 - a. Click the Search sicon.
 The Find application dialog box appears.
 - The **Find application** dialog box appears.
 - b. Select to search by application name or SKU.
 - c. Type a search criterion, and then click **Search**.
 - d. Select application in the displayed list and then click **OK**.
 - e. When applicable, select **Stock-keeping unit (SKU)** from the list.
- 6. If the license is part of an **Agreement**, perform the following steps:
 - a. Click the Search Sicon.
 The Select agreement dialog box appears.
 - b. Select to search by Agreement name or Agreement number.
 - c. By default, the list shows all agreements that have a period matching the license purchase date, as well as agreements that have the option **Include in searches where license purchase date is outside of active period** selected. To also search among other agreements, select **Include agreements inactive on purchase date**.
 - d. Type a search criterion, and then click **Search**.
 - Select the Agreement from the list, and then click OK.
 The agreement period is displayed to the right of the Agreement text box.

If the agreement is not available, it could be for one of the following reasons:

- The license purchase date is not within an agreement period, and the option Include in searches where license purchase date is outside of active period is not selected for the agreement. Select Include agreements inactive on purchase date to search also among agreements that have not yet started or agreements that have expired.
- The agreement has not yet been created.
- 7. In the **Quantity** box, type the number of licenses included in the purchase. The box is only editable for new and incomplete licenses.
- 8. Select **Metric** from the list.



- 9. If the metric is **Installations** or **Users**, select **Assignment type** from the list. Depending on selected assignment type, assignments to an **Organization**, **Computer/datacenter**, **User**, or **Site** must be made on the **Assignment** tab. If no assignments are made for a metric that requires assignment, the license will be shown as unassigned and these licenses will not be considered in compliance calculations. For more information on assignment types, see Assignment types.
- 10. If the license is purchased with downgrade rights, select the **Downgrade rights** check box.
- 11. If the license is an upgrade license, select the **Upgrade license** check box. When selected, the additional tab **Base licenses** will appear.
- 12. If the license allows for coverage of applications within the family (same version) and with the <u>same or lower edition</u>, select the **Cross edition rights** check box.
- 13. If the license allows for coverage of applications within the family (same version) and with the <u>same edition</u>, regardless of the operating system they are installed on, select the **Cross platform rights** check box.
- 14. If the license is a subscription license, select the **License has a subscription period** check box, and then enter a subscription period using the **From** and **To** calendar views.

14.2.2 MAINTENANCE AND SUPPORT TAB

Use the **Maintenance and support** tab to register any maintenance and support periods and costs for this license.

If a license purchase is both part of an agreement and has a SKU with application upgrade rights, both the **According to agreement** and **Use upgrade rights according to SKU** will be available as options. However, only one option can be selected.

NOTE

Information on **Period from** and **Period to** is required, or the license purchase will be registered as incomplete.

14.2.2.1 ADD PERIOD AND UPGRADE RIGHTS MANUALLY

- 1. Click **Add period**.
 - A row with input fields is added to the table.
- 2. Select dates from the **Period from** and **Period to** calendars.
- 3. Use the **Invoice reference** and **Notes** textboxes for reference and comments (optional).
- 4. If the license includes application upgrade rights, select **Yes** from the **Upgrade rights** list.
- 5. Optionally, use the **Support cost** and **Maintenance cost** textboxes to specify the current costs.

14.2.2.2 Use period and upgrade rights from an existing agreement

 Select the According to agreement option. One or several rows with input fields are added to the table, where dates for Period from and Period to are fetched from the agreement together with any application Upgrade rights.



- 2. Use the **Invoice reference** and **Notes** textboxes for reference and comments (optional).
- 3. If the agreement includes no application upgrade rights but the license purchase does, select **Yes** from the **Upgrade rights** list.
- 4. Optionally, use the **Support cost** and **Maintenance cost** textboxes to specify the current costs.

14.2.2.3 Use upgrade rights from SKU

- 1. Select the **Use upgrade rights according to SKU** option and click **Add period**. A row with input fields is added to the table where application **Upgrade rights** are fetched from the SKU.
- 2. Select dates from the **Period from** and **Period to** calendars.
- 3. Use the **Invoice reference** and **Notes** textboxes for reference and comments (optional).
- 4. Optionally, use the **Support cost** and **Maintenance cost** textboxes to specify the current costs.

14.2.3 ASSIGNMENT TAB

Depending on the selected assignment type for the license, assignments to an **Organization**, **Computer/datacenter**, **User**, or **Site** must be made. The assignment type is selected on the **Purchase** tab. The assignment types are defined in Assignment types.

14.2.3.1 Assignment type: Organization

When adding a license, you have the option to enable automatic allocation or to manually allocate licenses. To have the licenses automatically allocated at each compliance calculation, and based on the actual needs in the organization, select the **Auto allocate** check box. To manually allocate the licenses, clear the **Auto allocate** check box.

To enable that the **Auto allocate** check box is enabled by default, configure the user settings on the Settings tab.

To select **Automatic allocation** for the license purchase:

- 1. Select the **Auto allocate** check box.
- 2. Optionally, select **Disable auto allocation after first calculation** to have the licenses allocated only once and then keep that allocation.

To select **Manual allocation** for the license purchase:

- 1. Clear the **Auto allocate** check box.
- 2. Select one organization node at a time from the list and click **OK**. The legal organization level is always added as default.
- 3. Click **Add** to add the organization node.
- 4. Type the **Quantity** of licenses allocated to each organization node.

14.2.3.2 Assignment type: Computer/datacenter

To assign the purchased licenses to one or more computers:



1. Click Add.

A search dialog box appears.

- 2. To search for a computer/datacenter:
 - a. Optionally, type search criteria.
 - b. Optionally, click **More options** and select the check boxes to filter the search, according to the following table.

NOTE

The starting point for the search function is to find all machines with the application installed to which the license can be assigned to, based on the use rights selected for the license. The use rights that are taken into account are downgrade rights, upgrade rights, cross platform rights and cross edition rights. To refine the search result, add filter options to the search.

Filter option	Description	
Physical	Shows all physical machines with the application installed <i>and</i> all physical machines hosting a virtual machine with the application installed.	
Virtual	Shows all virtual machines with the application installed.	
Datacenter / Cluster	Shows all datacenters or clusters hosting physical or virtual machines with the application installed.	
Show only machines hosting VMs with the application installed	Shows all physical machines, datacenters, and clusters hosting virtual machines with the application installed.	
Show only machines hosting VMs with application family installed	Shows all datacenters, clusters, and physical machines hosting virtual machines with the application or an application from the same application family installed.	
Show only machines requiring a license	 Shows all machines* with the application installed, which are not compliant and require a license. * Physical machines, physical machines hosting a virtual machine, and datacenters or clusters hosting physical or virtual machines 	
Ignore use rights	Shows all datacenters, clusters, and physical and virtual machines.	
	Use this option to find and assign a license to a machine where the application is not yet installed.	

EXAMPLE

A user wants to find all physical machines with the application installed that is currently not covered by a license. The machines should host virtual machines. To find the physical machines, the user selects the following filter options:



- Physical
- Show only machines hosting VMs with the application installed
- Show only machines requiring a license

EXAMPLE

A user wants to find all datacenters that hosts at least one virtual machines with the application installed that is currently not covered by a license. To find the datacenters, the user selects the following filter options:

- Datacenters
- Show only machines hosting VMs with the application installed
- Show only machines requiring a license

EXAMPLE

A user wants to find all virtual machines with the application installed that is currently not covered by a license. To find the virtual machines, the user selects the following filter options:

- Virtual
- Show only machines requiring a license

EXAMPLE

A user wants to find all virtual machine where the application is not yet installed. To find the virtual machines, the user selects the following filter options:

- Virtual
- Ignore use rights
- c. Click **Search**.
- 3. In the search result list, use the check boxes to select computers, and then click **Add**.
- For each computer, type number of Assigned licenses.
 The number of Total licenses, Total assigned and Total remaining is changed according to the number of Assigned licenses.
- 5. For licenses with VM use rights, set the **VM use rights** for the host with virtual instances:
 - a. Click **Change**.

The **VM use rights** dialog box appears.

- b. Click the option that meets the license purchase conditions.
- c. Click outside the VM use rights dialog box to close it.
 VM use rights are now set for Unlimited or Any (number) virtual instances.
- 6. To override the **Unlimited** or **Any (number)** setting and assign VM use rights to specific virtual instances:



- a. Click the **VM use rights** cell of the host computer. A dialog box appears.
- b. Optionally, filter the list of virtual instances.
- c. Use the check boxes to select the virtual instances to be assigned with a license.
- d. Click OK.

For more information on VM use rights, see VM use rights.

14.2.3.3 ASSIGNMENT TYPE: USER

NOTE

If you don't know the <u>exact</u> **Username** or **Full name** of the user, you must use "%" as a wild card character in the search.

Example: To find the user "John Doe" with the username "johndoe" in the domain "SWE", you can search for username **SWE\john%**, **SWE\johndoe**, or **%johndoe%**.

- Type search criteria for the Username or Full name and/or select an Organization from the list, and then click Search. The result of the search appears in Search results.
- 2. In **Search results**, select the user to whom the license should be attached, and then click **Add**.

The selected user is moved to **Current grants**.

3. To remove an assigned user, select the user in **Current grants**, and then click **Remove**.

The selected user is removed from **Current grants**.

14.2.3.4 Assignment type: Site

A site license can only be assigned to one specified site and the quantity of a site license is always "1".

To assign a purchased site license:

- 1. Click the list, and then select the organization node representing the site.
- 2. Click **OK**, and then click **Add**.
- 3. In **Quantity**, type **1**.

14.2.4 INFORMATION TAB

Use the **Information** tab to add additional information on the license purchase. Information entered on the **Information** tab can be used as search criteria in lists, searches, and reports using the **Column selector**.

1. Type an **External ID** (external for SLM) for the license, for example purchase order ID, or system ID.

NOTE

When the basic setting LICENSE_EXTID_CHECK is enabled in Snow MACC, this value can be used to avoid duplicate license purchase records when performing bulk imports.



- 2. Enter a vendor in the **Vendor** box.
- 3. Type information on **License proof location**.
- 4. Type information on **Installation media storage**.
- 5. Type **Serial numbers/license keys** connected to the license purchase.
- 6. Use the **Notes** textbox for comments.

14.2.5 DOCUMENTS TAB

On the **Documents** tab, click **Add document** to upload documents or add links related to the license.

For more information, see Manage documents and links.

14.2.6 CUSTOM INFORMATION TAB

On the **Custom information** tab, enter information and values in the custom fields that are mandatory for the **License** category.

For more information, see Enter custom field information.

14.2.7 BASE LICENSES TAB

The **Base licenses** tab is only available if the **Upgrade license** check box on the **Purchase tab** is selected.

To add a base license:

- Select Add. The Search for license dialog box appears.
- 2. Enter a search criteria, and then click **Search**.
- 3. Use the check boxes to select one or more base licenses, and then click **OK**.
- 4. In **Base licenses to upgrade**, enter the number of base licenses to upgrade.
- 5. In **Upgrade quantity**, enter the quantity of upgrade licenses that you are entitled to.

EXAMPLE

You have registered a license where the metric is installations. You want to upgrade one of the licenses to a higher version that uses the processor metric. For the base license, you enter 1, and for the upgrade quantity you enter 2.

NOTE

If the number of base licenses available for upgrade is not enough, the license purchase will be marked as incomplete when saved.

14.3 COPY LICENSE PURCHASE

When multiple license purchases are to be added with more or less the same settings and information, or if a similar license already exists, the **Copy license** option can be used.



To create a new license based on another license:

- 1. Add the first license purchase and save it, or navigate to an existing license purchase that is to be copied.
- On the context menu, click Copy license. The Copy license view appears.
- 3. If required, edit the information on the tabs.
- 4. Click **Save**.

14.4 EDIT LICENSE

- 1. On the **Licenses** menu, click **List all licenses** or **Search for licenses** and find the license to be edited.
- Click the licenses row.
 The License detail view appears.
- 3. On the context menu, click **Edit license**.
- 4. Edit the information in the fields on the tabs according to Add license purchase.
- 5. Click Save.

14.5 ARCHIVING AND UNARCHIVING LICENSES

A license can be archived, for example if it is not in use or if it is in a draft stage. It is kept in the database for future reference, in contrast to when a license is deleted and removed from the system completely. An archived license can be viewed but will not be included in compliance calculations. During the archiving procedure, you will have the option to archive connected licenses and agreements.

If you archive a base license without its upgraded licenses it will make the upgraded licenses become incomplete, since the base license is missing.

A license can be unarchived and will then be included in compliance calculations. During the unarchiving procedure, you will have the option to unarchive licenses that were archived at the same time as the selected license.

A license can be unarchived only together with its base licenses and upgraded licenses. A license will be reconnected to its previous agreement when it is unarchived.

Archived licenses can be viewed in the report **Archived licenses**. For instructions how to find it, go to Find a report.

14.5.1 ARCHIVE LICENSE

- 1. On the Licenses menu, select **List all licenses** or **Search for licenses** to find the license to archive.
- Select the license row.
 The License detail view appears.
- On the context menu, select Archive license.
 The Select licenses view appears, which shows all base licenses and upgraded licenses connected to the selected license.



- 4. Select the check boxes for the licenses to archive.
- Select the Next button if it is enabled, indicating that there are agreements connected to the selected licenses. Otherwise, continue to step Step 7.
 The Select agreements view appears. The list shows agreements connected to the selected licenses.
- 6. Select the check boxes for the agreements to archive.
- 7. Select **Archive**.

The selected licenses and agreements are archived, and you are returned to the **License list** view. Use the **Archived** column to either show or hide archived licenses in the list.

14.5.2 UNARCHIVE LICENSE

- 1. On the **Licenses** menu, select **List all licenses**.
- 2. In the **License** list, select **Yes** in the menu in the **Archived** column.
- Select the license row.
 The License detail view appears.
- On the context menu, select Unarchive license.
 The Select licenses view appears, which shows all base licenses and upgraded licenses connected to the selected license.
- 5. Select the check boxes for the licenses to unarchive.
- Select the Next button if it is enabled, indicating that there are agreements connected to the selected licenses. Otherwise, continue to Step 8.
 The Select agreements view appears. The list shows agreements previously connected to the selected licenses.
- 7. Select the check boxes for the agreements to unarchive.
- 8. Select **Unarchive**.

The selected licenses and agreements are unarchived, and you are returned to the **License list** view.

14.6 DELETE LICENSE

For information on how to delete licenses, see Category views.

14.7 UPGRADE LICENSE

Licenses can be upgraded within a single license purchase or simultaneously within multiple licenses. However, selected licenses must belong to the same application family. Note that only existing licenses can be upgraded.

To upgrade one or more licenses:

- 1. Perform one of the following steps:
 - To upgrade a single license:
 - a. Navigate to the license to be upgraded.
 - b. On the context menu, click **Upgrade license**.



- To upgrade multiple licenses at the same time:
 - a. On the **Licenses** menu, click **List all licenses**.
 - b. Click the check boxes to the left to select the licenses.
 - c. On the context menu, click **Upgrade**.
- 2. The **Add license view** appears.
- 3. On the **Base licenses** tab, the number of **Available base licenses** is stated. In the **Base licenses to upgrade** box for the application, type the number of base licenses to be upgraded, and in the **Upgrade quantity** box, type the quantity to upgrade to.
- 4. On the **Purchase** tab, select the application to upgrade to by performing the following steps:
 - a. Click the search icon.The **Find application** dialog box appears.
 - b. Select to search by application name or SKU.
 - c. Type a search criteria and click **Search**.
 - d. Select application in the displayed list and then click **OK**.
- 5. Enter the rest of the license purchase information according to Add license purchase.

EXAMPLE

In Snow License Manager 9, it is possible to change license metric when upgrading licenses. For example, a license for Windows Server 2008 R2 Standard has **Installations** as default metric. If that license is upgraded to Windows Server 2012 R2 Standard, the upgrade license can have **Number of processors** as metric, which is the Microsoft default metric for this Windows Server version. Subsequently, the Windows Server 2012 R2 Standard license, then using **Number of processor cores** as metric.

For an upgrade license, one can specify the number of **Base licenses to upgrade**, and also the **Upgrade quantity**.

To trace the upgrades for a license, display it in in Snow License Manager and select the **Purchase** tab. If you are displaying a license that has been upgraded to or upgraded from, **Show base licenses** and **Show upgrades** will display, respectively.

14.8 ENSURE CORRECT LICENSE REGISTRATIONS

By making fields mandatory, adding lists with pre-defined options, and adding descriptions that clearly state the intended purpose of a specific field, the Snow License Manager administrator can ensure that all license purchases are registered in accordance with the IT policy of the company.

Examples of **descriptions**:

- Total purchase amount: "Affects the average price for each purchased license and must be specified, with the correct currency."
- Invoice reference: "Must be defined for the traceability of the license certificate."



Examples of **lists with pre-defined options**:

- Installation media storage: IT Department, Sales Department, HR Department
- License proof location: Bank Vault, Office Safe

To enforce correct license registrations:

- 1. In the **Home** category, select **Administration**. The **Administration overview** appears.
- Select License policy. The License policy view appears.
- Click the Edit icon for each Field name to be changed. The Field name dialog box appears.
- 4. To make a field mandatory:
 - a. Select the **Required information** check box.
 - b. Type a **Description**.
 - c. Click **Save**.
- 5. To include a list:
 - a. Select the **Use multi selection** list check box.
 - b. Type **Selectable options**.
 - c. To allow other values than the listed options, select the **Allow use of custom values** check box.
 - d. Click Save.

NOTE

The task License Policy is only available to users with administrative rights.

14.9 MANAGE SECONDARY USE RIGHTS

With the Secondary use rights licensing feature, one single license covers two installations of the same application on two separate computers, for instance one desktop and one laptop. Secondary use rights must be activated for the application, and a connection must be established between the two computers.

14.9.1 ACTIVATE SECONDARY USE RIGHTS

- 1. Navigate to the application.
- 2. On the context menu, click **Edit application**.
- 3. On the License settings tab, select the Enable secondary use rights check box.
- 4. Click Save.

14.9.2 MANUALLY SPECIFY A SIBLING COMPUTER

1. Navigate to the primary computer (desktop, work PC).



- 2. On the context menu, click **Edit computer**.
- 3. On the **General** tab, click the **Select host icon** icon. The **Search for computer** dialog box appears.
- 4. Type a search criterion to find the sibling computer (laptop, home PC), and then click **Search**. A list of computers that match the search criterion is displayed.
- 5. Select the sibling computer, and then click **OK**.
- 6. Click **Save**.

14.10 MANAGE WINDOWS VDA LICENSING

Managing Windows VDA licensing includes the following tasks:

- Ensure that Windows licenses with Software Assurance are registered with upgrade rights enabled.
- Register Windows Virtual Desktop Access licenses, see Add license purchase.

NOTE

The instructions below only apply if the purchased Windows license entitles to Software Assurance.

To verify upgrade rights:

- 1. Navigate to the Windows license.
- 2. On the **Maintenance and support** tab, verify the **Upgrade rights** option:
 - Upgrade rights = Yes
 The Windows license is registered with Software Assurance, with the stated validation period.
 - Upgrade rights = No

The Windows license is registered without Software Assurance.

To enable upgrade rights if **Upgrade rights = No**:

- 1. On the context menu, click **Edit license**.
- 2. On the **Maintenance and support** tab, add upgrade rights according to Add license purchase.
- 3. Click Save.



15 OBJECTS

Custom objects, such as projectors, monitors, or other company assets can be managed in the **Objects** category. Create own object types and objects, and attach them to agreements for efficient asset management.

15.1 OBJECTS DETAIL VIEW

To show detailed information on a specific object, click the item in a list of objects.

The top section of the detail view contains general information on the object.

The bottom section of the detail view contains detailed information on the object. The information is presented in tabs according to the following table.

Tab	Description	
Properties	Displayed properties depend on type of object.	
Agreements	Agreements that this object is attached to.	

15.2 OBJECTS TYPE VIEW

The **Object types** view shows a list of the custom object types that have been created locally in the SLM Web UI.

15.3 ADD OBJECT

- 1. On the **Objects** menu, click **Add object**. The **Add custom object** view appears.
- To speed up the registration process when adding multiple objects, select the After object has been saved, open new form for same object type check box.
 When selected, the system will automatically go to Add object with the current object type selected when you save the current item.
- 3. Enter information in the fields on the tabs according to the following sections.
- 4. Click Save.

15.3.1 PROPERTIES TAB

Use the **Properties** tab to enter properties for the object:

- 1. Select an **Object type** from the list.
- 2. Type a **Name** of the object.
- 3. Select **Organization** node from the list in order to attach the object to a specific part of the organization.
- 4. Enter **Property values** of the object. Available property values depend on selected object type.



- 5. Click the **Select computer Q** icon for **Linked computer** to search for a computer and link the object to it.
- 6. Click the **Select user** icon for **Linked user** to search for a user and link the object to it.

15.3.2 AGREEMENTS TAB

The **Agreements** tab is only available if the selected object type can be attached to an agreement.

To attach the object to an agreement:

• Click the check boxes to select an agreement.

15.4 ADD OBJECT TYPE

To create a new object type:

- 1. On the **Objects** menu, click **Object types**.
- On the context menu, click Add object type. The Add custom object type view appears.
- 3. Enter information in the fields on the tabs according to the following sections.
- 4. Click **Save**.

15.4.1 INFORMATION TAB

Use the **Information** tab to enter basic information on the object type:

- 1. Type a **Name** of the object type.
- 2. Type a **Description** of the object type.
- 3. To make it possible to attach objects of this type to agreements, select the **This object type can be attached to agreements** check box.

15.4.2 PROPERTIES TAB

Use the **Properties** tab to define the fields that will be available (and mandatory) when registering an object of this type:

1. Click **Add property**.

A dialog box appears.

- 2. Select **Type** of field from the list.
- 3. Type a **Name** and a **Description** for the property.
- 4. To make this property mandatory for all objects of this object type, select the **Mandatory** check box.
- 5. Click Save.
- 6. Repeat for all properties needed.



15.5 EDIT OBJECT TYPE

To edit details of an existing object type:

- 1. On the **Objects** menu, click **Object types**. The **Custom object types** view appears.
- 2. Click the object type to be edited. The **Object type** tabs appear.
- 3. Edit the details for the object type.
- 4. Click Save.



16 ENTERPRISE

The **Enterprise** category gives detailed information on the Oracle and SAP environments.

ORACLE OVERVIEW

The **Enterprise** > **Oracle overview** section in Snow License Manager enables asset management of your Oracle products by showing detailed information about your Oracle environment.

16.1.1 DESCRIPTION

Oracle licensing is complex, with intricate rules and dependencies. To determine if you are correctly licensed, you need to know which Oracle products are installed and used in your IT environment. In addition, you need to know the hardware configuration of the servers running Oracle, as well as have full control over all Oracle agreements and orders.

The Oracle overview section provides visibility of your Oracle Databases, Fusion Middleware, and Oracle Java products, as well as license requirements, license assignments, and compliancy position for the Oracle Databases plus their Options and Management packs, and for Oracle WebLogic Server. The section is divided in tabs:

- The Overview Products tab summarizes the license compliance and costs for your Oracle products in key figures and charts.
- The Recommendations tab gives you an overview of potential optimization opportunities in your Oracle environment.
- The Products tab gives you visibility of all inventoried Oracle Databases, Oracle Fusion Middleware, and Java installations in your environment.
- On the Entitlements tab you can view all registered Oracle agreements, orders, and the compliance status for all your virtual machines, physical servers, and datacenters or clusters. You can also register new agreements and orders and manage license assignments.

While the information from the inventoried Oracle environments, gathered by the Oracle scanners, is supplied automatically to Snow License Manager, all Oracle agreements must be registered manually. You must also register your Oracle orders (entitlements), either one by one or through a bulk order file import. Furthermore, you must associate the Oracle orders with the Oracle servers, which you can do either manually or by using the Oracle auto-assignment functionality.

- The Reports tab gathers all available Oracle related reports, for example, the Oracle Product Compliance report.
- The Oracle verified data tab enables you to download a ZIP file with Oracle Database, Oracle Fusion Middleware, and Java SE data that Oracle accepts as an alternative to installing Oracle tooling. Note that the tab is not available by default for all users.

16.1.1.1 Oracle license compliance: Supported rule sets

The metrics **Processor** and **Named User Plus** minimums are used when determining license requirements for Oracle Databases (their Options and Management Packs) and



Middleware (WebLogic Server) on the inventoried clusters and computers, and when updating the license compliance calculations.

NOTE

The number of users within the Oracle estate cannot yet be inventoried or manually added to the system. Therefore, the **Named User Plus** metric is only supported as **Named User Plus**per processor minimums.

The currently covered Oracle license requirement calculation rule sets are:

- Oracle (Databases and WebLogic Server) Standard Edition and virtualization/physical server (on-premises)
- Oracle (Databases and WebLogic Server) Enterprise Edition on physical servers (no virtualization, on-premises)
- Oracle (Databases and WebLogic Server) on soft partitioning on-premises environments (also known as *support for soft partitioning*) As defined in the Oracle Partitioning Policy, *partitioning* means that server CPUs are separated, with each section behaving as if it were an individual system.
 - In soft partitioning scenarios, Oracle does not allow you to license the resources assigned to a virtual machine; you need to license the entire physical infrastructure. This usually happens in VMware environments in a datacenter/cluster.
 - This rule set calculates the license requirement for these products based on the number of processors in all the combined hosts.
- Oracle (Databases and WebLogic Server) on IBM AIX LPAR on-premises environments (also known as *support for IBM hard partitioning*)
 - Instead of licensing an entire server, Oracle allows grouping of server resources into logical partitions (LPARs), with one LPAR assigned to a virtual machine, for example. This concept is known as *hard partitioning*, which is supported by this rule set for LPARs on IBM AIX servers.
 - This rule set is able to take in most of the required data points for LPARs, using this information to accurately calculate these hard-partitioned environments to support most scenarios.
 - The benefit from the hard partitioning licensing is that the user can make the environment compliant assigning the least amount of licenses based on the LPARs containing Oracle products.

OVERVIEW PRODUCTS TAB

Use the **Oracle products** tab in the **Enterprise** > **Oracle overview** section of Snow License Manager to gain visibility of the license compliance for your Oracle products and see an overview of your Oracle licenses and associated costs.

16.1.2.1 DESCRIPTION

You can choose between two different views on the Overview Products tab:

On the **Compliance summary view** you can see the compliance for your entire Oracle estate, as well as broken down by product type or product.



On the **Order summary view** you can see the number of Oracle licenses per product, and your Oracle licenses costs per organization.

Select the view you want to see from the **Select view** list.

On each view the information is presented in three sections:

- **Key figures** give a quick status overview in numbers.
- **Charts** visualize certain aspects of the license compliance or cost status.
- Insights highlight areas of potential spend-optimization opportunities, for example unassigned licenses that may represent unnecessary spend. For each area, the potential optimization is shown, together with a link to a report with more detailed information.

See the **Characteristics** section below for descriptions on all key figures and charts.

16.1.2.2 CHARACTERISTICS

You can refer to the tables below for descriptions of the key figures and charts on the Overview Products tab. Note that the key figures and charts depend on whether you have selected **Compliance summary** or **Order summary** from the **Select view** list.

COMPLIANCE SUMMARY VIEW: KEY FIGURES

The key figures give a quick overview of the compliance status for your Oracle estate. The figures depend on the selected chart:

- When the **Compliance by product type** chart is shown, the figures show the compliance for all Oracle products in your estate.
- When the **Compliance by product** chart is shown, the figures show the compliance for all Oracle products within the selected product type.

16.1.3.1 DESCRIPTION

The information on the Recommendations tab is divided into two parts:

Recommendations list

The list shows recommendations for a number of devices or computers that should be further investigated in your Oracle environment. An arrow or circle on the icon



for each recommendation indicates if the number has increased (red arrow) or decreased (green arrow) since the last scan. Click the recommendation to show a report of the computers or devices that should be investigated.

Environment overview of discovered computers and License cost overview graphs

The **Environment overview of discovered computers** graph visualizes to what extent the computers in your environment have been inventoried. To show the exact number of computers, point to the respective bar.

The **License cost overview** graph shows the Oracle order cost in relation to total licensing costs. Note that only licenses with available cost information are shown here.

PRODUCTS TAB

The **Products** tab in the **Enterprise** > **Oracle overview** section of Snow License Manager shows the Oracle Databases, Oracle Fusion Middleware, and Java installations in your environment.

16.1.4.1 DESCRIPTION

To view the details of an Oracle Database, Oracle Fusion Middleware product, or a grouping of Java installations, select it from the list on the left of the Products tab. An overview with summary information about the selected item will appear in the view pane.

To see more detailed information about the selected item, select **Go to** to the right of the selected name. You will then be directed to the detailed view of the Oracle Database, Oracle Fusion Middleware, or Java installations grouping.

ORACLE DATABASE EDITION DETAILED VIEW

Reach the page by selecting the applicable Oracle Database edition from the list on the left of the Products tab, and then selecting **Go to**. The page shows all inventoried databases, instances, servers, and registered orders associated with a specific Oracle Database edition.

The information on the page is presented on four tabs:

Select an order row to see detailed information for the order in the Oracle order detailed view.

For an explanation of the statuses in the **Completeness** field of the Oracle order list, see Oracle order statuses.

- License Assignments lists the license compliance status for all virtual machines, physical servers, and datacenters/clusters. You can assign licenses to your Oracle products via this view, see Assign Oracle licenses.
 For an explanation of the license compliance statuses, see Oracle license compliance statuses.
- Auto assignment lists all auto-assignment rules, if any. To learn more about autoassignment and how to configure auto-assignment rules, see Auto assignment of Oracle licenses.

16.1.6.1 DESCRIPTION

Use the reports to gather data and gain insights about the status of your Oracle environment, and as a support in the compliance analysis process. You can also generate and export reports in the format required when submitting a declaration to Oracle, for example, the Oracle Product Compliance report.

16.1.7 ORACLE VERIFIED DATA TAB

The **Oracle overview** > **Oracle verified data** tab enables you to download Oracle verified data for your Oracle environment.

Snow Software is a verified third-party tool vendor for Oracle Databases and Database options, Fusion Middleware, and Java SE, meaning that Oracle accepts the data collected by Snow License Manager as verified data.

The Oracle verified data tab is not available by default for all users. See Oracle verified data in Snow License Manager for more information on the Oracle verified data feature and how to enable it.

The Oracle verified data tab divides the computers of the estate into two tables:

Computers with complete verified data

Oracle verified data can be prepared and downloaded for the computers listed in this table.

Computers lacking information about Assigned database license, Metric, and/or Environment are included in the list, but the missing information must be added before those computers can be included in the output file. If any computers in the table are lacking the above-mentioned information, a warning message is shown above the table. The missing information can be added directly via the user interface.



Computers with incomplete verified data

Oracle verified data cannot be prepared and downloaded for the computers listed in this table because of critical missing data or errors, for example, missing Snow Inventory Oracle Scanner data, missing computer in the topology, validation errors, or parsing errors.

For each issue listed in the table, the reasons why the data is categorized as incomplete are shown, together with recommended actions for resolving the issue. If all the issues for a computer are resolved, it will be moved to the **Computers with complete verified data** table, and verified data for the computer can be included in the output file.

16.1.8 AUTO ASSIGNMENT OF ORACLE LICENSES

Instead of manually assigning Oracle licenses to your products, you can use the autoassignment function.

16.1.8.1 DESCRIPTION

You can use the default auto-assignment rule or configure your own rules. The default rule assigns licenses where the License Type is **Full Use** and the metric is **Processor**.

When run, auto assignment analyses the need for licenses to cover incompliant environments. Environments are virtual machines, physical servers, and datacenters. When an incompliant environment is discovered, auto assignment finds out whether there is need to license all of its products. If there is an adequate amount of licenses—entered via Oracle orders—to cover all products for an environment, auto assign will cover that environment; otherwise, that environment will be skipped by auto assignment and will be retried the next time auto assignment runs.

For example, if there is need for auto assign to cover four required licenses for a product that is installed on an environment, but only three licenses exist, the environment will not have licenses auto assigned to it. The next time auto assignment runs, the process will be retried.

To enable auto-assignment with the default rule, see Auto-assign Oracle licenses. To configure your own rules, see Configure rules for auto-assigning Oracle licenses.

THE AUTO ASSIGNMENT PROCESS

When enabled, auto assignment is scheduled to occur once every day at 06:00 a.m. When user-defined rules are active, you can also trigger the process manually by selecting **Trigger the auto assignment process now**.

The auto assignment process consists of the following steps:

- 1. Auto assignment analyses the environments to see where licenses are needed.
- If any user-defined rules are active, auto assignment will fill those license requirements first. This means that licenses where the License Type is **Full Use** and the metric is **NUP** will be covered first.



When those licenses are covered, auto assignment continues:

Auto assignment covers the licenses where the License Type is Full Use and the metric is Processor.
 If user-defined rules do not completely cover license requirements due to an insufficient number of licenses for the selected metric, the default rule will be applied instead.

NOTE

- When auto assign is enabled, the default rule will execute even if no user-defined rules are active.
- Hard partitioning environments (IBM LPAR) with licenses manually assigned to one or more levels will not be included in the auto assignment process.

MANAGE ORACLE AGREEMENTS

Learn how to manage your Oracle agreements in Snow License Manager.

- 3. To see the details of a specific order, select the order from the list. The Oracle order detailed view appears, displaying the order information that has been entered into Snow License Manager, such as order number, currency, and license information per Oracle product included in the order.

16.1.10.2 Add an Oracle order

To register information about a single order:

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. On the Orders view, select Add an Oracle order and then Add order manually.
- 3. On the **Order information** tab, enter general information about the order, such as the order number, currency, and the vendor's contact details. See Order information for descriptions of what information to enter into the fields on the tab.
- 4. On the **Products** tab, for each product included in the order:



- a. Select **Add product** and enter information about the ordered licenses, such as the applicable Oracle product, license type, and metric. You can also connect the ordered product licenses to the relevant agreement if it has already been added to Snow License Manager. See Products for descriptions of what information to enter into the fields on the tab.
- b. When you have entered all the relevant information for the product, select **Add product** in the bottom-right corner of the tab.

Each added product is listed in the table on the **Products** tab.

Select Save in the upper-right corner of the page when you have entered all the relevant information for the order and the included products.
 The new order is listed in the table on the Orders view. The registered information is displayed on the Oracle order detailed view.

BULK-IMPORT ORACLE ORDERS

Instead of registering individual Oracle orders manually, you can import XLS, XLSX, and CSV files containing one or more Oracle orders. Make sure you have a correctly filled-in and formatted source data file before you start the import. You can download a template XLSX source data file via the **Home** > **Import data** page. For detailed information on required import data, see the Oracle order import section in *Data Import Field Description*. When the information has been imported, it will be displayed on the Oracle order detailed view for each order.

NOTE

The Oracle order import functionality cannot validate the uniqueness of licenses in an order, so you must ensure that the entitlements that are imported are not yet in the system; otherwise, this could result in registering duplicate licenses.

- 1. Navigate to the order import wizard either via the **Home** or **Enterprise** menu:
 - Via **Home**: Select **Import data** and then **Oracle order import** to go to step 1 of the import wizard.
 - Via **Enterprise**:
 - a. Select **Oracle overview**, and then select the **Entitlements** tab.
 - b. On the **Orders** view, select **Add an Oracle order** and then **Upload document** to go to step 1 of the import wizard.
- 2. On the **Upload your Oracle orders** view, select **Choose file** and then select the source data file you prepared for the import.
- 3. Select **Save and continue** to go to step 2 of the wizard.
- 4. On the **Import settings** view, do one of the following, depending on the format of your source data file:
 - CSV format: Select the delimiter character—comma, semicolon, or tab—to use as a column separator, and then select Save and continue to go to step 3 of the wizard.



NOTE

If you select a delimiter character that is not used in the source data file, the file import status will become **Discarded** when you complete step 4 of the import wizard. In this case, the order import will fail; therefore, you must make changes in the CSV import file so that the delimiter character selection matches the column-separator format of the file to be uploaded.

- XLS or XLSX format: Select Save and continue to go to step 3 of the wizard.
- 5. On the **Map fields** view, map the **Source** field names in the source data file with the **Destination** field names in SAM Core:
 - a. To map an unmapped field, or to manually override the automapping, select a source field name from the drop-down list in the **Source** column.
 Mandatory fields are marked with an asterisk (*) and must be included in the source data file.
 - b. When the fields are mapped, select **Save and continue** to go to step 4 of the wizard.
- On the **Review import** view, review the data to be imported.
 The **Status** column shows if the order row will be imported or not.
 - Complete: All relevant data is present. The order information will be imported and you will be able to assign Oracle licenses to the products included in the order.
 - **Incomplete**: Required fields are present but other relevant data is missing. The order information will be imported but you will not be able to assign Oracle licenses to the products included in the order.

Incomplete Oracle orders that are imported into Snow License Manager can be edited and completed at a later stage.

NOTE

You may already have Oracle order Excel export files that closely, but not exactly, match the Snow template. You can use the export files to import the Oracle orders but you will not be able to assign Oracle licenses as long as the order status is other than Complete.

- **Discarded**: The order information will not be imported due to any of the following reasons:
 - The source data file is missing any of the required fields.
 - One or more of the required fields have errors, such as the order file containing a currency that is not currently supported by Snow License Manager.
 - The delimiter character in the CSV source data file does not match the selected column separator setting.
- 7. Optionally, perform one or more of the following steps:
 - Select to Export all rows, Export incomplete rows, or Export discarded rows to an Excel file.



The file can be an aid in creating a correct source file, with the right fields and content.

- Select **Back** to go back and correct field mappings or import settings.
- 8. When you are satisfied with the review, select **Finish import** to start the import and finish the wizard.

16.1.10.3 Edit an Oracle order

To update general information for an order, for example, the vendor's contact information, or to add, edit, or delete products included in the order:

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. On the **Orders** view, select the table row for the order that you want to edit.
- 3. In the detailed order view that appears, select **Edit order**.
- 4. On the **Order information** tab, you can edit relevant fields regarding general information about the order. See Order information for field descriptions.
- 5. On the **Products** tab, you can add a new product entry and also edit or delete a previously added product entry. See Products for field descriptions.
- 6. Select **Save** in the upper-right corner of the page when you have edited all the relevant information.

16.1.10.4 Edit multiple Oracle orders

Editing several orders at the same time may be useful when you have to make the same updates to multiple orders, for example, updating the vendor's contact information.

To edit several orders at the same time:

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Orders** view.
- 3. In the list of Oracle orders, select the check boxes for the orders that you want to edit, and then select **Edit**.
- In the Select fields step, select an area of information, for example, General or Vendor/contractor, select the field or fields within that area that you want to edit, and then select Continue.

You can select fields from several areas of information. The number of selected fields is shown to the right of each area of information.

TIP

If you want to see what information is currently filled in for each order, select **View selected orders** in the upper-right corner of the view, and then select an order to open the detailed view for the order in a new tab.

5. In the **Edit fields** step, enter the new information for the selected fields, and then select **Continue**.

The fields are empty from the start. The number of fields that you have selected for editing is shown to the right of each area of information. The number of empty fields is shown with a blue background. As you enter information in the fields, the number of filled-in fields will be shown with a green background. Checking that all



numbers are shown with a green background is an easy way to make sure that you have filled in all the fields.

NOTE

The changes you make will apply to all selected orders.

Leaving a field blank will delete any value that has been previously entered in that field for any of the selected orders.

- 6. In the **Confirm changes** view, review the changes that you have made, and when you're done, select **Finish**.
- 7. In the **Finish** step, select **Go to order overview** to return to the **Orders** view with the list of Oracle orders.

16.1.10.5 Delete Oracle orders

You can only delete Oracle orders with no assigned licenses.

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Orders** view.
- 3. In the list of Oracle orders, select the check boxes for the orders that you want to delete.
- 4. Select **Delete orders**.

TIP

You can also delete an order when you are in edit mode, see Edit an Oracle order, Step 1, to Step 3. Select **Delete**, and then confirm the action.

16.1.10.7 Oracle license types

The table lists the supported Oracle-specific license types. When adding an Oracle order in Snow License Manager, you must assign one of these license types to each purchased product included in the order. The license type for an Oracle product is the unit of measurement for the Oracle license.

License type	Description
Full use	License limit is based on any application and interaction with third-party procurement (3PP) and unrestricted development rights.
Application specific full use	The license is application specific for a single independent software vendor (ISV) application and has restricted development rights and no interaction with a 3PP.



License type	Description
Application specific	The license is application specific for a single independent software vendor (ISV) application and has limited development rights and no 3PP usage is allowed.
Embedded	This license type is used when Oracle is embedded in the independent software vendor's application. It is impossible for end customers to detect underlying data schema or tables.
Runtime	License with restricted usage in conjunction with the specific independent software vendor's application with no modification rights.
Limited Use Other	This license type is used when end customers have an agreement with provisions not covered under any of the other supported Oracle-specific license types. What this actually means varies between customers.

MANAGE ORACLE LICENSES

When you have registered an Oracle order, you can assign the purchased licenses to your Oracle environment. You can either assign them manually or use the auto-assignment function.

16.1.11.1 Assign Oracle Licenses

Note that to assign the licenses included in an order, the status of the order must be **Complete**.

TIP

To see the status of your Oracle orders, go to **Enterprise** > **Oracle overview**, select the **Entitlements** tab, and then select the **Orders** view. The status for each order is shown in the **Completeness** column.

To assign licenses to an Oracle product:

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **License Assignments** view.
- 3. Select the entity type for which you want to view the Oracle license compliance position: **Virtual machines**, (Physical) **Servers**, or **Datacenters**.
- Select the virtual machine, server, or datacenter table row with the status Not compliant that you want to investigate.
 For a description of all possible statuses shown in the Status column, see Oracle order statuses.
- 5. If the **Navigating to another environment** dialog opens, it means that you cannot assign licenses to the selected environment because of the Oracle license requirements calculation rule sets. For example, Oracle does not allow you to license the resources assigned to a VM; you need to license the entire physical infrastructure. For more details, see Oracle license compliance: Supported rule sets. Select **Go to** to go to the environment you want to assign licenses to.
- 6. On the resulting Computer or Datacenter License Assignment page, select either the **Database Products** tab or **Middleware Products** tab, so that you can investigate which products do not have the required license coverage.



Products in table rows with the value **No** in the **Is satisfied** column do not have the required license coverage.

- 7. Select the **Edit** icon in the rightmost column for the product to which you want to assign licenses to go to the **Find licenses** view for the product.
- 8. In the **Available licenses** section, select the right arrow on one of the product rows, select the number of desired licenses, and then select **Assign**.
- 9. Select **Save changes** in the bottom-right corner of the view to save the license assignment.

16.1.11.2 Auto-assign Oracle licenses

Instead of assigning the licenses manually, you can select to use the auto-assign functionality.

NOTE

If auto-assign is enabled, compliance for your Oracle environment is likely to be affected. Read Auto assignment of Oracle licenses before enabling the feature.

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Auto assignments** view.
- 3. Turn on the **Auto assign is active** toggle.

Instead of using the default auto-assignment rules, you can define your own rules, see Configure rules for auto-assigning Oracle licenses.

16.1.11.3 CONFIGURE RULES FOR AUTO-ASSIGNING ORACLE LICENSES

To create your own user-defined auto-assignment rules to be used instead of the default rules:

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Auto assignments** view.
- 3. Select **Configure auto assignment rules** to start the four-step wizard.
- In the **Configure rules** step, switch the **Status** toggle to **Active** for rules that you want to activate, and then select **Continue**.
 To enter more than one value in a **Value** box, use a vertical bar (|) to separate the values. Do not add space characters before or after use of the vertical bar.

EXAMPLE

If the rule **Database name** is activated and its Value is **DBName Maintenance**, auto assignment will only affect environments where the database name contains **DBname** or **Maintenance**.

5. In the **Confirm environments** step, preview the results for every rule before they are applied, and then select **Continue**.

The number of covered environments and the percentage of the total number of environments are displayed, per rule. When the number of covered environments is larger than zero, you can select the linked text to see a preview list of the environments that will be affected by the rule.



6. In the **Confirm licenses to be assigned** step, review the displayed information, and then select **Complete configuration**.

The displayed information is:

- The total number of orders that will be used to assign licenses.
- The total number of licenses that will be assigned when the rules are applied. The number of licenses is also displayed by NUP and Processor, respectively.
- The total number of environments that will be covered.
- The compliance status before and after license assignment.
- 7. In the **Finish** step, perform one of the following actions:
 - Select Trigger the auto assignment process now if you want the configured auto-assignment rules to take effect immediately.
 - Select **Return to overview** if you do not want the configured autoassignment rules to take effect immediately. The rules will run according to schedule, that is, every day at 07:00.

16.1.11.4 UNASSIGN ORACLE LICENSES FROM ORDERS

You must be a member of the **License Administrator** role to unassign Oracle licenses.

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Orders** view.
- 3. In the list of Oracle orders, select the checkboxes for the orders from which you want to unassign licenses.
- 4. Select **Unassign licenses** in the upper-right corner of the view, and then select **Unassign licenses** in the dialog.

16.1.11.5 UNASSIGN ORACLE LICENSES FROM PRODUCTS

You must be a member of the **License Administrator** role to unassign Oracle licenses.

- 1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.
- 2. Select the **Orders** view.
- 3. In the list of Oracle orders, select the order containing the product or products from which you want to unassign licenses.
- 4. Select **Unassign licenses** in the upper-right corner of the view, and then select **Unassign licenses** in the dialog.
- 5. On the **Products** tab, select **Manage license assignments** in the upper-right corner of the view.
- 6. In the list of products, select the checkboxes for the products from which you want to unassign licenses, and then select **Remove licenses** in the dialog.

16.1.11.6 UNASSIGN ORACLE LICENSES FROM COMPUTERS OR DATACENTERS/CLUSTERS

You must be a member of the **License Administrator** role to unassign Oracle licenses.

1. On the **Enterprise** menu, select **Oracle overview** and then select the **Entitlements** tab.



- 2. Select the **License assignments** view.
- 3. Select **Virtual machines**, **Servers**, or **Datacenters** to show the applicable type in the list.
- 4. Select **Manage license assignments** in the upper-right corner of the view.
- 5. In the list of devices, select the checkboxes for the computers or datacenters/ clusters from which you want to unassign licenses.
- 6. Select **Unassign licenses** in the upper-right corner of the view, and then select **Remove licenses** in the dialog.

16.1.12 MANAGE ORACLE VERIFIED DATA

Learn how to manage data on the **Oracle verified data** tab to download data on your environment that is accepted by Oracle as verified data.

16.1.12.1 VIEW COMPUTERS WITH VERIFIED DATA

1. On the Oracle verified data tab, go to the Computers with complete verified data view.

The table shows all inventoried computers for which verified data can be prepared and downloaded.

2. Select the arrow to the left of the computer name to expand the table row and see detailed information.

In the expanded view, the data is shown in separate tables for Databases, Middleware, and Java, respectively. See Oracle verified data tab: Reference for descriptions of the content of the respective table.

TIP

- You can filter the table to only show inventoried Databases, Middleware, or Java, respectively.
- You can filter the table to only show items with empty values for the properties Assigned Database license, Environment, and/or Metric.

The filters are available via dropdown lists above the table.

16.1.12.2 Prepare and download Oracle verified data

To download a file containing data on your environment that is accepted by Oracle as verified data, follow the steps below.

NOTE

The following items cannot be included in the output file:

- Computers listed in the Computers with incomplete verified data table. See Resolve issues for computers with incomplete data for instructions on how to enable them to be included in the file.
- Databases lacking information on the Assigned database license, Metric, or Environment properties, and Java or Middleware installations lacking information on the Environment property.
 The missing data must be added before those computers can be included in t

The missing data must be added before those computers can be included in the output file, see Edit data for instructions on how to add the data.



- 1. On the **Oracle verified data** tab, go to the **Computers with complete verified data** view.
- 2. Select the checkboxes for the items you want to include in the output file, and then select **Prepare file**.

Tip: If you want to include all the items in the table, you can select **Actions** and then **Select all**.

The data for the selected items is extracted. If many items are selected, the process may take some time. When all data is extracted, the **Download file** button is enabled.

3. Select **Download file**.

The output file with Oracle verified data is downloaded as a ZIP file.

We strongly advise that you check the contents of the output file before sharing it with third parties.

16.1.12.3 Edit data

You can edit the records in the **Computers with complete verified data** table with regards to the following properties:

- General property: **Environment**
- Database-specific properties: Assigned database license, Metric
- Java-specific properties: Machine type, Used with OCI, Part of other product, Support required, OTN, BCL, NFTC, BLRA

NOTE

Edited values only affect the records in the Oracle verified data view, with the exception of the **Environment** property for Database instances. In this case, the value will be permanently stored, which means that other views in the user interface will display the same Environment value for the Database instance.

To add or edit data:

- 1. On the **Oracle verified data** tab, go to the **Computers with complete verified data** view.
- 2. In the table, select the checkboxes for one or more items you want to edit.
- 3. Select **Actions** and then **Edit**.
- In the Edit properties window, select the fields you want to edit, edit the data, and then select Save.
 For field descriptions, see Oracle verified data tab: Reference.

TIP

If you want to edit one single row in the table, you can select the **Edit** icon in the **Edit** column of the row to go directly to the **Edit properties** window.

16.1.12.4 Reset data

You can reset edited records to their original value.



NOTE

- You cannot reset the **Environment** property for Database instances. To change edited environment values for Database instances, use the **Edit** function instead.
- All edited and resettable values for all Database, Middleware, and Java instances will be reset when you use the reset function, whether you have selected them in the table or not.
- 1. On the **Oracle verified data** tab, go to the **Computers with complete verified data** view.
- 2. Select the checkbox for at least one item in the table.
- 3. Select **Actions** and then **Reset**.

16.1.12.5 Resolve issues for computers with incomplete data

Computers with incomplete data cannot be included in the output file with Oracle verified data. To resolve issues for a computer and make the data complete:

- 1. On the **Oracle verified data** tab, go to the **Computers with incomplete verified data** view.
- For each issue listed in the table for a specific computer, follow the recommended actions described in the **Recommendations** column.
 When all the issues have been resolved, the computer will be moved to the **Computers with complete verified data** table and it can be included in the output file.

16.2 SAP OVERVIEW

The **SAP overview** shows information provided by the Snow Optimizer for SAP Software. The information can be either automatically imported from file via the Web Configurator, or manually imported from file using the SAP import wizard in the **Import data** view.

NOTE

The **SAP overview** is only available if the setting SAP_ENABLED has been set, and if the logged in user has the required permission to view the information. System settings and permissions are set in Snow MACC.

NOTE

All information on the **SAP overview** page is read-only.

The user will be notified when the imported SAP data is more than 90 days old.

16.2.1 TOP 5 LICENSE TYPE RECOMMENDATION

The top section of the **SAP overview** shows a **Top 5 metric recommendation** graph. Information on the current count of used metrics is displayed together with the count recommended by the Snow Optimizer for SAP Software. The graph shows the metrics with the largest absolute difference in current and recommended count.

To view more details in the **All SAP user accounts** report:



• Click **View report** in the top right corner.

The **User summary** shows information based on the import file.

The bottom section of **SAP overview** contains detailed information on the utilization of SAP software. The information is presented in tabs according to the following table.

Applications	The number of installations and users for each identified SAP software based on information in Snow License Manager. Only applications with installations or users will be displayed. Click an application to open the application details.
Licenses	Information on each license purchase of SAP software registered in Snow License Manager. Only licenses attached to an application will be displayed. Click a license to open the license details.
Agreements	Information on each SAP agreement registered in Snow License Manager. The agreement will be displayed in the list if either one or more SAP licenses are attached to the agreement, or information in the Contractor field contains "SAP". Click an agreement to open the agreement details.



17 **REPORTS**

Reports are an ideal way to gather data and gain insights about the status of your environment. Reports support decision-making in asset management for activities such as audit tracking and spend optimization. The features available in the **Reports** category enable you to assemble data in standardized views, customize it, save it to the system, download to your device, share with other users, and schedule to track data over time. The views available in this category are:

- **All reports** a list of all standard and user-modified reports.
- **Report files** a list of reports created using the system-save feature.
- **Scheduled reports** a list of reports created using the scheduling feature.

The system ships with useful pre-configured reports that correspond to common tasks such as *Compliance Summary*, *Cost of unused applications per computer*, and *Computers without antivirus software installed*.

The access rights of the signed-in user and licensing of Snow products control what reports a user can see. To manage user roles and access rights, refer to the User Guide for Snow Management and Configuration Center. For licensing, refer to your purchase with Snow.

17.1 ICONS, CONFIGURATIONS, AND DATA

Clues in the graphical user interface help to differentiate among the different types of reports and file types, as well as providing easy access to report features such as delete, edit, and schedule.

When working with reports, distinguishing between a report configuration and report data is key. A report configuration controls what data should be shown in a report, such as what columns and how the report should be filtered. Report data is the information that populates those columns when you run **Show report**. Once you've set up a report configuration, you will probably keep it, whereas the data that populates it will change as your network environment evolves and licenses are added to the system. The word report is used interchangeably to describe both a report configuration and its data.

Icon	Description
	Standard reports are the set of baseline report configurations that ship with the system. The standard configuration for Compliance summary , for example, includes the columns: Application, Manufacturer, Total licenses, License requirement, Available licenses, Coverage, Compliance, and Cost. The icon illustrates a worksheet.
	User-modified standard reports are standard configurations that have been customized by a user with, for example, additional data columns or reordered columns, and saved. These reports are visible to the user who created them. The icon illustrates a worksheet with a user symbol.



Icon	Description
	Shared reports are user-modified standard reports that have been shared. All users within the organization with access rights to the standard report that the modified report is based on will be able to view this report. The icon illustrates a worksheet with a share symbol.
	Customized report are additional report configurations delivered by Snow Services. Examples of custom reports include <i>LPAR and WPAR data</i> , <i>Software per computer</i> , and <i>Unassigned inventoried software</i> .

System-save supports several file formats differentiated with tags:

17.2 FIND A REPORT

To locate a report, use the search box on the **All Reports** view. As you enter search criteria, any matching reports will show. Use the **Categories** dropdown menu to filter results. By default, the system searches all categories, but you can refine your search to **Application reports**, for example, by checking the appropriate box.

17.3 SHOW REPORT

To populate a report with data from your environment:



1. From any list view (**All reports**, **Report files**, or **Scheduled reports**), select the name of the report.

The **Report detail** view appears.

- 2. Populate the report with current or cached data from your environment.
 - To populate the report with the current data from your environment, select **Show report**.
 - To populate the report with cached data from your environment, select **Show cached report**.

ΝΟΤΕ

The report can only be populated with cached data if caching is enabled, see Enable or disable caching.

To refine the data populated in a report, use the filtering features available in the report criteria panel. See: Change report criteria.

17.3.1 ENABLE OR DISABLE CACHING

Some reports can take a long time to run. Use the cache reports functionality to run the reports from a cache instead of from the live database. This will enable you to run reports faster.

To enable or disable caching for a single report:

• On the context menu for the report, select **Enable caching** or **Disable caching**

To enable or disable caching for several reports at the same time, see Reports cache.

17.3.2 CHANGE REPORT CRITERIA

Filtering reports is an ideal way to refine the amount of data running a report extracts from the system. In a **Report detail** view, create filters by adding conditions or groups of conditions in the **Report criteria** panel.

Hide/collapse this panel by selecting the $\stackrel{\frown}{\sim}$ icon, and show/expand it by selecting the $\stackrel{\checkmark}{\sim}$ icon.

Create refinement conditions by using the pre-populated dropdown menus. The contents of this menu depend on the report you are filtering and operators, such as *like* and *not equals to* in turn depend on whether you have selected a parameter that is text or a number. Boolean logic applies. For complex filtering create groups of conditions.

Add group	Add a new group of conditions.
 Remove group 	Remove both the group and all conditions within that group.
(*) Add criteria	Add a new condition, within or outside a group. You can also create nested conditions.
×	Remove a condition.

17.4 EXPORT FROM REPORT DETAILS VIEW

- From any list view, click the name of the report to be viewed. The **Report detail** view appears.
- 2. Click **Show report**.
- 3. From the context i menu, select **Export**, and choose the type of file you want to export to (CSV, PDF, XLS/XLSX, or XML) from the dropdown menu.
- 4. Select to **Save** to export the file.

NOTE

Your file will be saved to your device in accordance with your browser settings.

17.5 EXPORT REPORT TO FILE

The export/system-save feature saves the data of a report configuration to the system as a file. By saving to the system, you can refer back to your reports, share them with other users, or download to a device at any time.



Commonly-used file formats are supported: Comma-separated values (CSV), Portable Document Format (PDF), Microsoft Excel (XLS/XLSX), and eXtensible Markup Language (XML).

When exporting to Microsoft Excel, counts and totals are saved using Excel formulas. In this way, counts and totals will remain consistent with subsequent offline editing of the data.

NOTE

In Excel, the maximum number of arguments for a formula is 256. Consequently, it is not possible a save report with a formula that exceeds 256 arguments. In such cases, only the *value* of a count or total is exported and any subsequent editing of the file contents may result in data inconsistencies.

- 1. In the **All reports** view, click the **Download** icon next to the report. The **Export to file** dialog box appears.
- 2. In the dialog, you can change the **Name** and **Description** fields for the report.
- 3. Select the **Type** of file to export to (CSV, PDF, XLS/XLSX, or XML) from the list.
- 4. Click **Save** to export the file.

To view a saved report, from the **Reports** category, select **Report files**.

17.6 SHOW RELATED DOCUMENTS

Documents saved in the system relating to computers, mobile devices, users, agreements, or licenses can be extracted through the **Show related documents** feature. This feature is accessible from the context menu for reports, such as **All computers**, that can have attached documents. If the **Show related documents** option doesn't appear on the context menu, you are viewing a report for which documents are not relevant. To extract related documents:

- In the All reports view, click the name of the report. The Report details view appears.
- 2. Click **Show report**.
- 3. From the context menu, click **Show related documents**. The **Documents** view appears.
- 4. To download all documents, check the **Select all** box, otherwise check the box or boxes next to the specific document or documents you want. Select **Export**. A compressed file containing the documents you have selected will be downloaded to your device.

17.7 SHARE REPORT

Use the **Share report** feature to share user-modified reports with other users.

- 1. In the **All reports** view, click the name of the user-modified report you want to share.
- 2. From the context menu, click **Share report**. The **Share report** dialog box appears.



3. Check the names of the users you wish to share this report with, and then click **Save**. The report will appear in the top section of the All reports view for the selected users, assuming they have the correct access rights.

NOTE

To view a shared report the signed-in user must have access rights to the standard report that the user-modified report is based on.

17.8 MANAGE CUSTOMIZED REPORTS

You can change columns, filtering, and report criteria of a standard report, and then save it as a customized report. When you save a customized report, you save the report configuration but you do not save any data from your system.

EXAMPLE

If you customize the **Compliance summary** standard report and then save it as **My Compliance Summary**, every time you open **My Compliance Summary**, your customized columns and filters will show. If you then select **Show report**, the columns will be populated with data from your system.

17.8.1 USE GROUPS FOR CUSTOMIZED REPORTS

When you save new customized reports or resave existing ones, you have the possibility to organize them in groups for easy management. You can either select an existing group or create a new one in the process. For details, see <u>Save customized reports</u>. If you want to change the group of an existing report, you edit the report and then add it to another group. For details, see <u>Edit customized reports</u>.

After saving, the report will appear under the named group in the **All Reports** view. If you don't specify a group, the report will appear under the **Ungrouped reports** in the **All Reports** view.

NOTE

A group can only exist if there are reports added to it. If all the reports in a group are moved to other groups, the empty report will be removed from the system.

17.8.2 SAVE CUSTOMIZED REPORTS

- 1. In a **Report detail** view, select **Save report** from the context ^{II} menu.
- 2. In the **Save report** dialog:
 - a. Optionally, change the **Name** and the **Description** of the report.
 - b. Optionally, select a **Group name** from the list, or type a new group name.
- 3. Click Save.

17.8.3 EDIT CUSTOMIZED REPORTS

If you make changes to one of your customized reports, you can choose to save it as a new customized report or as an update of your customized report.



- 1. In a **Report detail** view, select **Save report** from the context ^{II} menu.
- 2. In the **Save report** dialog:
 - a. Optionally, change the **Name** and the **Description** of the report.
 - b. Optionally, select a **Group name** from the list, or type a new group name.
 - c. Do one of the following:
 - To save it as a new customized report, select **Save as new**.
 - To save it as an update of your customized report, leave Save as new cleared.
- 3. Click **Save**.

17.8.4 DELETE CUSTOMIZED REPORTS

You can delete a report if the delete \times icon appears next to the name of a report. You can delete reports you, the signed-in user, have created, but you cannot delete **Standard reports** or **Shared reports** created by another user.

17.9 MANAGE SCHEDULED REPORTS

You can schedule reports to be automatically generated, and then sent to an email recipient or saved to a file location. When you save the report to a location, you enable third-party systems to fetch and import data about the computers, applications, and licenses in your environment.

Automatically generated reports can be saved in CSV, PDF, XLS/XLSX, or XML format.

17.9.1 SCHEDULE AUTOMATIC GENERATION OF A REPORT

CAUTION

A scheduled generation of a report is associated with the user account that set it up. If that user account is deleted from Snow License Manager, the schedule will also be deleted.

1. In the **All reports** view, select the **Schedule** icon next to the report you want to schedule.

The **Schedule report** dialog box appears.

- 2. Optionally, change the **Name** and **Description** of the scheduled report.
- 3. Select the output file format from the **Type** list, how often you want to generate a report under **Recurrence**, and when during the day from the **Time** list.
- Select email or Disk under Delivery.
 Enter the email address where the report should be sent, or the pathname where it should be stored.
- 5. Check the **Active** checkbox to activate the schedule, or leave it cleared if you want to activate it later.



NOTE

As long as the **Active** checkbox is cleared, no scheduled reports will be created according to your settings.

6. Select **Save**.

17.9.2 SHOW SCHEDULED REPORTS

- 1. On the **Reports** category, select **Scheduled reports**.
- 2. A list of all scheduled reports will appear, showing the name, type of export (email or disk), when the next export is due, and when the most recent export was carried out.

NOTE

Next export will be empty if the report is not **Active**, and **Latest report** will be empty if the scheduled report has never run.

17.9.3 EDIT SCHEDULED REPORTS

- 1. On the **Reports** category, select **Scheduled reports**.
- 2. In the list of scheduled reports, select the **Schedule** icon next to the report you want to edit.
- 3. Make your changes, and then select **Save**

17.9.4 DELETE SCHEDULED REPORTS

When you delete a scheduled report, you deactivate the scheduling and remove the configuration from your system

- 1. On the **Reports** category, select **Scheduled reports**.
- 2. In the list of scheduled reports, select the **Delete** \times icon next to the report you want to delete.
- 3. Select **OK** to confirm.

MANAGE REPORTS WITH APPLICATION LIFECYCLE INFORMATION

Learn how to use reports with application lifecycle information in Snow License Manager.

For information on lifecycle management, see Snow Software Technical Videos and the video **Application Lifecycle Management from Snow Software**.

17.10.1 USE THE REPORT APPLICATIONS NEARING END OF SUPPORT

- 1. On the **Applications** menu, click **Application reports**.
- 2. Find and click the **Applications nearing End of Support** report.



3. Click **Show report**.

By default, the report uses the filter "Nearing End of Support equal to Yes".

17.10.2 USE THE REPORT APPLICATIONS NEARING END OF EXTENDED SUPPORT

- 1. On the **Applications** menu, click **Application reports**.
- 2. Find and click the **Applications nearing End of Extended Support** report.
- Click Show report.
 By default, the report uses the filter "Nearing End of Extended Support equal to Yes".

17.10.3 USE THE REPORT APPLICATIONS NEARING END OF LIFE

- 1. On the **Applications** menu, click **Application reports**.
- 2. Find and click the **Applications nearing End of Life** report.
- Click Show report.
 By default, the report uses the filter "Nearing End of Life equal to Yes".

17.10.4 USE AND CONFIGURE THE REPORT ALL APPLICATIONS

The following procedure describes how you make available information about an application's Release, End-of-Support, End-of-Extended-Support, and End-of-Life visible in the **All applications** standard report in Snow License Manager.

To generate and configure the report, do the following:

- 1. On the **Applications** menu, click **Application reports**.
- 2. Find and click the **All applications** report.
- 3. Optionally, you can select to only include applications from a specified manufacturer. Do the following:
 - a. In **Report criteria**, click **Add criteria**.
 - b. Select criterion **Application manufacturer**, select operator **like**, and then type the manufacturer name. Use % as a wildcard character.

EXAMPLE Application manufacturer *like* Microsoft%

- 4. Click **Show report**.
- Click Column selector.
 The Select columns dialog box appears.
- 6. Add the following columns to the report by drag-and-drop:
 - Release date (Date)
 - Release date is not announced (Yes/No)
 - End of support date (Date)
 - End of support (Yes/No)



- End of support date is not announced (Yes/No)
- End of extended support date (Date)
- End of extended support (Yes/No)
- End of extended support date is not announced (Yes/No)
- End of life date (Date)
- End of life (Yes/No)
- End of life date is not announced (Yes/No)
- When all columns are added, close the Select columns dialog box.
 The added columns are now populated with the information that is available for the listed applications from your selected manufacturer.

17.11 GENERATE A MICROSOFT CIDC

The Clean Inventory Data Contract (CIDC) is an Excel file that consists of a set of tabs; on the first tab definitions and instructions are provided by Microsoft of how to handle the file, while the tabs that follow are intended to be completed with inventory data related to Microsoft products.

In Snow License Manager it is possible to export inventory data to pre-populate the Microsoft CIDC as an initial step for generating a CIDC. After the bulk part has been pre-populated, some additional manual input is required to verify and complete the CIDC.

Export of CIDC's requires a specific Report Security permission, which is set in Snow MACC.

17.11.1 EXPORT A CIDC

NOTE

- The CIDC must be in .xlsx format and is only available for export.
- The CIDC can only be generated in English.
- Export date will be automatically added to the CIDC file name.

To export a CIDC:

- 1. On the **Reports** menu, click **Reports**.
- 2. Expand the **Microsoft** report group or search for the report by typing search criteria in the **Find report** box.
- Click the Download icon to export the Clean Inventory Data Contract (CIDC) – Excel export only.
 The Export to file dialog box appears. Name and Type is automatically set and cannot be changed.
- 4. To more easily identify the export file, type a **Description**.
- 5. Click **Save**.



17.11.2 OPEN THE CIDC

- 1. In the **Reports** view and on the context menu, click **Report files**. All exported **Report files** are listed.
- 2. Find the CIDC in the list and click the **Download** ¹ icon.
- 3. Select to open the report, or to save the report to disk.

17.11.3 VERIFY AND COMPLETE

The CIDC is populated with data from Snow License Manager, given that the requested information is stored in the database.

Any errors in the file are indicated by a red background and the prefix [ERR:...].

Columns with values that need to be verified are indicated by a yellow background.

Columns destined for information that is not stored in Snow License Manager will be left empty, and need to be completed manually, if mandatory. In some cases, a default value will be set instead. The sections that follow describe these columns and values, and what actions the SAM administrator needs to take to complete the file.

NOTE

To correct and complete the CIDC, use the information provided in the *WorkSpace Domain Data – Definition Document* that can be found on the WorkSpace website.

17.11.3.1 A - HARDWARE AND OPERATING SYSTEMS

NOTE

The operating system **Install Date** is set to the installation date of the Snow client in the CIDC file.

Physical Machine Fully Qualified Name	[name of physical machine] - or – <unknown host></unknown 	Only computer name is retrieved from Snow License Manager. 17.11.3.3 C - Access Licensing

No information is retrieved from Snow License Manager. Instead, information needs to be manually collected and entered.

17.11.3.4 D - USER SUBSCRIPTION

No information is retrieved from Snow License Manager. Instead, information needs to be manually collected and entered.

17.11.3.5 E - VIRTUAL MACHINE MOVEMENT HISTORY

NOTE

This sheet displays movement history of virtual machines. Virtual machines that have never been moved will not show up here.

17.11.3.7 G - GENERAL INFORMATION

Information that cannot be retrieved from Snow License Manager is indicated by an empty column and a yellow background. Information in these columns needs to be manually entered.



18 IMPORT DATA

Import data is a wizard-based feature for importing data to Snow License Manager. Examples of import types are licenses, agreements, and users. Available import types are determined by the access rights of the logged on user.

Depending on the type of import, either new objects are created or existing objects are updated with new metadata.

The wizard guides you through the import/update, which consists of the following steps:

- 1. Upload a data source.
- 2. Configure import settings.
- 3. Map source and destination fields.
- 4. Preview of imported data.
- 5. Import.

There is a dedicated wizard for each type of import/update.

18.1 IMPORT SOURCE FILE

The import source file can be in Excel (.xls or .xlsx) or CSV (Comma Separated Values) format, and source files both with or without file headers can be used. Note that CSV files need to be encoded as UTF-8. Information can be imported to the pre-defined fields and to most custom fields applicable to the category (except for custom fields of type currency).

To download templates for importing data to Snow License Manager:

- 1. On the **Home** menu, select **Import data**. The **Import data** view appears.
- Select Import templates.
 The Import templates dialog box appears.
- 3. Select an import template from the list and then select **Download**. The template is downloaded.

NOTE

The source file column names (if any) do not have to match the destination field names in Snow License Manager.

For a successful import of new or updated information in Snow License Manager, certain information must be provided. For more detailed information on required import data, and where the data can be found in Snow License Manager after the import, see the document *Data Import Field Description.*

18.2 VALIDATION OF DATA

To verify that only allowed data types and values are included in the import source file, the **Import data** function validates the data before it is imported. In the preview step of



the import, errors are highlighted in red. Point to the field to see more information on the error.

Errors and conflicts that are highlighted in red prevent import/update of data.

Data can only be updated for an object that already exists in Snow License Manager. If the import data does not match an object in the database, it is not possible to continue with the update of that particular object.

18.3 FIELD MAPPINGS

In the **Field mappings** step of the import, the column names of the import source file are mapped to the corresponding fields in Snow License Manager. If the import source file has no header, index mapping can be used instead. This means that the fields of the import source file will be identified by index (column position 0, 1, 2, etc.) instead of text (column header).

18.4 RUN IMPORT

- 1. On the **Home** menu, select **Import data**. The **Import data** view appears.
- 2. Select import type to start the import wizard, which will take you through the steps described in the following sections.

NOTE

The import procedures for the following import types are described in separate sections:

- Licenses, see Import or update licenses.
- Microsoft License Statement (MLS) files, see Microsoft License Statement file import.
- **Oracle orders**, see Bulk-import Oracle orders.

18.4.1 UPLOAD A DATA SOURCE

- 1. Select **Browse** and then select the import source file.
- 2. If the import source file is a CSV file, select used **Delimiter** from the list. Otherwise, leave the default value.
- 3. Select Next.

18.4.2 CONFIGURE IMPORT SETTINGS

- 1. Manage settings for the data import according to the following sections. Available import settings depend on the type of import/update.
- 2. Select **Next**.



18.4.2.1 Settings for all imports/updates

In the **New organization action** list, select how to handle organizations that exist in the import source file but not in the Snow License Manager database. The options are described in the following table.

Options for New organization action	Description
Do nothing	Unknown organizations will be ignored. However, information on organization is required for a successful import. The field will be highlighted in the Preview step and it will not be possible to import data for that particular row.
Create	The system will create the new organization node, either directly under the root (for example: ROOT/[new organization node]) or according to the path in the import source file (for example: ROOT/IT/ [new organization node]).

18.4.2.2 Computer update settings

In the **Obsolete computer action** list, select how to handle computers that exist in the Snow License Manager database but not in the import source file. The options are described in the following table.

Options for Obsolete computer action	Description
Do nothing	Nothing will happen to the obsolete computers.
Inactivate	All obsolete computers will be inactivated during the import. An inactive computer does not require licenses for its installed applications and is not included in the compliance calculations.
Archive	All obsolete computers will be archived during the import. An archived computer is removed and all licenses currently attached to it are released.
Delete	All obsolete computers will be deleted during the import. A deleted computer is removed from the system; all computer details are deleted and all attachments to users, agreements, licenses, etc. are released. This option is available when the basic setting IMPORT_ENABLE_DELETE is enabled.

CAUTION

A computer that has been archived or deleted during import cannot be restored. If you have an import file that does not include all the computers in the database, only select **Archive** or **Delete** if you really want to remove them from the system.

ΝΟΤΕ

It is possible to limit the obsolete computer action to certain computers in the database by a configuration setting in Snow MACC.



18.4.2.3 CUSTOM OBJECT UPDATE SETTINGS

In the **Object type** list, specify the object type that will be updated. Depending on object type, different destination fields will be available in the **Field mappings**.

18.4.2.4 LICENSE ASSIGNMENT IMPORT SETTINGS

In the **Assignment action** list, select to add to existing assignments on a license, or to replace them completely.

18.4.3 MAP SOURCE AND DESTINATION FIELDS

Map the column headers of the import **Source** file to the corresponding **Destination** fields in Snow License Manager. Mandatory fields are marked with an asterisk * and must be included in the import source file. The fields to be mapped depend on type of import/update.

If the source file has no header, **Map by index** can be used instead.

18.4.3.1 MAP AND CONFIGURE IDENTIFIERS

For updated information to be mapped to the correct items, an identifier must be selected. Depending on how the import file looks like, select to identify by using the file header or to map by index.

To map and configure identifiers:

- 1. To map by index, select the **Map by index** check box.
- 2. In the **Map identifiers** destination list to the right, select identifier.
- 3. In the **Map identifiers** source list to the left, select column header or column position where information on selected identifier is found.
- 4. To remove any spaces in the beginning or the end of a data value, select the **Trim leading or trailing white space** check box.

18.4.3.2 MAP AND CONFIGURE FIELD MAPPING OPTIONS

1. To configure a field mapping, select the **Mapping** icon to the right of the field name.

A dialog box appears.

- 2. To remove any spaces in the beginning or the end of a data value, select the **Trim leading or trailing white space** check box.
- 3. To map by index, select the **Map by index** check box.
- 4. Enter a **Default value** to be imported if there is no value in the source field.
- 5. Optionally, enter a **Prefix** (text and/or number) to be added in front of all imported values. This can be used for separating objects from different sites. For example, enter "**SE_**" to be added in front of all computers located in site Sweden.
- 6. For update of existing items an option is included for any existing custom fields. In the **Empty value action** list, select how the system shall handle an empty field in the source file when updating the database:
 - **Do not update** The database will not be updated.
 - **Remove value** The database will be updated with the empty (blank) value.



NOTE

If a Default value has been defined, see above, the Empty value action will not apply.

- 7. Select **Save**. The **Mapping** icon to the right of the field name is replaced by an exclamation mark **settings** have been made.
- 8. In the **Source** list, select column header or column position where information on selected **Destination** field is found.
- 9. Repeat the previous steps for every field mapping.
- 10. Select Next.

18.4.4 PREVIEW OF IMPORTED DATA

In the **Preview of imported data**, errors, missing information and data that differs from what is expected are color highlighted, according to the following table.

Color of field	Description
Yellow	If the Incomplete licenses functionality is activated (which is done in Snow MACC), fields that are missing the required information are highlighted in yellow.
Red	Errors like conflicts or invalid values are highlighted in red. Rows that have any fields highlighted in red will not be imported.

It is possible to continue with the import/update even if there are invalid rows. However, only rows that are not highlighted or highlighted in yellow will be imported.

To preview the data:

- 1. To see more information about a highlighted field, point to the field.
- 2. To export the entire preview to an Excel file, select **Export all rows**.
- 3. To export only rows with errors, select **Export invalid rows** Descriptions of the errors/warnings will be included in the file. This may help you to correctly create the source file, with the right fields and content.
- 4. To go back and correct field mappings and import settings, select **Previous**.
- 5. To start the import, select **Next**.

18.4.5 IMPORT

The progress of the import is displayed.

• When completed, select **Finish**.

18.5 IMPORT OR UPDATE LICENSES

To import new licenses, or to update data for licenses already in Snow License Manager, go to **Home > Import data > License import/update**. This starts a wizard that contains five steps:



- 1. Prepare the license import.
- 2. Upload the license import file and configure import settings.
- 3. Map source and destination fields.
- 4. Preview of the import data, including optionally adding new metrics.
- 5. View the results of the license import.

Each step of the wizard is described below.

NOTE

- If the license import is interrupted, for example if the browser window is accidentally closed, you can resume the import process by returning to step 1 of the license import wizard. A dialog box will appear, where you can select to either **Resume current import** or **Start a new import**.
- You can view or undo the results of the most recently completed license import until a new import is started. If there is a previously completed license import, the **Last import** section will be shown in the upper right corner of step 1 of the wizard. Select the link in that section to get to the import **Results** view, where you can view or undo the results of the import.

18.5.1 STEP 1: PREPARE THE LICENSE IMPORT

The preparations consist of the following steps:

Import agreements (optional)

If you want to attach the licenses, that you are about to import, to agreements that are not yet in Snow License Manager, you must first import the agreements. To import agreements, go to **Home > Import data > Agreement import**.

Create your license import file

The license import file must be in Excel (.xls or .xlsx) format. A license import template with the right format and fields can be downloaded from this step of the wizard.

Use the drop-down menu to see a description of a field in the template. For more detailed information on required import data, and where the data can be found in Snow License Manager after the import, see Data Import Field Description. The following fields in the template are mandatory:

- **Application name** or **SKU** (Stock Keeping Unit)
- Legal organization
- Purchase date

• Assignment type

For license updates, the following field is required in addition to the above fields:

• License ID

If the License ID is not included, Snow License Manager will treat the licenses in the import file as new instead of as updates.

To find the ID for a license in Snow License Manager: Go to **Licenses > List all licenses**, open the **Column selector** and add the **License ID** column to the list.



NOTE

A license, for which only the above fields have been filled in, will be imported to Snow License Manager, but will be marked as incomplete and will not be included in compliance calculations. For an imported license to be complete, the fields **Metric** and **Quantity** must also be filled in.

When you have completed the preparations, select **Start license import** to continue to the next step of the wizard.

18.5.2 STEP 2: UPLOAD THE LICENSE IMPORT FILE AND CONFIGURE IMPORT SETTINGS

Upload the license import file by selecting **Choose file** and browse for the file you have prepared. When the file is uploaded, the file name is displayed to the right of the **Choose file** button.

Configure the settings for the license import:

Identity field mapping

Select to use either **Application name** or **SKU** (Stock Keeping Unit) as identity field for mapping the licenses to applications.

New organization action

Select how organizations in the **Legal organization** field of the license import file that do not already exist in the Snow License Manager database should be handled:

• Do nothing

The data in the field will be disregarded. The new organization will not be added to Snow License Manager.

Note that information on organization is required. The field will be highlighted in the **Preview** step of this wizard and it will not be possible to import data for that row.

• Create

The system will create the new organization node according to the path in the license import file, for example: ROOT,IT,[new organization node]. If no path is specified, the new organization node will be created directly under the root.

Select **Next** to continue to the next step of the wizard.

18.5.3 STEP 3: MAP SOURCE AND DESTINATION FIELDS

In this step the fields of the license import **Source** file are mapped to the corresponding **Destination** fields in Snow License Manager. Matching source and destination field names are automatically mapped. You can manually override the auto mapping by selecting another source field name from the drop-down list.

Mandatory fields are marked with an asterisk (*) and must be included in the license import file.

For license updates, the **License ID** field is required in addition to the fields marked with an asterisk. If the **License ID** field is not mapped, Snow License Manager will treat the licenses in the import file as new. When the **License ID** field is mapped, the values in the mapped fields will be replaced with the values in the import file for those licenses. Note



that this means that if no value is present in the import source file for a mapped field, the field will be cleared in Snow License Manager.

To configure a field mapping, open the configuration dialog box by selecting the **Mapping** icon to the right of the destination field name.

- To remove any spaces in the beginning or end of a data value, select the Trim leading or trailing white space check box.
 For example, the values "Application xyz" and " Application xyz " in the Application name field will be interpreted as one and the same application when the check box is selected.
- To populate the destination field with a default value if the source field is empty, enter a value in the **Default value** box.
 For example, if the fields in the **Is upgrade** column of the import file contain the value "yes" for upgrade licenses and are empty for non-upgrade licenses, and "no" is entered as default value, the destination field will be populated with the value "no" for all empty source fields.
- To add a prefix in front of all imported values, enter a prefix (text and/or number) in the **Prefix** box.
 This option is available for some of the destination fields. It can be used to separate

or specify the values in the import file. For example, if the invoice reference values in the import file are "1", "2", and "3", and the text "INV_" is added as a prefix to all invoice references, the imported values will be changed to "INV_1", "INV_2", and "INV_3".

Select **Next** to continue to the next step of the wizard.

18.5.4 STEP 4: PREVIEW OF THE IMPORT DATA, INCLUDING OPTIONALLY ADDING NEW METRICS

This step presents a preview of the he data in the license import file. The **Status** column shows for each row in the import file if it is **Ready** or **Not ready** to be imported. You can continue with the import or update even if the import file contains invalid rows. However, rows in status **Not ready** will not be included in the import.

The fields of the preview are color highlighted as follows:

Highlighting color	Description
No highlighting	The field is properly filled. A row with no highlighted fields is given the status Ready with a green check icon. The license will be included in the import and it will be included in compliance calculations.



Highlighting color	Description
Yellow	Required information is missing.
	A row with fields highlighted in yellow in addition to any fields with no highlighting is given the status Ready with an orange check icon. The license will be included in the import, but it will be marked as incomplete. It will not be included in compliance calculations until it has been completed with the missing data.
	Note: For license updates, empty fields in the import file will result in the fields being cleared in Snow License Manager. To avoid unintentional loss of data it is therefore important to consider yellow fields, if any, when the import concerns updating existing licenses.
	Note: The Incomplete licenses functionality must be activated in Snow Management and Configuration Center for missing required information to be highlighted in yellow.
Red	The field contains errors, such as conflicts or invalid values.
	A row with one or more fields highlighted in red is given the status Not ready and will not be included in the import.

You can perform the following actions in this step:

- Hover over a highlighted field to see more information about it.
- Select **Export all rows** to export the entire preview to an Excel file.
- Select Export invalid rows to export only rows with errors to an Excel file.
 Descriptions of the errors and warnings will be included in the file. This can be an aid in creating a correct source file, with the right fields and content.
- Select **Previous** to go back and correct field mappings and import settings.
- Select application version from the drop-down list in the SKU (Stock Keeping Unit) column to change version for the application in that row.
 The drop-down list is available if SKU was chosen as identity field in step 2 of the import wizard and the SKU represents multiple application versions. Selecting another application version will trigger re-validation of the row.
- Select Add new metrics to add one or more new metrics from the license import file to one or more applications in Snow License Manager. See Add new metrics.
- Once you are satisfied with the preview, select **Run import** to import the licenses to Snow License Manager.
 The **Import completed** pop up window will appear, showing the number of imported rows and the number of rows that failed to be imported. Select **Close and view results** to continue to the last step of the wizard.

18.5.4.1 ADD NEW METRICS

A **Metric** field is highlighted in red when the metric for an application in the license import file does not match the metric or metrics currently added to the application in Snow License Manager.

To add the metric in the license import file to the application:



1. Select **Add new metrics**.

The **Import preview/Add new metrics** view is displayed. All rows in the license import file containing an unmatched metric are listed. The metric or metrics currently added to the application in Snow License Manager are shown in the **Current metric(s)** column. The metric from the license import file is shown in the **New metric** column.

- 2. Select the check box for the application you want to add the new metric to. Multiple applications can be selected if they share the same new metric.
- Select Add metrics for selected applications.
 The Import preview/Add new metrics/Enter metric details view is displayed.
- 4. Enter the details for the new metric.
 See applicable parts of subsections **Metrics** and **General** in License settings tab for guidance.
 Select the **Set as default metric** check box if you want to make the new metric the default metric of the application.

NOTE

The default metric cannot be changed for a Windows Server application.

- 5. To apply the new metric details, select one of the following:
 - Select **Apply to selected** to apply the details to the applications you selected in the previous view.
 - Select Apply to applications with same metric type to apply the details to all applications with the same new metric type listed in the previous view.

You are returned to the **Import preview/Add new metrics** view. The applications to which the new metrics have been added are now in status **Ready**.

6. Select **Continue** when you are done adding new metrics to applications. You are returned to the **Import preview** view.

18.5.5 STEP 5: VIEW THE RESULTS OF THE LICENSE IMPORT

The last step of the wizard shows the results of the license import.

The **Status** column shows for each row of the import file if it has been **Imported**, **Updated**, or if the import or update **Failed**.

You can perform the following actions in this step:

- Select **Export all rows** to export all rows to an Excel file.
- Select Export invalid rows to export only rows with errors to an Excel file.
 Descriptions of the errors/warnings will be included in the file.
- Select **Undo import** to undo the import you just carried out.

ΝΟΤΕ

Any metric changes for an application will also be reverted to the way they were before the import.

If you have used any of the licenses from the import before undoing it, the action may cause incompliance.



- Select **Go to your licenses** to see a list of all licenses in Snow License Manager.
- Select Start a new import to go to step 1 of the import wizard and start a new import.

18.6 MICROSOFT LICENSE STATEMENT FILE IMPORT

Snow License Manager can import Microsoft License Statement (MLS) files. The file must be in .xlsx format, and in its original state (unaltered). The MLS import will import agreements and licenses, and map licenses to applications in SLM using the SKU (Stockkeeping Unit) repository. Moreover, the import will apply product use rights information where possible.

License information is imported from the **License Agreement** and the **Transaction Data** tabs of the MLS file. The columns that are used for import are described in the user guide *Data Import Field Description*.

18.6.1 RUN IMPORT

- 1. On the **Home** menu, select **Import data**. The **Import data** view appears.
- 2. Select **MLS import** to start the import wizard.
- 3. Select **Browse**, select the import source file, and then select **Next**.
- 4. Change the MLS import settings:
 - a. To use an organization alias when linking the agreements or licenses to organization nodes, select the **Use organization alias for agreements** and/or **Use organization alias for licenses** check boxes.

NOTE

There has to be an alias, case sensitive, for each company name appearing in the **Customer Name on Agreement** column on the tab **License Agreements** of the MLS file. Aliases are created when adding/ editing an organization node in Snow Management and Configuration Center.

- b. To include incomplete licenses in the import, select the **Import incomplete licenses** check box.
- c. Select **Next**.
- 5. Verify the agreements, and then select **Next**.
- 6. Verify the licenses, and then select **Next** to start the import.
- 7. Select **Finish** when the import is complete.



19 COMPLIANCE EXAMPLES

19.1 EXAMPLE: WINRAR ARCHIVER

In the compliance summary of the application we see that:

- The metric of the application is set to **Installations**
- There are **10** licenses with that metric for this application

19.1.2 OTHER METRICS

On the **Compliance** tab and in the **Details** view, we see that licenses with another metric than the application's metric have been registered. However, these licenses have not been assigned to any computer/datacenter and are not used for coverage.

To correct the unassigned licenses:

- 1. Navigate to the license with the **Number of processors** metric, and click **Edit license**.
- 2. Click the **Assignment** tab.
- 3. Click **Add** and search for the computers that you want to assign the licenses to.
- 4. Type number of licenses to be assigned for each computer.
- 5. Save the changes to the license.
- 6. Select **Recalculate compliance** from the dropdown menu under your username.



7. Navigate to the application, and then click the **Compliance** tab.

In this example the computers that we assigned the licenses to have 1 processor each. This means that the 4 licenses correspond to 4 installations which they now cover. This is shown in the **Coverage** column where we in the top section now have a row for **Covered by other metrics**, and in the second section a row for **Licensing other metrics**.
